Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of JCJ Employee Stock Ownership Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Note 1 - Plan description and basis of presentation

The following brief description of JCJ Employee Stock Ownership Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan agreement for complete information.

JCJ Business Corp., Inc. and Affiliates (the "Company") established the Plan effective as of January 1, 2012. The Plan operates, in relevant part, as an employee stock ownership plan (the "ESOP") and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (the "IRC"), and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan is administered by an Administrative Committee (the "Committee") comprised of the Executive Committee of the Company's Board of Directors as appointed by the Company's Board of Directors.

Eligibility

Employees of the Company and its participating affiliates, who are not employees covered by a collective bargaining agreement or a nonresident alien, are generally eligible to participate in the Plan upon attaining the age of 21 and after one year of service provided they worked at least 1,000 hours during such Plan year. Participants who do not have at least 1,000 hours of service during such Plan year or are not employed on the last working day of a Plan year are not eligible for an allocation of Company contributions for such year.

Employer contributions

The Company is obligated to make contributions in cash to the Plan which, when aggregated with the Plan's dividends and interest earnings, if any, equal the amount necessary to enable the Plan to make benefit payments to participants and to fund diversifications elected by eligible participants.

Payment of benefits

Distributions on account of death, disability or retirement are made in the Plan year following the event. Distributions for other separations from service can generally be paid as soon as practical but no later than the end of the sixth Plan year following the Plan year of the separation from service. A participant with a vested account balance of \$1,000 or less will receive a lump sum distribution equal to the value of the vested portion of his or her account. Distributions for participants with a vested account balance of more than \$1,000 are made in installments over a period of no more than five years, but the Committee may accelerate the payment schedule in its sole and absolute discretion. The Committee has elected to distribute balances of more than \$1,000 and less than \$50,000 in the form of a lump sum distribution with the participant's consent. Participants with an account balance in excess of a threshold amount set by the Internal Revenue Service (the "IRS") will receive payment of their benefits over a period of five years plus one additional year for each dollar amount, or fraction of that dollar amount, by which their benefit exceeds the threshold amount or such other amounts prescribed by Treasury Regulations. A participant may elect to have any portion of his or her account paid in the form of a direct rollover to an eligible retirement plan. The amount to be distributed is based upon the account valuation date immediately preceding the distribution, beginning no later than one year after the close of the Plan year. Distributions are made in shares of employer securities, cash or a combination of employer securities and cash.

Under the provisions of the Plan, the Company is obligated to repurchase participant shares, which have been distributed under the terms of the Plan if the shares are not publicly traded or if the shares are subject to trading limitations. During 2024, there were no shares repurchased from participants.

Administrative expenses

As provided in the Plan agreement, administrative expenses may be paid either by the Plan or by the Company. The Company has paid the operating expenses for the Plan during 2024.

Voting rights

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by Michael E. New (the "Trustee") or Evolve Bank and Trust (the "Custodian") prior to the time that such rights are to be exercised. The Trustee is not permitted to vote any allocated share for which instructions have not been given by a participant. The Trustee is required, however, to vote any unallocated shares on behalf of the collective best interest of Plan participants and beneficiaries.

Plan termination

The Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon such termination of the Plan, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the IRC. Upon termination of the Plan, the Committee shall direct the Custodian to pay all liabilities and expenses of the trust fund.

Participant accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each Plan year with Company contributions of cash and stock, along with forfeitures of terminated participants' nonvested accounts. Only those participants who are eligible employees of the Company as of the last day of the Plan year will receive an allocation. Allocations are based on a participant's eligible compensation, relative to total eligible compensation. Plan earnings are allocated to each participant's account based on the ratio of the participant's account balance.

Vesting

If a participant's employment with the Company ends for any reason other than retirement, permanent disability, or death, he or she will vest in the balances in his or her account based on total years of service with the Company subsequent to January 1, 2012. Participants become 20% vested after 2 years of service, 40% vested after 3 years of service, 60% vested after 4 years of service, 80% vested after 5 years of service and 100% vested after 6 years of service. Upon death, disability or normal retirement age, the participant will become fully vested in his or her account balance.

Put option

Under federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

During 2024, the Company exercised the put option, distributing 9,590.3881 shares to participants who were eligible for distributions or diversifications. These shares were then purchased from those participants by the Company in cash. Additionally, the Company contributed 5,783.8927 shares to the Plan subsequent to year end.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company common stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. Participants who elect to diversify receive a cash distribution or elect to rollover to another investment alternative.

Effective January 1, 2022, certain participants in the Plan became eligible to elect to diversify a portion of the balance in each such individual's account, as provided in the Plan and Section 401(a)(28)(B) of the Code. Of the \$2,188,718 in benefit payments, \$218,767 were diversification distributions from the Plan during 2024 paid in shares. The eligible diversified account balances remain subject to the distribution rules of the Plan.

Forfeitures

Plan forfeitures are allocated to each participant's account based upon the relation of the participant's eligible compensation to total compensation for the Plan's participants for the Plan year. Forfeitures of terminated nonvested account balances allocated to remaining participants during the year ended December 31, 2024 totaled \$207,264. Forfeited nonvested accounts to be allocated to participant accounts in future years as of December 31, 2024 and 2023 were \$298,417 and \$412,604, respectively.

Note 2 - Summary of significant accounting policies

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in accordance with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

The interest-bearing cash account and shares of Company common stock are valued at fair value. See Note 7 for discussion of fair value measurements.

Interest income, if any, is recorded on the accrual basis. Dividend income, if any, is accrued on the ex-dividend date.

Purchases and sales of securities are recorded on a trade-date basis. Realized gains and losses from security transactions are reported on the average cost method. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits

Benefits are recorded when paid.

Reclassifications

Certain reclassifications have been made to the 2023 financial statements to conform to the 2024 financial statement presentation.

Subsequent events

The Plan has evaluated subsequent events through October 14, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified investments

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments held at December 31, 2024 and 2023 and investment income for the year ended December 31, 2024, that are disclosed in the accompanying financial statements and supplemental schedule, were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the Custodian of the Plan.

Note 4 - Tax status

The IRS has determined and informed the Company by a letter dated October 29, 2014, stating that the Plan and related trust are designed in accordance with applicable sections of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5 - Administration of plan assets

The Plan's assets, which consist of an interest-bearing cash account and Company common shares, are held by the Custodian of the Plan.

Company contributions are held and managed by the Custodian, which invests cash received, interest and dividend income, if any, and makes distributions to participants.

Certain administrative functions are performed by officers or employees of the Company or its affiliates. No such officer or employee receives compensation from the Plan. Administrative expenses for the Trustee's and Custodian's fees are paid directly by the Company.

Note 7 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board issued Accounting Standards Codification 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The Company's common stock held by the Plan is valued at fair value based upon an independent appraisal. This appraisal was based upon a combination of market and income valuation techniques consistent with prior years. The appraiser took into account historical and projected cash flow and net income, return on assets, return on equity, market comparables and fair value of Company assets and liabilities. Plan management has concluded that a market participant would also recognize a discount for lack of marketability. Substantially all of these are unobservable inputs.

The valuation process involves Plan management's selection of an independent appraiser under contract with the right to cancel such contract at any time. Plan management accumulates the data for the appraiser from the records of the Company. The appraiser prepares a preliminary report which Plan management, along with the ESOP Trustee, reviews in detail, discusses and approves.

The interest-bearing cash account is valued at cash value, which approximates fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 8 - Related party and party-in-interest transactions

The Plan invests in Company common stock with the Trustee. This is a related party and party-in-interest transaction. As described in Notes 1 and 5, the Plan has several service providers. Such parties are parties-in-interest under ERISA.

Note 9 - Risks and uncertainties

The Plan's investments consist of interest-bearing cash and the Company's common stock, which are exposed to various risks such as interest rate, market and credit risks. The common stock is also exposed to risks relating to valuation assumptions based on earnings, cash flows and/or other such techniques. Due to the level of risk associated with the investment in common stock and to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in value of the common stock will occur in the near-term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.
