## **Note 1. Description of Plan**

The following description of the B&A (Bart & Associates, LLC) (the “Company”) 401(k) Plan (the “Plan”) audit provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

### ***General***

The Plan is a defined contribution plan covering substantially all eligible employees who are 21 years of age or older who have worked thirty consecutive days for the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). John Hancock Life Insurance Company (John Hancock) serves as the custodian of the Plan.

### ***Contributions***

Participants may elect to defer up to 100% of compensation, not to exceed the maximum allowance amount defined by the Internal Revenue Service. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company may make a discretionary matching contribution as a percentage of the participant’s elective deferral. During 2024, the Company matched 20% of the first 5% of a participant’s compensation. The Company may also make a non-elective discretionary contributions. During the year ended December 31, 2024, no non-elective discretionary contributions as made. Contributions are subject to certain limitations.

Contributions from Plan participants and the matching contribution from the Company are recorded in the year in which the employee contributions are withheld from compensation.

### ***Investment Options***

Participants direct the investment of their accounts into various investment options offered by the Plan. The Plan offers pooled separate accounts as investment options for participants.

### ***Participant Accounts***

Each participant’s account is credited with the participant’s contribution and allocations of the Company’s contributions and plan earnings (losses), and charged with benefit payments, transaction fees related to notes receivable from participants and distributions, and allocations of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

### ***Vesting***

Participants are immediately vested in their contributions and the Company’s safe-harbor contributions plus actual earnings thereon. Vesting in the Company’s contributions, plus actual earnings thereon, is based on years of service. A participant is 100% vested after four years of credited service. Participants become 100% vested in the case of death, permanent disability, or upon attaining the age of 65.

### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant’s account and bear interest at rates which are commensurate with local prevailing rates as determined by the plan administrator. At December 31, 2024, outstanding loans bore interest rates between 4.25% and 9.50%. Principal and interest are paid ratably through semi-monthly payroll deductions.

***Payment of Benefits***

On termination of service, death, or retirement, a participant may elect to receive an amount equal to the value of the full amount in that participant's salary reduction and rollover contributions as well as the participant's vested interest in the Plan. Hardship distributions are permitted upon demonstration of financial hardship. All fully vested balances are available for distributions after the participant reached the age of 59.5.

***Forfeitures***

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$24,610 and \$13,862, respectively. These accounts will be used to reduce future Company contributions or plan expenses. During 2024, no forfeitures were used to pay for plan expenses.

***Revision of Prior Year's Financial Statements***

Certain revisions have been made to the 2023 financial statements to properly disclose pooled separate accounts investments valued at net asset value ("NAV"). These revisions did not have an impact on the statement of net assets available for benefits.

The "Fair Value Measurements" disclosure in the Plan's 2023 financial statements disclosed the Plan's investments in pooled separate accounts as mutual funds and a guaranteed interest contract. This resulted in the investments measured at fair value overstated by \$22,929,760 and investment valued at contract value overstated by \$859,737 and the pooled separate accounts investments being understated by \$23,789,497. In addition, certain disclosures specifically related to pooled separate accounts investments were not included as these investments did not have a disclosed balance.

The 2023 presentation of the pooled separate accounts investments in the "Fair Value Measurements" disclosure (Note 3) for these 2024 financial statements has been revised to reflect the proper presentation.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

***Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates and assumptions.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are recognized as assets on the statement of net assets available for benefits when granted to eligible participants. Notes receivable from participants are initially measured at their principal amount and are subsequently measured at their unpaid principal balance and interest.

***Payment of Benefits***

Benefits are recorded upon distribution.

***Administrative Expenses***

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the plan document.

***Subsequent Events***

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

**Note 3. Fair Value Measurements**

Fair value, as defined under GAAP, is an exit price representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1**    Observable inputs such as quoted prices in active markets.
- Level 2**    Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3**    Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment, and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

The following is a description of the valuation methodology used for assets measured at fair value:

***Pooled Separate Accounts***

The Plan invests pooled separate accounts for which quoted price are not available in active markets for identical instruments. The Plan utilizes the net asset value ("NAV") per share, as determined by the custodian, as the estimated fair value. Because quoted prices in active markets for identical assets are not available, these prices are determined using observable market information such as quotes from less active markets and/or quoted prices of securities with similar characteristics.

Following are the investment strategies for investments for which fair value is measured using the NAV:

- (A) Blend fund strategies seek to invest in securities that are balanced between securities whose primary objective is to appreciate and securities whose primary objective is to pay dividends.
- (B) Growth fund strategies seek to invest in corporate securities with capital appreciation as the primary objective.
- (C) Value fund strategies seek to invest in corporate securities that are deemed to be undervalued in price and are likely to pay dividends.
- (D) Bond fund strategies seek to invest in a diversified portfolio of long duration fixed income securities.
- (E) Represents investment in a common collective trust fund consisting of securities in U.S. government agencies, foreign government agencies, mortgage-backed securities, and various fixed-income securities.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 4. Certification of Plan Custodian**

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statement of net assets available for benefits as of December 31, 2024
- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

**Note 5. Exempt Party-In-Interest Transactions**

Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. During the year ended December 31, 2024, the Plan paid \$73,084 for third-party administration services. Those transactions qualify as exempt party-in-interest transactions under ERISA.

**Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

**Note 7. Tax Status**

The Plan has not obtained a determination letter from the Internal Revenue Service (the "IRS") stating that the Plan was in compliance with the applicable requirement of the IRC. The Plan is relying on the IRS approval of the non-standardized pre-approved profit sharing plan that it is utilizing. The IRS has determined and informed the document sponsor by a letter dated November 30, 2020 that the non-standardized plan document was designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
