## Independent Auditor's Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Heapy Engineering, Inc. Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate to the best of its knowledge and belief.

### Opinion

#### Note 1. Description of Plan

The following description of the Heapy Engineering, Inc. Savings Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description for a more complete explanation of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering substantially all employees of Heapy Engineering Inc. and its wholly owned subsidiary Heapy Engineering Indiana LLC (referred to collectively as the Company or Employer) who are age 21 or older and have completed one month of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions:** Participants may contribute from 1% to 100% of their compensation as defined by the Plan, subject to certain limitations under the Internal Revenue Code (IRC). Eligible employees may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participant contributions are recognized when earned.

The Company may also elect to make qualified nonelective contributions to the Plan on behalf of the participant. The Plan allows these discretionary contributions to be allocated to participant accounts based on how the participant is categorized under the Plan document. Employer profit sharing contributions are recognized on an annual basis.

**Rollovers:** The Plan allows rollovers received by a participant as a distribution from another qualified plan after approval from the Plan Sponsor. Participants are fully vested in these amounts.

**Participant accounts:** Each participant's account is credited with the participant's contribution and allocations of the Company's contribution and plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are immediately 100% vested in both their own contributions and company contributions upon participation in the Plan.

**Payment of benefits:** Participants become eligible for benefit payments upon death, disability, retirement or termination. Participants may elect to receive a lump-sum cash distribution, periodic installments, or a direct rollover distribution.

**Notes receivable from participants:** Participants may borrow from their fund accounts. Loans may not exceed the lesser of \$50,000 or 50% of a participant's vested account balance, and loan terms range from one to five years or up to 10 years for the purchase of a primary residence. Each loan is collateralized by the remaining balance in the participant's account. Interest charged to participants is reviewed by the loan administrator and is based upon prevailing interest rates for similar loans in the surrounding community. Interest rates on participant loans ranged from 4.25% to 9.50% as of December 31, 2024 and 2023. Loan repayments are made through payroll deductions but can be repaid in full at any time.

**Basis of presentation:** The accompanying financial statements are prepared in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC).

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

#### **Note 2. Summary of Significant Accounting Policies**

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year. Capital gain distributions are included in interest income.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the Plan document.

**Payment of benefits:** Benefits are recorded when paid.

**Use of estimates:** The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the amounts and disclosures reported in the financial statements and accompanying notes. Actual results could differ from these estimates.

**Forfeited accounts:** Forfeitures are used to reduce future employer contributions or pay plan expenses. Forfeited, nonvested accounts totaled \$125 and \$90 at December 31, 2023 and 2024, respectively. No forfeitures were used to reduce employer contributions or pay plan expenses in 2024.

**Administrative expenses:** Administrative expenses are not paid by the Plan.

**Subsequent events:** The Plan has evaluated subsequent events for potential recognition and/or disclosure through October 14, 2025, the date the financial statements were available to be issued.

#### **Note 3. Information Certified by the Plan's Certifying Entity, Reliance Trust Company**

The information related to investments and notes receivable from participants that is included throughout the Plan's financial statements and supplemental schedule as of December 31, 2024 and 2023, and for the year ended December 31, 2024, was prepared by or derived from information provided by the certifying entity and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the certifying entity that information provided to the Plan Administrator by the certifying entity related to these assets is complete and accurate to the best of its knowledge and belief. Accordingly, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information in Note 8 and the supplemental schedule related to the Plan's assets.

Reliance Trust Company (Reliance) certified the completeness and accuracy based on the records they maintain of \$36,764,765 of participant-directed investments and \$484,568 of notes receivable from participants as of December 31, 2024. Reliance also certified the completeness and accuracy based on the records they maintain of \$4,304,677 of net appreciation in fair value of investments, \$938,542 of interest and dividend income, and \$41,583 of interest income on notes receivable from participants for the year ended December 31, 2024.

#### **Note 4. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan is terminated, the assets of the Plan will be distributed to participating employees or their beneficiaries. The Company shall have no right, title or interest in the contributions made by them under the Plan.

#### **Note 5. Income Tax Status**

The Plan has adopted a preapproved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the IRC. The Plan has been amended since adopting the preapproved plan document; however, the Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC.

The Plan Administrator evaluated the Plan's tax positions and concluded that there are no uncertain tax positions that require recognition or disclosure in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by tax authorities for years before 2021.

#### **Note 6. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statements of net assets available for benefits.

#### **Note 7. Party-in-Interest Transactions**

Certain plan investments were managed by Reliance for the year ended December 31, 2024, the certifying entity as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions under ERISA. Consequently, such transactions are permitted under the provisions of the Plan and are exempt from the prohibitions of party-in-interest transactions under ERISA. Fees paid by the Plan for certifying entity services amounted to \$188,025 for the year ended December 31, 2024.

#### **Note 8. Fair Value Measurements**

The Plan has determined the fair value of certain assets and liabilities through application of accounting guidance that establishes a framework for measuring fair values. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under this standard are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

**Note 8. Fair Value Measurements (Continued)**

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual funds:** Valued at the closing price reported on the active market on which the individual securities are traded.

**Pooled separate account:** Primarily valued at net asset value (NAV) per share based on quoted market prices of underlying investments. The NAV, as provided by the trustee, is used as a practical expedient to estimating fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
