## Report of Independent Auditors

### **Opinion**

We have audited the financial statements of Cedars-Sinai Defined Contribution Retirement Plan FKA Cedars-Sinai Health System Defined Contribution Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes (collectively referred to as the “financial statements”).

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan at December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

### **Basis for Opinion**

**1. Description of Plan**

The Cedars-Sinai Defined Contribution Retirement Plan (FKA Cedars-Sinai Health System Defined Contribution Plan) (the Plan) is a noncontributory defined contribution retirement plan sponsored by Cedars-Sinai Medical Center (the Plan Sponsor). All employees of Cedar-Sinai Medical Center, Cedars-Sinai Medical Care Foundation, and effective January 1, 2024, Cedars-Sinai Marina Hospital (collectively, the Company) who have satisfied the eligibility requirements can be covered. Employees can select participation in either, but not both, this Plan or the Cedars-Sinai Defined Benefit Retirement Plan. Employees may switch plans once during their employment. The primary eligibility requirements are that an employee must have completed a minimum of 1,000 hours of service within a defined period of 12 months.

Contributions to the Plan are made quarterly by the Company based on a percentage of the participants' annual compensation determined by their qualified years of service. Contribution percentages are as follows:

<u>Years of Service</u>	<u>Contribution Percentage</u>
Less than 5	3.0%
5–9	4.0
10–14	5.5
15–19	8.0
20 or more	11.0

The Company may also contribute an additional amount to the Plan at its sole discretion. Any discretionary contribution is allocated to the active participants' accounts in proportion to the annual allocation. During 2024 and 2023, there were no discretionary contributions made to the Plan. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions).

Each participant's account is credited with the Company's contributions and allocations of plan earnings and is charged with an allocation of administrative expenses. Plan earnings are allocated based on the participant's share of net earnings or losses of their respective elected investment options. Allocations of administrative expenses are based on the participant's account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**1. Description of Plan (continued)**

Participants become vested in the Company's contributions as follows: (a) 25% after two years of service; (b) 50% after three years of service; (c) 75% after four years of service; and (d) 100% after five years of service. Participants who terminate employment with the Company forfeit their unvested account balance. Forfeitures may be used to offset plan administrative expenses and/or reduce the amount of employer contributions required to meet the amounts required to be allocated to the participants. During 2024 and 2023, forfeitures were used to reduce employer contributions by approximately \$1,320,000 and \$1,075,000, respectively. The forfeiture balance at December 31, 2024 and 2023 was approximately \$738,000 and \$718,000, respectively.

**Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). In the event of Plan termination, participants will become 100% vested in their accounts.

**2. Significant Accounting Policies**

**Basis of Accounting**

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

**Investment Valuation and Income Recognition**

Investments are carried at fair value. The mutual funds are traded on a national exchange are valued at the last reported sales price on the last business day of the plan year. The Plan invests in common collective trust funds which are considered to have readily determinable fair values based on their daily net asset value provided by the fund's issuer.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The difference between the sale price and the cost of the securities is included in the statements of changes in net assets available for benefits as net realized and unrealized appreciation in the fair value of investments.

**2. Significant Accounting Policies (continued)**

**Expenses**

Trustee fees and other administrative expenses are paid by the Plan. Certain expenses such as settlor expenses incurred are paid by the plan sponsor.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States (U.S. GAAP) requires management to make estimates and assumptions that affect the amounts reported in the financial statements, accompanying notes and the supplemental schedule. Actual results could differ from these estimates.

**Benefit Payments**

Benefit payments to participants are recorded when paid.

**3. Investments**

Participants have the opportunity to choose among various publicly traded mutual funds, common collective trust funds, as well as a choice of three risk-based portfolios (managed accounts) which invest in varying percentages of mutual funds (most of these mutual funds are the same mutual funds that a participant can invest in directly). These portfolios are the Cedars-Sinai Lower Risk, Medium Risk, and Higher Risk Portfolios. The risk-based portfolios invest in mutual funds and common collective trust funds based on investment allocation percentages created by the Pension Investment Committee and administrated by Voya Retirement Insurance and Annuity Company (VOYA). Actual investments are purchased and sold daily to maintain the relative allocated percentages. The participants can select to invest in one of the risk-based portfolios, a self-directed brokerage option, which is managed by Charles Schwab & Co., Inc, or in any of the investment options offered in the Plan; those who did not make such a selection defaulted to the Cedars-Sinai Medium Risk Portfolio.

**4. Fair Value Measurements**

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). As such, fair value is a market-based measurement that should be determined based on assumptions that market participants would use in pricing an asset or liability, taking into consideration a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value as follows:

Level 1: Observable inputs such as quoted prices (unadjusted) in active markets that are accessible at the measurement date for identical assets or liabilities.

Level 2: Inputs other than quoted prices that are observable for the asset or liability, either directly or indirectly. These include quoted prices for similar assets or liabilities in active markets and quoted prices for identical or similar assets and liabilities in markets that are not active.

Level 3: Unobservable inputs that reflect the reporting entity’s own assumptions.

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level of input that is significant to the fair value measurement in its entirety.

**5. Tax Status**

The Plan has received a determination letter from the Internal Revenue Service (IRS) dated November 21, 2017, stating that the Plan is qualified under Section 401(a) of the Internal Revenue Code (the Code), and therefore the related trust is exempt from taxation. Subsequent to this determination by the IRS, the Plan was amended. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan, as amended, is qualified and the related trust is tax-exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**6. Concentrations of Credit Risk**

Financial instruments that potentially subject the Plan to concentrations of credit risk consist of investments. The Plan's investments are managed by professional investment managers within the guidelines established by the Board of Directors. The Plan's exposure to credit loss in the event of nonperformance of investments is limited to the carrying value of such instruments.

**7. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**8. Party-in-Interest Transactions**

VOYA, the trustee and recordkeeper of the Plan, charged fees to the Plan that are exempt from the prohibited transactions rules under ERISA.
