Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We were engaged to perform audits of the financial statements of 403(b) Thrift Plan of Goodwill Industries International, Inc. (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Disclaimer of Opinion

We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matters described in the Basis for Disclaimer of Opinion on the Financial Statements section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

Basis for Disclaimer of Opinion

The Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the accompanying financial statements may have been affected by these conditions.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our responsibility is to conduct an audit of the Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditor's report. However, because of the matters described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits.

Other Matter—Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. Because of the significance of the matters described in the Basis for Disclaimer of Opinion section of our report, it is inappropriate to, and we do not express an opinion on the supplemental schedule referred to above.

Note 1. Description of Plan

The following description of the 403(b) Thrift Plan of Goodwill Industries International, Inc. (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General and eligibility: The Plan is a defined contribution, participant-directed 403(b) thrift plan covering substantially all employees of Goodwill Industries International, Inc. (GII), and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established in 1987 to enable GII employees to accumulate long-term savings for their retirement while benefiting from favorable tax treatment on their current salaries. GII employees are automatically enrolled as a participant in the Plan on the first day of the month following their date of hire.

Administration: The Plan Administrator has the overall responsibility for the Plan. This includes the power to interpret the provisions of the Plan and to determine questions concerning eligibility, participation and benefits and such other powers and duties as are necessary to the operation and administration of the Plan. The Plan Administrator determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions: GII employees are automatically enrolled to defer 6% of their pay as of the date they become a participant in the Plan, unless they choose a different percentage or choose not to defer. If participants do not choose a different percentage (including zero), the percentage will also be automatically increased on the first day of each successive plan year by 1% up to a maximum percentage of 10%. Participants can make contributions to the Plan through either specified-percentage or fixed-dollar payroll deductions in any amount up to statutory limitations as specified in the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the plan year are also eligible to make catch-up contributions. Participants may also contribute amounts to the Plan representing rollover distributions from certain other qualified benefit plans.

GII's makes matching and discretionary nonelective contributions. To be eligible to receive GII's contributions, participants must be at least 21 years of age and complete six months of service. For the 2024 plan year, GII matched 100% up to 4% of eligible compensation and made a nonelective contribution of 4% of eligible compensation to eligible participants.

Contributions are subject to certain IRC limitations.

Participant accounts: Participants direct the investment of their contributions and GII's contributions into various investment options offered by the Plan. Contributions are credited to the participants' individual accounts on the date received by the custodian. Participants may change their elected investment options/allocations with the custodian at any time via direct phone or internet access by using a personal identification number.

Each participant's account is credited with the participant's contributions and GII's contributions, as well as allocations of any Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant compensation, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1. Description of Plan (Continued)

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in GII's contributions plus actual earnings thereon is based on years of continuous service. See the table below.

Payments of benefits: Distributions may be made to participants or their beneficiaries, as applicable. Upon termination of employment, death, disability or normal retirement, a participant is entitled to receive the vested percentage of their account balance. Participants may elect to receive a distribution in the form of a single lump-sum payment. Participants who are required to receive minimum required distributions may receive their distributions in the form of partial withdrawals, installments or annuities. If the participant's vested balance is between \$1,000 and \$5,000, benefits shall be distributed to the participant through a lump-sum distribution, or, if no election has been made by the participant, through a direct rollover into an Individual Retirement Account. If the participant's account balance is less than \$1,000, benefits shall be distributed to the participant through a lump-sum distribution.

Participants may receive an in-service distribution from the Plan prior to termination provided they have attained age 59½ or early distributions provided they have attained age 55. In addition, hardship distributions may be made to satisfy certain immediate and heavy financial needs a participant may have, subject to certain limitations, as defined in the Plan agreement.

Forfeitures: Participant forfeitures of nonvested balances are used to pay the expenses of the Plan or to offset future GII contributions. During 2024, GII contributions were offset by \$209,733 from forfeited nonvested accounts. Unallocated forfeitures totaled \$1,343 and \$38,379 at December 31, 2024 and 2023, respectively.

Notes receivable from participants: Participants may borrow from their account balances held by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (Principal) from a minimum of \$1,000 up to a maximum amount which is equal to \$50,000 or 50% of their vested account balance, whichever is less. The loans bear interest at rates available for similar loans from commercial lending institutions. The interest rate remains constant for the term of the loan. The notes receivable outstanding as of December 31, 2024, mature through October 2029, with interest rates ranging from 4.25% to 9.50%. Effective January 15, 2023, the Plan was amended to only allow one outstanding loan at a time. Prior to this, up to five loans were allowed at a time.

Administrative expenses: Certain administrative functions are performed by officers or employees of GII. However, such employees receive no compensation from the Plan. GII and the Plan participants share in the Plan expenses. Plan expenses, such as transaction fees from receiving a withdrawal or distribution from the Plan, are deducted from participants' accounts.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment issuers and custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold during the year as well as held at year-end.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make the scheduled repayments and the Plan Administrator deems the participant to be in default, the participant's note receivable is reduced and a benefit payment is recorded based on the terms of the Plan. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Contributions: Contributions from Plan participants and matching contributions from the employer are recorded in the year in which participant compensation is earned. The employer nonelective contribution is recorded upon authorization.

Benefits paid to participants: Benefit payments are recorded when paid.

Subsequent events: The Plan Administrator has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Note 4. Fair Value Measurements (Continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies (mutual funds) and money market funds: Valued at the daily closing price as reported by the fund. The mutual and money market funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission and are deemed to be actively traded. The funds are required to publish their daily net asset value (NAV) and to transact at that price.

Pooled separate accounts: Valued at the NAV of shares in each account held by the Plan at year-end. The net asset value is not a publicly-quoted price in an active market. The NAV, as provided by the insurance carrier, is used as a practical expedient to estimate fair value.

Guaranteed interest accounts: The guaranteed interest accounts cannot be sold to a third party; thus, the only option to exit the guaranteed interest accounts is to withdraw the funds prior to maturity. This fair value is determined by comparing current market interest rates to the interest rate on the account and adjusting for the number of years until the maturity date. These accounts are not fully benefit-responsive and as such are reported at fair value.

- (a) This asset class invests in a combination of assets, such as aggressive stocks, international stocks, large-company stocks, government bonds, foreign bonds or money markets.

During the years ended December 31, 2024 and 2023, there were no purchases, issues or transfers into/out of assets classified as Level 3.

Note 5. Fully Benefit-Responsive Investment Contracts

The Plan holds guaranteed annuity contracts and guaranteed investment contracts that are fully benefit-responsive. In accordance with generally accepted accounting principles, fully benefit-responsive investments are presented at contract value in the statements of net assets available for benefits. The Plan's investment in these contracts is described below:

Principal Fixed Income Guaranteed Option: Investments in the Principal Fixed Income Guaranteed Option are held within the general account of Principal. Participant accounts are increased by the current rate of interest in effect and decreased by withdrawals and administrative expenses. For the year ended December 31, 2024, the effective yield of the option is guaranteed to be a minimum of 1.30% through November 2025.

Mutual of America (MOA) Interest Accumulation Account: Through the Plan's contracts with MOA, investments in the Interest Accumulation Account, a guaranteed annuity contract, are held within the general account of MOA. Participant accounts are increased by the guaranteed rate of interest and decreased by withdrawals and administrative expenses. For the year ended December 31, 2024 the effective annual yield was 3% compounded daily, which is the guaranteed rate specified in the underlying contract. MOA has the option to adjust the guaranteed rate of interest on an annual basis but not below set minimum rates.

Voya Fixed Account and Short-Term Accumulation Account: The Plan holds guaranteed annuity contracts with Voya. Voya maintains the contributions in a general account. The account is credited with contributions, earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer and is periodically reviewed for resetting.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Note 5. Fully Benefit-Responsive Investment Contracts (Continued)

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the IRC or the failure of the trust to be tax-exempt under Section 501(a) of the IRC
2. Premature termination of the contracts
3. Plan termination or merger
4. Changes to the Plan's prohibition on competing investment options
5. Bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreement without the consent of the issuer

Note 6. Related-Party and Party-in-Interest Transactions

Principal, MOA and Voya are custodians of the Plan; therefore, transactions with the custodians qualify as party-in-interest transactions. Fees paid by the Plan directly to the custodians totaled \$26,871 for the year ended December 31, 2024. GII also paid certain administrative expenses of the Plan.

Note 7. Plan Termination

Although it has not expressed any intent to do so, GII has the right under the plan agreement to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, all participants would become fully vested in their accounts.

Note 8. Tax Status

The Plan has adopted a volume submitter 403(b) plan sponsored by Principal Life Insurance Company. The volume submitter plan provider has received an advisory letter from the Internal Revenue Service as to the volume submitter plan's qualified status. The volume submitter advisory letter has been relied upon by the Plan. The Plan has been amended since the volume submitter received the advisory letter. The Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' accounts and balances and the amounts reported in the statements of net assets available for benefits.

Note 10. Subsequent Event

The Plan was amended effective January 1, 2025 to require participants be employed by GII as of the end of the plan year to be eligible for employer nonelective contributions. It also modified the definition of Annual Compensation.
