Scope And Nature Of The ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the TOMY International, Inc. Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities For The Audit Of The Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis For Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (U.S. GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities For The Audit Of The Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. NOTES TO FINANCIAL STATEMENTS

1. Description Of The Plan

The following description of the TOMY International, Inc. Retirement Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 401(k) plan covering substantially all employees of TOMY International, Inc. and domestic affiliates (the Employer). Excluded employees include non-resident aliens, residents of Puerto Rico, leased employees, temporary employees, seasonal employees, part-time employees whose regularly scheduled service is less than 1,000 hours per year and employees covered by a collective bargaining agreement other than those covered by UAW Locals 592 and 1982. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The following adopting employers are allowed to participate in the Plan:

- TOMY International, Inc.
- Fat Brain Toys, LLC

Contributions

Participants may contribute up to 100% of eligible compensation in the form of pre-tax or after-tax (ROTH) contributions not to exceed Internal Revenue Code (IRC) limits. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Under the provisions of the Plan, the Employer makes discretionary matching contributions equal to a percentage of eligible participants' elective deferral contributions. Participants are eligible for the matching contributions upon becoming eligible to make elective deferral contributions. For participants that are not covered under a collective bargaining agreement, the Employer elected to make a 100% matching contribution on the first 3% of a participant's deferral contributions and 50% on the next 2% of a participant's deferral contributions for the year ended December 31, 2024. For participants that are covered under a collective bargaining agreement and were hired on or before December 31, 2001, the Employer elected to make a 50% matching contribution on the first 2% of a participant's eligible contributions for the year ended December 31, 2024. For participants that are covered under a collective bargaining agreement and were hired on or after January 1, 2002, the Employer elected to make a 100% matching contribution on the first 5% of a participant's eligible contributions for the year ended December 31, 2024.

Under the provisions of the Plan, the Employer has the option to make profit-sharing contributions at the discretion of the board of directors. Participants are eligible for the discretionary profit-sharing contribution upon completing 1,000 hours of service and being employed by the Employer on the last day of the plan year. The Employer did not make any profit-sharing contributions to the Plan for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions and employer discretionary matching and profit-sharing contributions as well as allocations of the Plan's earnings and expenses. Allocations are based on the participant's eligible compensation, the value of account balances, an equal dollar amount based on the number of participants in the Plan or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable From Participants

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The number of outstanding loans for any participant is limited to one general purpose loan or one primary residence loan. The loans are secured by the participant's vested account balance and bear interest at the prime rate plus 1%. Loan terms may not exceed five years, except for a loan for the purchase of a principal residence. Principal and interest are paid ratably through payroll deductions.

Vesting

Participants are immediately vested in their rollover and voluntary contributions plus actual earnings thereon. In addition, participants are immediately vested in employer matching contributions. For nonelective employer contributions, vesting occurs at a rate of 20% for each year of credited service beginning in the second year of service. Participants are fully vested in nonelective employer contributions after six years of credited service or upon death, disability or the attainment of normal retirement age of 65.

Hardship Withdrawals

Prior to October 2, 2024, certain participants could elect to withdraw all or a portion of their vested account balance, plus actual earnings thereon, if they incurred a financial hardship. Hardship withdrawals were subject to the terms of the plan agreement and provisions of the IRC. Effective October 2, 2024, hardship distributions are no longer allowed under the terms of the plan agreement.

Payment Of Benefits

Upon termination of service due to death, disability or retirement, participants with an account balance greater than \$5,000 may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, annual installments over a contracted period or may elect to leave their balance in the Plan subject to minimum distribution requirements. Under the default automatic rollover provisions, distributions less than or equal to \$5,000 will be made to an Individual Retirement Account without participant consent if a participant does not make a different distribution election after receiving the required notification.

Prior to October 2, 2024, for termination of services for other reasons, a participant with an account balance greater than \$100,000 may receive the value of the vested interest in his or her account as a single lump-sum or it may be taken in multiple lump sum payments, provided that each payment is no less than the lesser of \$100,000 or the remaining participant balance. If taking multiple lump sums, the entire balance shall be distributed before the participant attains age 66. For termination of services for other reasons, a participant with an account balance less than \$100,000 may receive the value of the vested interest in his or her account as a single lump-sum distribution or it may be taken in two non-concurrent lump sums. A single lump sum must be taken no later than 60 days following the earlier of the termination date or the normal retirement date. If taking two non-concurrent lump sums, the first must occur no later than 60 days after the end of the plan year following termination of service and the second to occur no later than 60 days after the end of the plan year in which the participant attains the normal retirement age of 65. Partial disbursements (subject to \$100,000 minimum) as a form of distribution is no longer allowed effective October 2, 2024.

In-Service Withdrawals

Active participants who reach age 62 and attain 5 years of vesting service may withdraw a minimum of \$100,000 from all or part of their vested accounts.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited accounts totaled \$1,261 and \$732, respectively. These accounts may be used to offset administrative expenses or to reduce employer contributions. During 2024, forfeited accounts totaling \$68,243 were used to reduce employer matching contributions.

2. Summary Of Accounting Policies

Basis Of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use Of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation And Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's benefit administration committee determines the Plan's valuation policies utilizing information provided by the investment advisor and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Contributions

Contributions from participants and matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation. Profit-sharing contributions are recorded when declared by the Employer.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make scheduled repayments and the plan administrator deems the participant note receivable to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the plan agreement.

Payment Of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses are recorded net of amounts received under revenue sharing agreements with the custodian. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

3. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023 and net appreciation in fair value of investments, dividends and interest income from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Trust Company LLC and John Hancock Life Insurance Company (U.S.A.), the current trustee and former custodian of the Plan, respectively.

Effective October 1, 2024, the Plan changed its custodian from John Hancock Life Insurance Company (U.S.A.) to John Hancock Trust Company LLC, at which time John Hancock Trust Company LLC became the trustee.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability and
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for instruments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. These funds held by the Plan are open-ended funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/Collective Trust: Valued at the net asset value (NAV) of units of the trust. The NAV is based on the fair value of the underlying investments held by the fund, less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (common purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the common/collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Pooled Separate Accounts: Valued at the NAV per unit based on either the observable NAV of the underlying investment or the NAV of the underlying pool of securities. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities and then divided by the number of shares outstanding.

Investments in pooled separate accounts can be redeemed immediately at the current NAV based on the fair value of the underlying assets. The investment strategies for each investment category listed in the table above are as follows:

- (a) Large cap funds are composed of mutual funds who focus is long-term growth of capital. Some of these funds may also provide some small current income from dividends. The majority of assets are invested in companies with market capitalization similar to the companies in the Standard & Poor's 500 Index.
- (b) International funds are composed of mutual funds that invest in either or both developed markets outside of the United States (U.S.) (Europe and Asia) and emerging markets worldwide. The funds seek long-term growth of capital and can invest in both equities and debt instruments.
- (c) Balanced funds are composed of mutual funds that invest in a blend of U.S. and non-U.S. equities, U.S. and non-U.S. government, corporate or mortgage debt instruments or cash. The funds' objectives are to achieve a balance of long-term growth capital, long-term growth of income and the preservation of capital.

- (d) Bond funds are composed of mutual funds that invest in high-quality corporate bonds (U.S. and non-U.S.), government bonds, high-yield corporate bonds, mortgage bonds and emerging market debt. The funds seek a high level of current income commensurate with the duration and risk of the holdings.
- (e) Target date funds are comprised of mutual funds with a balanced portfolio to provide income, capital appreciation and liquidity based on projected retirement dates. These funds invest in a blend of U.S. and non-U.S. equities, bonds and money market funds.
- (f) Other funds include small cap, mid cap and specialty mutual funds (real estate, gold, utilities, commodities, etc.) that have an objective of long-term capital growth.

5. Related-Party And Party-In-Interest Transactions

Certain plan investments are shares of mutual funds, pooled separate accounts and a common/collective trust managed by John Hancock Trust Company LLC and John Hancock Life Insurance Company (U.S.A.), the current trustee and former custodian of the Plan. Therefore, these transactions qualify as party-in-interest transactions.

The Plan receives a revenue credit from certain funds managed by John Hancock Trust Company LLC. A revenue credit program is a refund of a portion of the revenue the fund managers have received based on the funds participants have chosen. Revenue credits are allocated to the participants or used to reduce plan expenses. For the year ended December 31, 2024, there were no amounts allocated to participants or plan expenses paid under this revenue credit program.

Notes receivable from participants given to parties-in-interest totaled \$171,069 and \$222,336 as of December 31, 2024 and 2023, respectively.

6. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their accounts.

7. Tax Status

The Employer has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Department of Labor or IRS. Management evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks And Uncertainties

The Plan invests in a variety of investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

10. Subsequent Event

The Securing a Strong Retirement Act (SECURE 2.0) was signed into law on December 29, 2022 and includes mandatory and optional provisions with effective dates in 2025 and later. The plan administrator will determine the optional provisions to elect and amend the plan document accordingly.

Effective January 1, 2025, the Plan's definition of eligible compensation specific to post-severance compensation was amended to exclude leave cash-out payments.
