INDEPENDENT AUDITOR'S REPORT

To the Participants and Plan Administrator of
The University of Chicago Health Care Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The University of Chicago Health Care Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available, of plan benefit obligations and of changes in plan benefit obligations for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from The Northern Trust Company, the custodian of the Plan and qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 and 2023

(1) Description of the Plan

The following description of The University of Chicago Health Care Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

(a) General

The Plan provides health and dental benefits covering all benefits-eligible employees of The University of Chicago (the University or Plan Sponsor). The Plan was established in 1970, and the related trust was established on January 1, 1995. The Plan has four health plans for active employees (two HMO plans and two PPO plans), which include the Maroon Savings Choice Plan (PPO), the Maroon Plan (PPO), the BlueCross BlueShield HMO Illinois Plan (HMO), and the University of Chicago Health Plan (HMO). The University offers two retiree medical plans to Medicare eligible retired employees and their eligible family members. There are two dental plans from which participants may choose. The Plan requires employer, employee, and retiree contributions and, except for retiree benefits, is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

(b) Eligibility

Medical benefits under the Plan are available to all employees working an average of 20 hours or more per week. Certain retirees and dependents of eligible employees may also receive benefits under the Plan.

(c) Benefits

The Plan provides health benefits (medical, hospital, surgical, major medical, pharmacy, and dental) to part-/full-time, benefits-eligible participants and to their covered dependents and beneficiaries. Retired employees are entitled to health care coverage provided they were employed prior to January 1, 2005, in a continuous benefits-eligible position and are at least age 55 when the employee terminates or they were employed on or after January 1, 2005, are at least age 55, and have completed at least 10 years of continuous benefits-eligible service when employment terminates.

Health claims of active and retired participants under age 65, dependents, and beneficiaries are processed by Blue Cross/Blue Shield of Illinois and Aetna, but the responsibility for payments to participants and providers is retained by the Plan.

(1) **Description of the Plan** *(continued)*

Pharmacy claims of active participants, dependents, and beneficiaries are processed by CVS, but the responsibility for payments to participants and providers is retained by the Plan.

Aetna pays Medicare Advantage and Medicare Supplement claims for the Medicare-eligible retirees.

Pharmacy claims of retired employees are processed by CVS/Silver Scripts, but the responsibility for payments to participants and providers is retained by the Plan.

(d) **Contributions**

The University and participants share the cost of funding the Plan. Employees contribute specified amounts that vary depending on salary, type of plan chosen, and type of coverage. Retiree contributions vary depending on age at retirement, pre/post Medicare, and type of coverage.

Contributions for retiree benefits are segregated from active employee contributions.

(e) **Administration**

The Retiree Health Plan's investments are held by The Northern Trust Company and administered by the University's Investment Office. All other components of the Plan are operated on a pass-through basis. In addition, Aetna processes claims under the Medicare Advantage and Medicare Supplement Plans. Under 65 Retirees remain on the active medical plans.

The University incurs related benefit and administrative expenses that are not paid for by the Plan; therefore, they are excluded from these financial statements.

(f) **Termination**

The University anticipates and believes that the Plan will continue without interruption but reserves the right to discontinue the Plan at any time. In the event that such discontinuance results in termination of the Plan, distributions to participants will be made as determined by the Plan administrator after reserving from the assets of the Plan such amounts as the Plan administrator deems reasonably necessary to provide for any claims incurred, but not paid.

(2) **Summary of Significant Accounting Policies**

(a) **Basis of Accounting**

The accompanying financial statements have been prepared on an accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

(b) **Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and benefit obligations, and changes therein, and incurred but not reported claims and disclosure of disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(c) **Valuation of Investments**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. See Note 5 for a discussion of fair value measurements.

(d) **Benefit Obligations**

Calculations to determine benefit obligations as of December 31, 2024 were made by the Plan administrator based on studies of claim lag patterns for medical claims incurred through 2024 and early 2023.

The postretirement benefit obligation represents the total actuarial present value of these estimated future benefits that are attributed by terms of the Plan to employee service rendered to December 31, 2024. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated employees and their beneficiaries and dependents and (2) active employees and their beneficiaries and dependents after retirement from service. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service rendered to the valuation date.

(2) **Summary of Significant Accounting Policies** *(continued)*

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary. It is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment between the valuation date and the expected date of payment.

The trend rate assumption at December 31, 2024 was 6.09% of incurred claims for Pre-65 Claims, decreasing to 4.50% by calendar year 2031. The trend rate assumption at December 31, 2024 was 6.09% for Post-65 Claims, decreasing to 4.50% by calendar year 2031.

The following were other significant assumptions used in the valuation as of December 31, 2024 and 2023.

Discount rate of 5.90% - 2024; 5.50% - 2023

Average retirement age - 78

Mortality Pri-2012 table and MP-2021 improvement scale (with adjustments)

The weighted-average health care cost-trend rate assumption has a significant effect on the amounts reported in the accompanying financial statements. If the assumed rates increased by one percentage point, then the obligation as of December 31, 2024 and 2023, would have increased by \$12.2 million and \$14.9 million, respectively.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation.

(e) **Claims Incurred but Not Reported**

Plan obligations at December 31 for health and dental claims incurred but not reported (IBNR) by active participants at that date are estimated by the Plan's actuary in accordance with accepted actuarial principles. Health claims IBNR by retired participants at year end are included in the postretirement benefit obligation. These amounts are paid by the Plan only if claims are submitted and approved for payment.

(2) **Summary of Significant Accounting Policies** *(continued)*

(f) **Payment of Benefits**

Premiums paid by either the University or the Trust are recorded as premium payments in the accompanying statements of changes in net assets for benefits. Claim payments are recorded when paid by the third-party claims processor. Amounts due to the claims processor that are yet to be reimbursed are recorded as claims payable in the statements of plan benefit obligations.

(g) **Administrative Expenses**

The Plan pays administrative expenses that consist of consulting and certain administrative fees. All other administrative costs are paid by the University.

(3) **Income Tax Status**

The Trust established under the Plan to hold the Plan's assets is intended to qualify pursuant to Section 501(c)(3) of the Internal Revenue Code (the Code), and, accordingly, the Trust's net investment income is exempt from income taxes. The Trust has obtained a favorable tax determination letter from the Internal Revenue Service (IRS), and the Plan Sponsor believes that the Trust continues to qualify and to operate in accordance with the applicable provisions of the Code.

U.S. GAAP requires the Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more-likely-than-not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

(4) **Information Certified by the Custodian**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, The Northern Trust Company, the custodian, has certified that the following data included in the accompanying financial statements and supplemental schedules is complete and accurate:

- Investments as shown on the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Schedule of assets (held at end of year) as of December 31, 2024.
- Schedule of reportable transactions for the year ended December 31, 2024.

(5) **Fair Value Measurements**

The Plan follows the guidance issued under the Fair Value Measurements and Disclosures topic of the Financial Accounting Standards Board Accounting Standards Codification, which provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as:

Level 1: Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

Level 2: Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:

- Quoted prices for identical or similar assets or liabilities in markets that are not active
- Observable inputs other than quoted prices that are used in the valuation of the assets or liabilities (*e.g.*, interest rate and yield curve quotes at commonly quoted intervals)
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

Level 3: Unobservable inputs for the asset or liability (*i.e.*, supported by little or no market activity). Level 3 inputs include management's own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level input that is significant to the fair value measure in its entirety. The following is a description of the valuation methodologies used for assets and liabilities measured at fair value.

Mutual fund is valued at the net asset value (NAV) of shares held by the Plan at year end. When calculating the fund's NAV, portfolio securities for which market quotations are readily available are generally valued at their fair value, which typically is the last quoted sales price at the time of valuation. When there are no readily available market quotations for a security, the portfolio security is valued based on its fair value, which typically is the amount which the fund might reasonably expect to receive for the security upon a current sale.

Fixed-income pool fund is valued at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer.

(5) **Fair Value Measurements** (continued)

Cash equivalents are valued daily based on observable market prices and categorized as Level 1.

The valuation methods described above may produce a fair value calculation that may not indicate net realizable value or reflect future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(6) **Contingencies**

The University, the Plan, and its third-party service providers are involved in various claims and legal actions arising in the ordinary course of business. In the opinion of management, the ultimate disposition of these matters will not have a material adverse effect on the Plan's financial position or liquidity.

(7) **Risks and Uncertainties**

The Plan invests in various investment securities that are exposed to several risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term. The changes could materially affect the amounts reported in the statement of net assets available for benefits.

(7) **Risks and Uncertainties** *(continued)*

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

(8) **Medicare Part D Subsidy**

In December 2003, the Medicare Prescription Drug, Improvement and Modernization Act of 2003 (the Act) for employers that sponsor postretirement healthcare plans that provide prescription drug benefits was signed into law. The Act introduces a prescription drug benefit under Medicare as well as a federal subsidy to sponsors of retiree healthcare plans that provide a benefit that is at least actuarially equivalent to Medicare Part D.1. Under the Act, the Medicare subsidy amount is received directly by the plan sponsor and not the related plan. Further, the plan sponsor is not required to use the subsidy amount to fund postretirement benefits and may use the subsidy for any valid business purpose. As such, the Plan's Accumulated Postretirement Benefit Obligation (APBO) and the changes in the benefit obligations do not reflect any amount associated with the Medicare subsidy. However, the amount of the APBO related to the Plan is reported net of the Medicare subsidy in the Plan Sponsor's financial statements, resulting in a difference between the two measurements.

In March 2010, the President signed into law comprehensive health care reform legislation under the Patient Protection and Affordable Care Act (PPACA) and the Health Care Education and Affordability Reconciliation Act (The Acts). Under the new legislation, the Medicare Part D Retiree Drug Subsidy, which reimburses plan sponsors for a portion of the cost associated with prescription drug coverage provided to retirees, will no longer be received tax free beginning in 2013. PPACA also includes a provision that imposes an excise tax on certain high-cost plans beginning in 2020. Plan costs in excess of a prescribed threshold will be subject to a 40% non-deductible excise tax. Although the excise tax does not go into effect until 2020, accounting guidance requires the University to incorporate the estimate impact of the excise tax in its annual actuarial valuation. The application of this legislation is still unclear and the University continues to monitor guidance from the Department of Labor and IRS for additional clarification. Certain key assumptions are required to estimate the impact of the excise tax on the University's other postretirement obligations, including projected inflation rates (based on the Consumer Price Index [CPI]) and whether pre- and post-65 retiree populations can be aggregated in determining the premium values of health care benefits.

The excise tax is applied to the value of retiree health care benefits in excess of certain thresholds, which increase each year based on the rate of CPI. Therefore, the assumed rate of CPI impacts the extent to which the University's future retiree health care benefit premiums exceed the thresholds. The University has reflected its best estimate of the expected impact of the excise tax.

(8) **Medicare Part D Subsidy** *(continued)*

Effective January 1, 2014, the post-Medicare retiree drug coverage transitioned to an Employer Group Waiver Plan from a Retiree Drug Subsidy (RDS) plan.

Effective January 1, 2020, the following were key features of the change to the retiree medical plan for Medicare-eligible retirees:

- The medical coverage for Medicare-eligible retirees was changed to a choice of a Medicare Advantage or Medicare Supplement Plan with Aetna from the Medicare Advantage Plan with Anthem Blue Cross Blue Shield.
- The new Medicare Supplement plan had a similar plan design to the Anthem Medicare Advantage Plan. The new Aetna Medicare Advantage Plan has a lower deductible and a lower maximum out-of-pocket compared to the old Anthem plan.

(9) **Transactions with Parties-in-Interest**

The Plan invests in certain investments issued by The Northern Trust Company. There were no such investments as of either December 31, 2024 and 2023.
