## INDEPENDENT AUDITOR'S REPORT

To the Trustees of

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the financial statements of Argon 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Argon 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Argon 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Argon 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

**NOTE 1 – Description of Plan**

The following description of the Argon 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**A. Nature of the Plan**

The Plan is a defined contribution plan covering substantially all eligible employees of Argon Industries, Inc. who are at least 18 years old and have completed at least 90 days of service. The Plan excludes leased employees, non-resident aliens, independent contractors, and seasonal employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The trustee of the Plan is Alerus Financial, N.A.

The Plan was restated effective June 30, 2020 in order to comply with required legislative updates. There were no significant changes to the Plan provisions as a result of the restatement. The Plan’s federal identification number is 01-0601214 and the Plan number is 001.

Effective for the Plan year ending December 31, 2024, the Plan adopted the provision to increase the maximum account balance for automatic direct rollovers from \$5,000 to \$7,000 in accordance with Version 2 of the Setting Every Community Up for Retirement Enhancement (SECURE) Act.

**B. Contributions**

Each year, participants may contribute up to 100% of pre-tax compensation, as defined by the Plan. Participants are permitted to designate a portion or all of their deferral contributions as Roth 401(k) contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Plan includes an auto-enrollment provision in which all newly eligible employees are automatically enrolled in the Plan at a deferral rate of 4% of eligible compensation unless they elect not to participate in the Plan. The contributions are invested in a designated target date fund until changed by the participant. Automatically enrolled participants are subject to automatic increases of their deferral rate by 1% each year up to 8% of eligible compensation, unless they elect otherwise.

The Company has the option to make discretionary matching contributions to the Plan. The Company elected to match 15% of participant contributions that do not exceed 8% of the participant’s compensation to the Plan for the years ending December 31, 2024 and 2023.

#### **NOTE 1 – Description of Plan (continued)**

##### **B. Contributions (continued)**

For the year ending December 31, 2024, the Company made a qualified non-elective contribution (QNEC) of \$42,295 to the Plan. The contribution was allocated to certain participants who should have had automatic 1% increases applied to their deferral rate starting in 2022. The contribution also includes the discretionary matching contribution portion on the missed deferrals and lost earnings related to those contributions.

Contributions are subject to certain limitations as mandated by the Internal Revenue Code (IRC).

##### **C. Participant Accounts and Rollovers**

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's discretionary matching contribution, (b) plan earnings and losses, (c) a transfer in from a qualified plan (rollover contribution), (d) QNEC contribution (if applicable) and charged with the participant's benefit payments and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

##### **D. Forfeitures**

If a participant terminates employment, any non-vested Company discretionary matching contributions are forfeited when the participant receives a distribution or incurs five consecutive one-year breaks in service, whichever occurs first. Forfeited amounts will be used in accordance with the applicable plan provisions. Forfeitures were used to reduce Plan expenses by \$7,176 and \$5,669 for the years ending December 31, 2024 and 2023, respectively. The unallocated forfeitures as of December 31, 2024 and 2023 were \$598 and \$704, respectively.

##### **E. Investment Options**

Participants may direct all their contributions among one or more investment options offered by the Plan. Upon enrollment in the Plan, participants may change their investment options daily.

##### **F. Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, less defaulted loans (if any). The term of the loan may not exceed five years unless they are used to purchase a home. The loans are secured by the balance in the participant's account. Interest rates range from 5.00% to 9.50%. Principal and interest are paid ratably through payroll deductions.

##### **G. Vesting**

Participants are immediately vested in their voluntary contributions, QNEC contributions, and rollover contributions plus actual earnings (losses) thereon. Vesting in the Company's discretionary matching contribution portion of their accounts plus earnings (losses) thereon is based on the following table:

##### **H. Benefit Payments**

Upon termination of service, death, disability, or retirement (age 65), a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Under certain conditions, participants may receive a hardship distribution from their account. In-service withdrawals of all or a portion of the participant's vested account balance can be made for any reason upon the participant's attainment of age 59 ½. A participant that terminates employment whose account balance is less than \$7,000 will receive a distribution of their vested aggregate account balance without the consent of the participant.

#### **NOTE 2 – Summary of Significant Accounting Policies**

##### **A. Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting.

##### **B. Estimates**

The preparation of financial statements is in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) and requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

##### **C. Investment Valuation and Income Recognition**

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance company. See Note 3 for discussion on fair value measurements.

**C. Investment Valuation and Income Recognition (continued)**

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**D. Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest less amounts defaulted (if any). Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document. Related fees are recorded as administrative expenses and are expensed when they are incurred.

**E. Payment of Benefits**

Benefits are recorded when paid.

**F. Administration Expenses**

The Company is not required to but may pay administrative expenses of the Plan. Loan administration and distribution fees are charged directly to the participant's account and are included in administrative expenses. The Plan also pays certain investment advisory and Plan administration fees from Plan assets. Certain investment-related expenses are included in net appreciation of fair value of investments.

**G. Subsequent Events**

The Company has evaluated subsequent events for potential recognition and disclosure through October 6, 2025, the date the financial statements were available for issuance. There were no significant non-recognized subsequent events through that date.

**NOTE 3 – Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are quoted prices in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2: Inputs to the valuation methodology other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as (a) Quoted prices for similar assets or liabilities in active markets; (b) Quoted prices for identical or similar assets or liabilities in inactive markets; (c) Inputs other than quoted prices that are observable for the asset or liability; (d) Inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology that are unobservable inputs for the asset or liability.

Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

#### **Registered Investment Companies (Mutual Funds)**

Mutual Funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the US Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

#### **Stable Value Collective Trust**

The stable value collective trust is valued at the fair value of participation units held in the Reliance Trust Stable Value Fund (MetLife GAC Series 25053). The trust is valued at net asset value (NAV) as reported by the Trustee, Reliance Trust Company, and as supported by the unit prices of actual purchase and sale transactions occurring daily. The collective trust invests in MetLife Group Annuity Contracts, which consist of separately managed investment portfolios in fixed income securities, and also enters into wrapper contracts which are issued by third parties and are designed to allow the fund to maintain a constant net asset value. The collective trust provides for daily redemptions by the Plan at reported net asset value, with no advance notice requirements.

The following tables set forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Certain information included in the accompanying financial statements and supplemental schedule of assets (held at end of year), including investments and notes receivable from participants held at December 31, 2024 and 2023, net appreciation in fair value of investments, interest on notes receivable from participants, and interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Alerus Financial, N.A. (qualified institution and custodian of the Plan) and has not been audited by the independent auditors for the Plan.

**NOTE 5 – Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer discretionary matching contributions. All rights, titles, powers, duties, discretions, and immunities imposed upon or reserved to the Trustee and the Company would continue in effect until all assets have been distributed by the Trustee as directed by the Company.

#### **NOTE 6 – Tax Status**

The Company adopted a non-standardized pre-approved plan document, which received an opinion letter dated June 30, 2020, in which the Internal Revenue Service (IRS) stated that the non-standardized pre-approved Plan document was in compliance with applicable requirements of the IRC. The Plan has not received a determination letter specific to the Plan itself and has been amended since adopting the non-standardized pre-approved Plan document; however, the Plan Administrator believes that the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management determined there were no items to be recognized as of December 31, 2024 and 2023. The Plan is subject to routine audits by US Federal taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **NOTE 7 – Party-In-Interest Transactions**

Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Certain administrative expenses were paid by the Plan or the Company. The Plan issues loans to participants, which are secured by the vested balance of the participants' accounts. These transactions qualify as party-in-interest.

#### **NOTE 8 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
