Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

1) Description of plan

The following description of Performance Energy Services, LLC 401(k) Plan & Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

(a) General

The Plan is a defined contribution plan covering substantially all employees of Performance Energy Services, LLC (the Company or Employer) who are 18 years of age and have completed 2 months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective May 1, 2024, accounts of the participants in the Plan were spun off from the Danos, LLC Plan and rolled over into the Plan. The net assets of the Danos, LLC Plan totaling \$\$6,989,227 were transferred in, which included outstanding participant loans.

(b) Contributions

Each year, participants may contribute up to 75% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan sponsor may make matching contributions equal to a discretionary percentage of the participants elective deferrals, which is determined by the Employer. In 2024, the Employer match was 100% of employee elected deferral not to exceed 3% of their compensation, exclusive of any performance bonuses, plus 50% of the employee elected deferral that exceeds 3% of their compensation but not to exceed 6%. Matching contributions were \$557,046 for the Plan period ended December 31, 2024. Each year, the Plan sponsor may make profit sharing contributions as determined by the Plan sponsor's board of directors. Qualified non-elective contributions (QNECs) and qualified matching contributions (QMACs) may be made by the Plan sponsor to satisfy special nondiscrimination rules that apply to the Plan. These QNECs and QMACs are fully vested when made. Contributions are subject to certain IRS limitations. There were no profit sharing contributions made in 2024.

(c) Participant accounts

Each participant's account is credited with the participant's contributions and an allocation of the Company contributions and Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(d) Forfeitures

Forfeitures of terminated participants' non-vested accounts are used first to pay Plan expenses and then used to reduce Employer contributions. Cumulative forfeited non-vested accounts total \$-0- at December 31, 2024.

(e) Vesting

Participants are immediately vested in their voluntary contributions, plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of service. A year of service is defined as the completion of 1,000 hours of service within a 12-consecutive month computation period. A participant becomes 100% vested after three years of credited service. All contributions are 100% vested upon attaining the normal retirement age, death, or disability.

1) Description of plan (continued)

(f) Payment of benefits

Upon termination of employment due to death, disability, or retirement, a participant will receive a lump-sum amount equal to the value of his or her account. Additionally, under certain circumstances of financial hardship, the participant is allowed to withdraw funds from the Plan. Balances under \$7,000 may be paid out at the discretion of the Company, as defined in the Plan documents. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

(g) Note receivable - participant loans

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest, which is equal to the prime rate as printed in the Wall Street Journal at the time of the loan.

2) Summary of accounting policies

(a) Basis of accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

(b) Investment valuation and income recognition

The Plan's investments are stated at fair market value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Shares of mutual funds are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end. See Note 8 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(c) Payment of benefits

Benefits are recorded when paid. There were no amounts allocated to accounts of participants who have elected to withdraw from the plan but not yet paid as of December 31, 2024.

(d) Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and the changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

(e) Notes receivable – participant loans

Notes receivable from participants are measured at their unpaid balance plus unpaid accrued interest. Defaulted loans are deemed distributed and recorded as benefits paid to participants in the statements of changes in net assets available for benefits. During 2024, no deemed distributions were recorded.

2) Summary of accounting policies (continued)

(f) Administrative expenses

The Plan allows certain administrative expenses to be paid from Plan assets, unless otherwise paid by the Company. Administrative expenses recorded in the Plan represent custodian fees, audit fees, and other record keeping fees that are deducted from participant's accounts and paid directly to the trustee. Loan fees and distribution fees are charged directly to the participant's account. These fees qualify as party-in-interest transactions.

3) Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts.

4) Investments

During the period ended December 31, 2024, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) depreciated in value by \$2,008.

5) Risks and uncertainties

Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

6) Federal income tax status

The Plan is based on a prototype plan, which received an opinion letter from the Internal Revenue Service dated October 6, 2020, stating that the prototype plan was designed in accordance with the provisions of the Internal Revenue Code. The Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. generally accepted accounting principles require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that would likely not be sustained upon examination by the Department of Labor and Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan is subject to tax examinations by tax authorities for a period of three years from the filing of those returns.

7) Information prepared and certified by the Plan's trustee

Certain information in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024, and net depreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period May 1, 2024 to December 31, 2024, was obtained by the Plan administrator and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, a qualified institution.

8) Fair value measurement

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Mutual funds and money market accounts: Valued at the daily closing price as reported by the fund.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different measurement at the reporting date.

9) Related party transactions

Certain Plan investments are shares of mutual funds managed by Reliance Trust Company, the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules.

10) Secure Act 2.0

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023 which included SECURE Act 2.0. SECURE Act 2.0 contains over 90 new retirement provisions, with varying effective dates through 2027. Since SECURE Act 2.0 provisions include both required and optional elements, the plan administrator will determine the optional provisions to elect and amend the Plan document accordingly. Most of the significant provisions became effective in 2024 and thereafter. Accordingly, there is no material impact to the Plan's 2024 financial statements.

11) Subsequent events

The Plan has evaluated subsequent events through the date of the auditor's report, the date which the financial statements were available to be issued.

The Company amended and restated the Plan effective January 1, 2025. The amendment changed the trustee to ADP Retirement Trust Services, LLC, and adopted an Eligible Automatic Contribution Arrangement that will automatically withhold 3% of an Employee's eligible compensation each payroll period and contribute the amount to the Plan as a Pre-Tax 401(k) deferral. The automatic deferral will increase 1% at the beginning of each subsequent Plan Year, and is not to exceed 10%. The Company has not yet requested or received a determination letter for the new Plan document. The Company believes that the provisions under the new plan document are in compliance with the applicable requirements of the IRC.
