### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Miami Valley Gaming 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### *Opinion*

### 1. Description of Plan

The following description of Miami Valley Gaming 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan covering substantially all employees of Miami Valley Gaming & Racing, LLC (the Company, Employer, or Plan Sponsor) who worked at least 1,000 hours in the previous year. To participate in the Plan, employees must work for at least three months. Eligible employees may enter the Plan on the first day of the month following the completion of the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

#### *Contributions*

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Unless a different percentage is selected, new participants are automatically enrolled to defer 3% of compensation and the automatic elective deferral contribution is automatically increased each year by 1%, up to a maximum automatic elective deferral contribution of 10%. A participant who has attained age 50 before the end of the Plan year is eligible to make additional catch-up contributions to the Plan.

Participants may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Any rollover contribution an employee makes to this Plan will be held in the employee's rollover contribution account, which is always 100% vested. The Plan also allows in-Plan Roth rollover conversions.

The Company makes safe harbor contributions of 100% up to the first 3% of each eligible employee's contributions plus 50% of contributions between 3% and 5% of Plan compensation, up to ERISA's annual compensation limit. During 2024 and 2023, the Company made safe harbor contributions totaling \$523,758 and \$490,976, respectively.

The Company may, in its sole discretion, make profit-sharing or discretionary employer match contributions to the Plan. During the years ended December 31, 2024 and 2023, no such contributions were made to the Plan.

Participants direct the investment of their contributions, as well as the Company's contributions, into various investment options offered by the Plan.

#### *Participant Accounts*

Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's contributions and (b) Plan earnings or losses (net of administrative expenses) and charged with his or her withdrawals. Allocations are based on participant contributions, earnings, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### ***Vesting***

Participants are immediately vested in their employee contributions and safe harbor contributions, plus any actual earnings thereon. Vesting in the Company's profit-sharing contribution portion of participant accounts plus earnings thereon is based on years of service under a five-year graded vesting schedule at a rate of 20% per year, beginning in the first year of service. A participant is fully vested after five years of credited service. The non-vested balance is forfeited upon termination of services. The exception to this vesting schedule is when the employee terminates, as a result of death or disability, at which time the employee becomes fully (100%) vested.

### ***Payment of Benefits***

Upon termination of service due to death, disability, normal retirement, or other reasons, a participant, or his or her beneficiary, may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Normal retirement age is 65; early retirement is not permitted. Participants may also receive a distribution for reasons of proven financial hardship, up to the amount the employee has deferred (excluding earnings thereon and safe harbor contributions) under the Plan.

Participants may elect to roll over their vested balance to another qualified retirement plan or individual retirement account (IRA).

### ***Forfeitures***

Forfeited non-vested accounts totaled \$128,876 and \$64,903 as of December 31, 2024 and 2023, respectively. These accounts will be used to reduce future employer contributions or pay Plan administrative expenses. Forfeitures were not used to reduce employer contributions or pay Plan administrative expenses during the years ended December 31, 2024 and 2023.

### ***Notes Receivable from Participants***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. A participant may not have more than one note outstanding at a time. The loans are secured by the balance in the participant's account. The interest rate for the loan is computed at the prime rate, as published in *The Wall Street Journal*, as of the date the loan is made, plus 1%. Interest rates on outstanding loans range from 4.25% to 9.50% at December 31, 2024. Principal and interest are paid through payroll deductions.

### ***Plan Expenses***

Expenses related to administration of the Plan or associated with the investment of the Plan assets may be paid by the Plan or by the Plan Sponsor. Fees related to the administration of notes receivable from participants and other miscellaneous fees associated with administration of participants' accounts are charged directly to the participants' accounts. Investment management fees and operating expenses charged to the Plan for investments in mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

### 2. Summary of Significant Accounting Policies

#### *Basis of Accounting*

The accompanying financial statements are prepared on the accrual basis of accounting.

#### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### *Investment Valuation and Income Recognition*

Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. The investment committee determines the Plan's valuation policies. See Note 6 for a discussion of fair value measurements and Note 7 for a discussion of the fully benefit-responsive investment contract.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold, as well as held during the year.

#### *Notes Receivable from Participants*

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Default loans will be taxed on the entire amount of the outstanding loan (plus accrued interest) through the date of the default. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan document.

#### *Benefit Payments*

Benefits are recorded when paid.

#### *Risks and Uncertainties*

The Plan provides for various investment securities. These investment securities are exposed to various risks, such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities and the level and uncertainty related to the changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment

securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

### ***Subsequent Events***

Plan management has evaluated subsequent events for recognition and disclosure from December 31, 2024 through October 15, 2025, the date the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

### **3. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in employer contributions credited to their accounts.

### **4. Certified Investment Information**

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held as of December 31, 2024 and 2023 and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company (Empower), qualified institutions.

### **5. Tax Status**

The Plan uses a non-standardized pre-approved profit-sharing plan sponsored by Empower. Empower received an opinion letter from the Internal Revenue Service (IRS), dated November 14, 2022, which states that the pre-approved document, as then designed, satisfies the applicable provisions of the Internal Revenue Code (IRC). Although the Plan has been amended since the date of the opinion letter, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

### **6. Fair Value Measurements**

The Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurements and Disclosure*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobserved inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

*Mutual Funds* - Mutual funds are valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with the other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 7. Fully Benefit-Responsive Investment Contract

The Plan holds a traditional investment contract that meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because it is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions plus credited interest, less participant withdrawals and fees. At December 31, 2024 and 2023, the contract value of the traditional investment contract was \$299,015 and \$272,011, respectively.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is reviewed every six months.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events may limit the ability of the Plan to transact at contract value with the issuer. The issuer will fully or partially terminate the contract if (a) the Plan provides communication to the issuer that the contract will be fully or partially terminated; (b) the IRS determines that the Plan no longer meets the requirements of the IRC; (c) there is a termination or partial termination of the Plan, (d) the Plan breaches a provision of the contract; or (e) the issuer provides communication to the Plan that the contract will be terminated. The Plan Administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are not probable of occurring.

### 8. Party-in-Interest Transactions

Notes receivable from participants qualify as party-in-interest transactions. The Plan holds an investment in a fully benefit-responsive investment contract managed by Empower, the third-party recordkeeper of the Plan; therefore, these qualify as party-in-interest transactions. Fees paid to the Plan for recordkeeping services were \$71,085 and \$57,481 for the years ended December 31, 2024 and 2023, respectively.
