INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of Lupin Pharmaceuticals, Inc. 401(k) Profit Sharing Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Plan provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General: The Plan, established on April 1, 2004, is a defined contribution plan. The Plan covers all eligible employees of Lupin Pharmaceuticals, Inc. (the Company), Lupin, Inc., Novel Laboratories, Inc., Lupin Research, Inc., and Lupin Management, Inc. (collectively, the Companies). The Plan is subject to the provisions of ERISA.

On December 29, 2022, the SECURE 2.0 Act of 2022 (SECURE 2.0 Act) was signed into law. The SECURE 2.0 Act makes various required and optional changes applicable to tax qualified retirement plans with varying effective dates through 2027. Certain mandatory changes to plan provisions or optional changes to be made to plan provisions as a result of the SECURE 2.0 Act are discussed in these financial statements. The plan document is required to be amended in regard to the requirements of SECURE 2.0 Act by December 31, 2026.

Eligibility: The Plan covers substantially all employees who are 21 years of age or older. Employees who are nonresident aliens, residents of Puerto Rico, leased employees, temporary employees (as defined; effective September 1, 2023) or those covered by a collective bargaining agreement that does not provide for their participation are not eligible to participate in the Plan. However, temporary employees who complete 1,000 hours of service during an eligibility computation period are no longer excluded from participation and will enter the Plan as of the first entry date that follows the completion of the eligibility computation period. Eligible employees may enter the Plan upon the first day of the month following their date of hire.

Contributions: Each year, participants may elect to contribute from 1% up to 90% of their eligible compensation (as defined) up to the maximum allowable contribution amount under the Internal Revenue Code (IRC). These contributions may be made as pre-tax or after-tax Roth deferral contributions. Under the Plan's Automatic Contribution Arrangement provision, a pre-tax deferral contribution of 3% of eligible compensation will automatically be elected, unless otherwise directed by the employee, and will automatically increase 1% each year up to a maximum of 8% (unless the participant elects a higher increase or maximum). Participants may also enter into a separate salary reduction agreement with respect to bonus compensation. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Companies may provide the following contributions on behalf of participants:

A safe harbor matching contribution equal to 100% of a participant's elective deferrals up to 3% of eligible compensation plus 50% of a participant's elective deferrals that exceed 3% but do not exceed 6% of a participant's eligible compensation. The Plan's provisions also provide for a true-up provision under which a participant's safe harbor matching contribution is re-determined on the last day of the plan year based on the participant's elective contributions during the plan year. For 2024, safe harbor matching contributions (including the true-up) totaled \$2,252,747, of which \$331,758 is reported as employers contributions receivable on the Statement of Net Assets Available for Benefits at December 31, 2024.

A discretionary contribution determined by the Companies' Board of Directors. The contribution is to be allocated as of the last day of the plan year by using an integrated formula (as defined). No discretionary contribution was made for 2024.

Contributions - continued:

Qualified Nonelective Contributions (QNECs) and Qualified Matching Contributions (QMACs), as defined in the Plan. No QNECs or QMACs were made for 2024.

Participant Accounts: Each participant's account is credited with the participant's contributions and the Companies' contributions, as well as allocations of plan earnings or losses and administrative fee credits. Participant accounts are charged with any participant requested transaction fees. Allocations are based on participant earnings/losses, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options: Participants may direct the investment of their contributions and the Companies' contributions into various registered investment companies (mutual funds) and common/collective trust funds offered by the Plan. For those participants who do not make an investment selection, their contributions and the Companies' contributions are automatically invested in the Plan's qualified default investment account.

Vesting: Participants are immediately vested in their contributions, QNECs, QMACs and the Companies' safe harbor and previous non-safe harbor matching contributions, plus earnings thereon. Vesting in the Companies' discretionary contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after five years of credited service. Regardless of the vesting schedule, participants will become fully vested upon reaching normal retirement age while an employee, or due to death or total and permanent disability.

Notes Receivable from Participants: Participants may borrow from their eligible fund accounts, as defined, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the participant's nonforfeitable account balance. The notes are secured by the balance in the participant's account, bear interest at prime + 1% and can only exceed a repayment period of five years for the purchase of a principal residence and may not be greater than ten years. Only two notes may be outstanding at a time. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits: Benefit payments may be in the form of lump sums, fixed installment payments (as defined), or partial distributions and are payable upon termination of employment, death, disability, or retirement at age 65. The Plan shall make automatic distributions of vested account balances that are less than \$7,000 (as updated by the SECURE 2.0 Act) in accordance with plan provisions. Distributions from a participant's rollover account may be made at any time. Hardship withdrawals and in-service withdrawals at age 59 ½ are also permitted, subject to provisions defined in the plan document.

Forfeitures: Forfeitures of the Companies' discretionary contribution (due to participants' termination prior to full vesting) and payroll adjustments processed by the plan sponsor (to correct contribution overfundings) are to be used to pay administrative expenses and reduce future employer contributions. Any remaining forfeitures may be allocated to participants as a discretionary contribution. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$206,959 and \$191,107, respectively. Forfeitures and payroll adjustments of \$2,683 were used during 2024 to offset employer contributions.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amount of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Basis of Accounting: The Plan's financial statements are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Retirement Plan Committee determines the Plan's valuation policies utilizing information provided by the Plan's investment advisor and the trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Unit Values: Individual participant accounts for the common/collective trust funds are maintained on a unit value basis. Participants do not have beneficial ownership in the specific underlying securities or other assets in the trust funds, but do have an interest therein represented by units valued daily. The trust funds earn investment income which accumulates in the net asset value and is automatically reinvested in additional units and the trust funds are charged trustee fees monthly. Generally, contributions to and withdrawals from each trust fund are converted to units by dividing the amounts of such transactions by the unit values last determined (see Note 3), and the participants' accounts are charged or credited with the number of units properly attributable to each participant.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes are reclassified as distributions based on the terms of the plan document.

Contributions: Contributions from plan participants and the safe harbor matching contributions from the Companies are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits: Benefits are recorded when paid. As of December 31, 2024 and 2023, there were no significant amounts due but unpaid to participants.

Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Companies. Expenses that are paid by the Companies are excluded from these financial statements. Investment management fees of individual fund investments are charged to the respective investment and included in the net appreciation/depreciation of the investment as they are paid through revenue sharing. Fees related to the administration of notes receivable from participants and participant distributions are charged directly to the participant's account and are included in administrative expenses.

Expenses - continued: An ERISA Budget Account funded by excess revenue sharing prior to 2019 is available to pay administrative expenses of the Plan. At December 31, 2024 and 2023, the balance in the ERISA Budget Account was \$38,147 and \$36,325, respectively. No administrative expenses were paid from the account during 2024.

NOTE 3 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2

Inputs to the valuation methodology include (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability; and (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered Investment Companies: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

T. Rowe Price Retirement Trusts: The trust funds are valued daily at the NAV as provided by its trustee and are based on the fair value of the underlying trusts (which are other trusts offered by the trust company) which invest directly in securities. The NAV is used as a practical expedient to estimate fair value. Unit values are computed by dividing total net assets by the total number of units outstanding on the valuation date.

T. Rowe Price Stable Value Common Trust Fund: The trust fund primarily invests in fully benefit responsive investment contracts. The trust fund is valued daily at the NAV as provided by its trustee and is based on the fair value of the underlying assets except for certain investment contracts that generally are valued at contract value. The NAV is used as a practical expedient to estimate fair value. The trust fund maintains a stable \$1 unit price.

Redemptions are processed daily at NAV. The T. Rowe Price Retirement Trusts' unitholders may be required to provide up to 30 days advance written notice to the trustee prior to redemption of units. Total or partial plan level withdrawals from the T. Rowe Price Stable Value Fund require 12 or 30 months' advance written notice, as applicable. However, the notice periods may be shortened or waived by the trustee in its sole discretion. There are no unfunded commitments.

NOTE 4 - INFORMATION CERTIFIED BY A QUALIFIED INSTITUTION

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest income on notes receivable from participants and dividend income for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by T. Rowe Price Trust Company (T. Rowe Price), a qualified institution and trustee of the Plan.

NOTE 5 - TAX STATUS

The Internal Revenue Service (IRS) has determined and informed T Rowe Price Retirement Plan Services Inc, by a letter dated August 19, 2020, that the prototype plan adopted by the Plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 - RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS

The Plan's investments consist of common/collective trust funds managed by T. Rowe Price Trust Company and the U.S. Treasury Money Fund managed by T. Rowe Price Associates, Inc., related parties of T. Rowe Price Group, Inc. and therefore, these transactions qualify as party in interest transactions.

T. Rowe Price Retirement Plan Services, Inc. (TRPRPS), a subsidiary of T. Rowe Price Associates, Inc., provides certain administrative and recordkeeping services to the Plan pursuant to the Plan Recordkeeping Agreement (the Agreement) between the Company and TRPRPS. In conjunction with the Agreement, TRPRPS receives certain administrative fees (fee credits) from non-proprietary mutual funds and the U.S. Treasury Money Fund as compensation for the recordkeeping and shareholder services it provides. These fee credits reduce the amount of expenses that would otherwise be payable pursuant to the Agreement. On a quarterly basis, TRPRPS provides an allocation of any remaining fee credits to plan participants, as directed. Participants also pay transactional fees relative to administration of notes receivable from participants and participant distributions. The Companies make payments to TRPRPS for per participant recordkeeping fees and other administrative expenses not covered by the administrative fees. Transactional fees paid to TRPRPS amounted to \$8,290 for 2024.

NOTE 7 - DELINQUENT CONTRIBUTIONS

During the plan years ended December 31, 2024, 2023, 2022 and 2017 employee contributions and loan repayments in the amount of \$320,183 were not remitted by the Companies to the Plan within the required timeframe, as defined by ERISA. As such, these transactions constitute prohibited transactions and are reported on the supplemental Schedule of Delinquent Participant Contributions (Schedule H, Line 4a). Certain corrections on the delinquent employee contributions and loan repayments were remitted to the Plan during 2024 and the remainder are expected to be calculated and remitted to the Plan during 2025.

NOTE 8 - PLAN TERMINATION

Although they have not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and the Company may terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in the Companies' discretionary contributions.

NOTE 9 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits. As of December 31, 2024 and 2023, 63% and 66%, respectively, of net assets available for benefits is invested in the T. Rowe Price Retirement Trusts; however, by their nature, these trusts are a diversified mix of equities and fixed income that rebalance over time.

NOTE 10 - SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

Effective May 1, 2025, participants may elect to treat their employer safe harbor matching contribution as an after-tax Roth contribution.
