NOTES TO FINANCIAL STATEMENTS

1. Plan Description and Summary of Significant Accounting Policies

The following description of the Cenneidigh, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General Information

The Plan is a 401(k) salary reduction plan which was established on April 15, 2018 and last amended and restated effective January 1, 2021. The Plan covers substantially all employees (other than part-time or seasonal employees, certain nonresident aliens, reclassified employees and leased employees) of Cenneidigh, Inc., KCQ, Inc., Inisfail, Inc., and Glendalough of Austin, Inc. (collectively, the Company) who have attained age 18. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Plan Administration

The Custodian of the Plan's assets is Alerus Financial, N.A. The Plan is administered by trustees whose members are appointed by the Company. The trustees have the authority to control the operation, management and administration of the Plan.

Contributions

Each year, participants may contribute up to the maximum allowable not to exceed the limits of Internal Revenue Service (IRS) Code Section 401(k), as defined in the Plan. Contributions to the Plan are allowable on a pre-tax basis and/or on an after-tax basis (Roth contributions). Participants who have attained the age of 50 before the end of the plan year are also eligible to make catch-up contributions in any amount up to the limits prescribed by law. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their account into various investment options offered by the Plan.

1. Plan Description and Summary of Significant Accounting Policies (Continued)

Contributions (continued)

The Company may contribute to the Plan discretionary matching and/or nonelective contributions. The Company contributed a matching contribution of 50% of the participant's contribution up to the first 5% of a participant's compensation for the years December 31, 2024 and 2023. A participant was entitled to employer discretionary nonelective contributions if employed on the last day of the plan year and had completed 1,000 hours of service during the plan year. There were no discretionary nonelective contributions made for the years ended December 31, 2024 and 2023.

Participant Accounts

Each participant's account is credited with the participant elective deferrals, employer matching contributions (if any), employer nonelective contributions (if any) and an allocation of plan earnings. Allocations of plan earnings are based on the valuation of the investments (participant-directed) held in each participant's account. Participants' accounts are valued on a daily basis. The benefit the participant is entitled to is the benefit that can be provided from the participant's account.

Vesting

A participant shall at all times have a fully vested, nonforfeitable interest in his or her salary deferral contributions and rollover contributions. Vesting in the Company matching and/or nonelective contributions is based on years of continuous service. A participant is fully vested in their account after 6 years of service, upon reaching normal retirement age (defined in the plan as age 65), upon death or upon permanent disability.

The Company matching and/or nonelective contributions and earnings thereon vest in accordance with provisions of the Plan as follows:

For vesting purposes, a year of service is at least 1,000 hours of service in the plan year.

Forfeited Accounts

Terminated participants forfeit the non-vested portion of their account upon the earlier of distribution of their vested benefits or after incurring five consecutive one-year breaks in service. Forfeitures are used by the employer to reduce participant plan expenses and employer matching contributions. There were \$23,995 of forfeitures during the year ended December 31, 2024, and forfeitures in the amount of \$17,112 were used to pay plan expenses. There were \$5,903 of forfeitures during the year ended December 31, 2023, and forfeitures in the amount of \$14,094 were used to pay plan expenses.

As of December 31, 2024 and 2023, forfeited non-vested amounts totaling \$10,536 and \$8,311, respectively, were available to reduce future employer matching contributions or to pay plan expenses.

Notes Receivable from Participants

The Plan does not allow for participants to borrow from their fund accounts.

Payment of Benefits

Upon termination of employment, disability, death, or retirement, participants may receive the value of the participant's vested interest in the form of a lump-sum payment or if the balance exceeds \$7,000, elect to defer the benefit payment in accordance with plan guidelines. If the participant's account balance is between \$1,000 and \$7,000, the participant's balance will be paid in the form of a direct rollover to an IRA if no other election is made by the participant. Participant balances that are less than \$1,000 will be paid to the participant in the form of a lump-sum distribution.

The Plan allows for early retirement distributions at age 59 ½. The Plan also allows for hardship withdrawals from participants' accounts.

Benefit payments are recorded upon distribution to participants.

1. Plan Description and Summary of Significant Accounting Policies (Continued)

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion on fair value measurements.

All purchases and sales of securities have been recorded on a trade-date basis. Income is recorded as earned. The increase or decrease in the fair value of investments represents the net difference between the current value of securities held at the beginning of the year or cost of securities purchased during the year and the current value of securities held at the end of the year.

Administrative Expenses

The Company pays certain administrative expenses on behalf of the Plan. Expenses paid by the Plan are included in the statement of changes in net assets available for benefits.

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

2. Certification of Investments

The Board of Directors appointed Alerus Financial, N.A. (Alerus) as custodian of the Plan's assets. Alerus has supplied the plan administrator with certifications as to the completeness and accuracy of plan assets aggregating \$2,618,888 and \$2,814,850 as of December 31, 2024 and 2023, respectively, and the related investment income of \$414,763 and \$425,909, respectively, for the years then ended. Such amounts and all related financial data are included in the accompanying financial statements and supplemental schedule based on the certifications from the custodian.

Under the terms of the custodial agreement, the Custodian manages investment funds on behalf of the Plan. The Custodian has been granted non-discretionary authority concerning the purchases and sales of the investments in the investment funds.

3. Fair Value Measurements

Accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Observable market-based inputs or unobservable inputs that are corroborated by market data. Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

3. Fair Value Measurements (Continued)

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce fair values that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Plan Termination

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

5. Plan Tax Status

The Plan has adopted a prototype plan document, which has received an opinion letter from the Internal Revenue Service stating that the plan document and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

The Plan evaluates all significant tax positions as required by generally accepted accounting principles in the United States. As of December 31, 2024, the Plan does not believe that it has taken any tax positions that would require the recording of any additional tax liability nor does it believe that there are any unrealized tax benefits that would either increase or decrease within the next twelve months. The Plan's income tax returns are subject to examination by the appropriate regulatory authorities as of December 31, 2024, and the Plan's federal tax returns generally remain open for three years.

6. Risk and Uncertainties

The Plan provides for investment in a variety of investment funds. In general, investments are exposed to various risks, such as interest rate, credit and overall market volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

7. Party-in-Interest Transactions

Certain plan investments are managed by Alerus Financial, N.A. (Alerus). Alerus is the Custodian of the Plan's assets and, therefore, these investment transactions qualify as party-in-interest transactions. However, the transactions are not considered prohibited transactions as ERISA regulations provide for a specific exemption for such transactions.

Additionally, certain employees of the Company provide certain accounting and administrative services to the Plan for which no fees are charged. These transactions are permitted under ERISA regulations.
