As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter — Supplemental Schedules Required by ERISA

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

1. Description of Plan:

The following description of the Farah and Farah, P.A. 401(k) Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan, established on January 1, 1997, is a defined contribution plan covering all full-time employees of Farah and Farah, P.A. (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Eligibility

Employees who have completed 3 months of service are eligible to contribute to the Plan, except union employees, leased employees, non-resident aliens, and flexible schedule employees. Upon meeting the eligibility requirements, employees may enroll on the first day of each quarter following the date the employee satisfies the Plan’s eligibility requirements.

Employees who are age 21 and have completed 1 year of service, with 1,000 hours for a year of crediting service, are eligible to participate in employer contributions in the Plan.

Contributions

Each year participants may elect to contribute up to the maximum of their pretax annual compensation as determined by the Internal Revenue Service (“IRS”) and as defined by the Plan. In addition, employees who have attained age 50 by the end of the Plan year may make catch-up contributions up to limits defined by the IRS. Participants may also contribute amounts representing distributions from other qualified plans.

The Company has elected safe harbor provisions. Safe harbor matching contributions are 100% of a participant's contribution (not in excess of 3% of eligible compensation), and 50% of the participant's contributions (in excess of 3% but not in excess of 5% of eligible compensation), subject to certain Plan limitations. Additional nonelective profit sharing amounts may be contributed at the discretion of the Company up to 4% of eligible compensation. During 2024, the Company did not make any additional nonelective profit-sharing contributions to the Plan.

Investment Options

Participants may direct the investment of their account balances into various investment options offered by the Plan. The Plan currently offers a variety of mutual funds and a guaranteed investment contract as investment options for participants.

Notes to Financial Statements

1. Description of Plan (Continued):

Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of Company contributions, and Plan earnings. Participant earnings are based on an allocation of Plan earnings respective to each participant's account balances and investment selections. Any related administrative expenses based on participant earnings or account balances are deducted from the participant's account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested balance.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and must be repaid in level payments through payroll deductions over a 5-year period, except for loans for the purchase of a principal residence which may be repaid over a period up to 20-years. The loans bear interest at the prime rate as published by the Wall Street Journal plus 1%. The Plan allows participants to have 2 loans outstanding at a time.

Administrative Expenses

In accordance with Plan provisions, the Company or the Plan may pay administrative expenses of the Plan. Recordkeeping and other administrative services expenses are paid by the Plan and allocated to participant accounts. Plan expenses charged for transactions that are participant specific are deducted from the respective participant account.

Vesting

Participants are immediately 100% vested in their elective deferrals including catch-up contributions, rollover contributions from other plans, and actual earnings thereon. Vesting in the Company's nonelective profit-sharing contribution portion of their accounts plus actual earnings thereon is based on years of continuous service with 1,000 hours for a year of crediting service.

Participant vesting in employer nonelective profit-sharing contributions are as follows:

Participants are immediately 100% vested in all safe harbor employer contributions. All employer contributions become fully vested in the event of death, disability, or after reaching normal retirement age while under the Company's employment.

1. Description of Plan (Continued):

Benefits Paid to Participants

On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive a lump-sum distribution equal to the value of the participant's vested interest in their account in accordance with Plan provisions. In-service withdrawals are allowed for participants who attain the age of 59 ½. Additionally, under certain circumstances of financial hardship, the participant is allowed to withdraw funds from the Plan.

Account balances that are under \$7,000 may be automatically distributed upon termination of service as a lump sum without the consent of the participant.

Forfeited Accounts

Forfeitures of non-vested participant balances are generally used to pay Plan expenses and reduce future employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$10,466 and \$10,320, respectively. During 2024, there were no forfeitures used to pay Plan expenses or reduce employer contributions.

2. Summary of Accounting Policies:

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are presented at fair value, except fully benefit-responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements. Contract value is the relative measurement attribute for that portion of the net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of investments are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded as earned on the accrual basis. Net appreciation (or depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. Realized gains and losses on the sales of securities are reported on the average cost method.

2. Summary of Accounting Policies (Continued):

Notes Receivable from Participants

Notes receivable from participants are reported at amortized principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent notes receivable from participants are reclassified as distributed based upon the terms of the Plan document. The loans are secured by the balance in the participants' accounts.

Payment of Benefits

Benefits are recorded when paid.

Risks and Uncertainties

The Plan invests in a combination of investment securities which are exposed to various risks, such as interest rates, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

3. Fair Value Measurements:

Financial Accounting Standards Board, Statement of Accounting Standards Codification Topic 820 (ASC 820), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly.

Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

In many cases, a valuation technique used to measure fair value includes inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy. The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

3. Fair Value Measurements (Continued):

Mutual funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

4. Investment Contract with Insurance Company:

The Plan invests in a fixed account group annuity contract with Great-West Life & Annuity Insurance Company (“GWI”), which is a fully benefit-responsive investment contract. GWI maintains the contributions in a general account. The account is credited with contributions and earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

The guaranteed investment contract issuer is contractually obligated to repay the principal and a guaranteed minimum interest rate of 0.10% to the Plan.

The guaranteed investment contract is fully benefit-responsive, and as such contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed interest contract. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Contract value of the guaranteed investment contract was \$55,396 and \$24,779 at December 31, 2024 and 2023, respectively. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include but may not be limited to the following: 1) complete or partial termination of the Plan, 2) the establishment or activation of, or material change in, any Plan investment fund, or an amendment to the Plan or a change in the administration or operation of the Plan, including offering a competing fund (a fund with similar investment strategies and assets as the investment contract) without the approval of GWI. The guaranteed interest contract permits contract termination with sufficient notice or with other violations of the contractual terms.

5. Information Certified by Custodians:

Investments, except the guaranteed investment contract, included in the statements of net assets available for benefits as of December 31, 2024 and 2023, and the dividend and interest income and net appreciation in fair value of investments included in the statement of changes in net assets available for benefits for the years ended December 31, 2024 have been derived from information certified as complete and accurate by Empower Trust Company, LLC, custodian, in accordance with 29 CFR 2520.103-5(c) of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

The guaranteed investment contract included in the statements of net assets available for benefits as of December 31, 2024 and 2023, and the dividend and interest income and net appreciation in fair value of investments included in the statement of changes in net assets available for benefits for the year ended December 31, 2024 have been derived from information certified as complete and accurate by Empower Annuity Insurance Company of America, custodian, in accordance with 29 CFR 2520.103-5(c) of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

6. Parties-in-Interest Transactions:

Empower Trust Company, LLC (“Empower”) is the trustee and custodian and manages the GWI guaranteed investment contract; therefore, transactions involving these parties qualify as party-in-interest transactions permitted under provisions of ERISA. Fees paid to Empower entities, which are subsidiaries of GWI, by the Plan for investment management services amounted to \$5,206 for the year ended December 31, 2024. Revenue received on investments managed by Empower related to revenue sharing may be applied to pay Plan expenses or allocated to participant accounts. During 2024, the Plan received \$87,555 in revenue sharing that reduced administrative expenses in the accompanying statement of changes in net assets.

BDO USA, LLP (“BDO”) provides contract management services to the Plan. Accordingly, transactions with these companies qualify as party-in-interest transactions. During 2024, the Plan paid BDO \$26,563 for contract administration services.

JW Cole Advisors Inc. (“JW Cole”) provides investment management and advisory services to the Plan. Accordingly, transactions with these companies qualify as party-in-interest transactions. During 2024, the Plan paid JW Cole \$68,791 for investment management and advisory services.

Included in the Plan assets are notes receivable from participants. At December 31, 2024 and 2023, notes receivable from participants amounted to \$439,078 and \$370,930, respectively. For the year ended December 31, 2024, interest income related to notes receivable from participants amounted to \$30,438. These transactions qualify as party-in-interest transactions permitted under provisions of ERISA.

7. Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants will become 100 percent vested in their accounts.

8. Tax Status:

The Plan obtained a determination letter on June 30, 2020, in which the IRS stated that the Plan was designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and tax counsel believe the Plan is currently being operated in compliance with the applicable requirements of the IRS.

Management has evaluated the Plan's tax positions and concluded that the Plan had taken no uncertain tax positions that require recognition of liability (or asset) in the accompanying financial statements. With few exceptions, the Plan is no longer subject to income tax examination by the U.S. federal, state or local tax authorities for years before 2021.

9. Subsequent Events:

Management has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be filed and has determined that there were no material events requiring recognition or disclosure.
