Opinion

1. Description of Plan

The following description of the Watt, Tieder, Hoffar & Fitzgerald, LLP Profit Sharing 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established effective January 1, 1986, as restated January 1, 2022. The Plan covers all employees, excluding union employees, nonresident aliens and leased employees, of Watt, Tieder, Hoffar & Fitzgerald, L.L.P. (the Partnership) who have completed 1,000 hours of service in a six-month period and are age 21 or older. Long-term part-time employees who met eligibility requirements under the SECURE 2.0 Act are also eligible to participate in the Plan. Participants who are not classified as attorneys are eligible for the employer matching contribution. The Plan requires a participant to be employed as of year end to be eligible to receive the top-heavy employer contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Pension Investment Committee is responsible for oversight of the Plan. The Plan's Pension Investment Committee determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

Contributions

Each year, participants may contribute a percentage of pretax annual compensation, as defined in the plan document, up to the maximum limits of the Internal Revenue Code (IRC). Participants may also designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan provides for a discretionary employer matching contribution, with the matching percentage determined on an annual basis. If the Plan is determined to be top heavy, the Partnership is required to make a 3% contribution to those participants who are not eligible to participate in the Partnership's other profit sharing plan. For the year ended December 31, 2024, the Partnership contributed a matching contribution equal to 25% of nonattorney participant contributions to the Plan. For the year ended December 31, 2024, the Plan was determined to be top heavy; therefore, the Partnership approved a \$308,611 profit sharing contribution to the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of the Partnership's discretionary contributions and an allocation of the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Partnership's contribution portion of their accounts is based on years of continuous service. A participant is 20% vested after two years of credited service and continues to vest in increments of 20% until 100% vested after six years of credited service.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of (a) \$50,000 or 50% of their vested account balance, or (b) \$50,000 reduced by the excess of the highest outstanding balance of notes receivable from the participant during the one-year period ending on the day before the note is issued, over the outstanding balance of notes receivable from the participant on the date the note is issued. The loans are secured by the balance in the participant's account. The loan interest rate, determined with changes in the published Prime interest rate, is set at a commercially reasonable rate, as defined. Principal and interest are typically paid through monthly payroll deductions. No more than five notes per participant may be outstanding at any point in time. Terms range up to five years or greater for the purchase of a primary residence.

Payment of Benefits

Upon termination of service, a participant may elect to receive either a lump-sum amount equal to the value of their account or required minimum distributions upon reaching retirement age. If the value of a participant's account upon termination of service was greater than \$1 but less than \$7,000 and, if the participant did not elect to have such distribution paid directly or rolled over into an eligible retirement plan, then the plan administrator paid the distribution in a direct rollover to an individual retirement account designated by the plan administrator in the participant's name. Accounts under \$1 are distributed in cash.

Forfeited Accounts

The nonvested percentage of a participant's account is forfeited by the participant upon distribution of their account or after five consecutive years following the date of the participant's termination of employment with the Partnership, whichever is earlier. Participant forfeitures are retained in the Plan and are used to reduce future Partnership contributions. If the participant is re-hired within a five-year period, any undistributed forfeited amounts will be restored to their account. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$21,007 and \$40,920, respectively. For 2024, employer contributions were reduced by \$50,240, from forfeited nonvested accounts, in accordance with plan provisions.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Partnership. Expenses that are paid by the Partnership are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Certain investment related expenses are included in net appreciation in fair value of investments.

Recent Regulatory Updates

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory and certain optional provisions effective for the year ended December 31, 2024, and continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. The application of the SECURE 2.0 Act did not have a material effect on the Plan's financial statements.

Subsequent Events

Subsequent events were evaluated through October 13, 2025, the date the financial statements were available to be issued.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Investments measured at net asset value: Common/collective trust represents the Plan's stable value product. The common/collective trust invests primarily in short-term and long-term investment contracts issued by insurance companies (GICS), investment contracts issued by commercial banks, synthetic investment contracts comprising underlying assets and a "wrapper" contract issued by a third party and cash equivalents represented by units in the trustee's money market portfolios, all of which are subject to the credit quality standard established by the trustee. The objective of the common/collective trust is to provide a low-risk, moderate-yield investment. The fund is managed to earn a consistent level of return, while providing for preservation of capital, high credit quality and liquidity to pay plan benefits. Fair value is determined using the NAV of the funds. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of a collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

4. Concentrations

As of December 31, 2024 and 2023, the Plan had investments of \$16,781,817 and \$12,899,811, respectively, that were concentrated in two funds.

5. Related-Party and Party in Interest Transactions

Certain Plan investments are managed by an affiliate of one of the custodians, and therefore, these transactions qualify as party in interest transactions.

Fees incurred by the Plan for certain investment management services are included in net appreciation in the fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. The custodians receive revenue from investment fund service providers for services the custodians provide to the funds. This revenue is used to offset certain amounts owed to the custodians for their administrative services to the Plan. If the revenue received by the custodians from such investment fund service providers exceeds the amount owed for their services, the custodians remit the excess to the Plan's trust on a quarterly basis. The Plan or Plan Sponsor may make a payment to the custodians for administrative expenses not covered by revenue sharing.

Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Partnership. No such officer or employee receives compensation from the Plan.

6. Plan Termination

Although it has not expressed any intent to do so, the Partnership has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

7. Tax Status

The Plan adopted a pre-approved plan offered by CCH Incorporated, DBA ftwilliam.com. The pre-approved plan received an IRS Opinion Letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the IRS Opinion Letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

9. Administration of Plan Assets

The Plan's assets were administered under contracts with Newport Trust Company, LLC (Newport), Ascensus Trust Company, LLC (Ascensus) and Charles Schwab Trust Bank (Charles Schwab). Newport and Charles Schwab served as custodians of the Plan prior to April 18, 2024, including the period from January 1, 2024 through April 17, 2024. Newport Trust Company, LLC combined with Ascensus Trust Company, LLC, and as a result, beginning April 18, 2024, Ascensus and Charles Schwab became custodians of the Plan. The custodians invest funds received from contributions, investment sales, interest and dividend income and make distribution payments to participants.
