NOTE 1: PLAN DESCRIPTION

A) General

The Cenlar Capital Corporation Employees' Stock Ownership Plan (the "Plan"), as effective on April 1, 1977, is a defined contribution plan whose purpose is to enable its participants to obtain a beneficial interest in the common stock of Cenlar Capital Corporation (the "Company"). Effective January 1, 2002, the Company elected S-Corporation status, which is retained until January 1, 2024. On this date, the Company revoked its S-Corporation election and returned to a C-Corporation status. The following brief description of the Plan is provided for general information purposes only. Participants should refer to the Plan Document for more complete information. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

B) Administration of Plan Assets

The ESOP Trustee directs the investment of cash, interest and dividends received as well as the processing of distributions to participants and the payment of Plan expenses. Certain administrative functions are performed by officers or employees of the Company or its subsidiaries. No such officers or employees receive compensation from the Plan.

C) Eligibility

Participants are eligible to participate in the Plan if they:

- Are employed by the Company or any participating affiliate or subsidiary;
- Have reached age 21;
- Completed 1,000 Hours of Service at the close of their first full 12 months of employment or subsequent Plan Year; and
- Are not covered by a collective bargaining agreement excluding them from participation in the Plan; and
- Are not a leased employee.

D) Contributions and Participant Accounts

Discretionary contributions to the Plan are made by the Company and are determined by the Company's Board of Directors. Contributions are allocated to each active participant's account in the form of shares of common stock and cash, and are based on the participant's eligible annual salary as a percentage of the total eligible annual salaries of all active participants. In 2024, no contributions were made to the Plan. In 2023, \$8,500 in cash was contributed to the Plan.

In 2024 and 2023, the plan did not receive any dividend distributions. When made, dividend distributions are allocated based on the number of shares of Company Stock allocated to the Participant's Account as of the beginning of the Plan Year less shares distributed or forfeited during the plan year.

E) Income Allocation

Income earned by the Plan is determined at the end of each year and is apportioned among the participant's accounts in proportion to the opening balance of each account adjusted for distributions and forfeitures during the plan year.

F) Vesting

All shares of common stock and cash credited to a participant's account become fully vested upon the earliest of the following events: (1) completion by the participant of three vesting years for participants with initial eligible service on or after January 1, 2007 and upon completion of five vesting years for participants with initial eligible service before January 1, 2007; (2) attainment of age 65, or (3) termination of employment due to death or permanent disability. A vesting year is each twelve month period beginning January 1 in which an employee has at least 1,000 hours of recognized service.

G) Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in company stock into investments that are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is available to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25 percent of the number of post-1986 shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50 percent. Participants who elect to diversify may receive a cash distribution or roll over the distribution into another qualified retirement plan.

H) Forfeitures

The non-vested portion of a participant's account shall be forfeited and deemed to be a Company contribution to the plan for the plan year in which the forfeiture occurs upon completion of a five year break in service. Forfeitures for 2024 and 2023 amounted to \$531 and \$1,603 respectively.

I) Distributions

Distributions of vested benefits normally are made upon a participant's election to diversify, and for retirement, death or permanent disability. The amount to be distributed is based upon the stock valuation as of December 31 immediately preceding the distribution. However, for terminated participants whose vested accounts do not exceed and have never exceeded \$1,000, the participant may elect to receive such vested account balance in a lump sum by the end of the following year. For those terminated participants with a balance between \$1,000 and \$50,000, the participant may elect to receive such vested account balance in five installments by the end of the following year. Participants may receive a cash distribution or roll over the distribution into another qualified retirement plan.

J) Amendment and Termination

Although it has not expressed any intent to do so, the Company has reserved the right to terminate the Plan, however no such action may deprive any participant or

beneficiary under the Plan of any vested right or cause any part of the Plan assets to be reverted to the Company.

K) Concentrations

As of December 31, 2024 and 2023, approximately 95% of the Plan's assets are invested in the Company's common stock.

L) Voting Rights

The Trustee shall vote all shares of Company stock held by the Plan with respect to all corporate matters upon which Company shareholders are entitled or permitted to vote. Notwithstanding the foregoing, each Participant in the Plan shall direct the Trustee as to voting of shares of Company Stock held in his or her Account in the Trust and not held in the Unallocated Stock Suspense Account with respect to any shareholder vote for both director candidates, or that is required for the approval or disapproval of any corporate merger or consolidation, recapitalization, reclassification, liquidation, dissolution, or sale of substantially all the assets of a trade or business. A Participant who is entitled to such pass-through voting shall, at the time any proxy materials are forwarded to Company shareholders for each annual or special meeting, receive from the Company such proxy materials and a proxy form upon which voting directions may be indicated to the Trustee. Each Participant shall have one vote for each share of Company Stock in his or her Company Stock Account. The Trustee shall vote such allocated shares of Company Stock as instructed by Participants. Allocated shares for which no direction is received shall not be voted by the Trustee.

M) Put Option

Under Federal income tax regulations, the employer stock that is held by the Plan is not readily tradable on an established market and includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market and can be exercised at the time of distribution, or in the following calendar year. The put price is representative of the fair market value of the stock. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

N) Investments

In addition to Cenlar Capital Corporation's Common Stock, the Plan invests in the following during 2024:

- The Goldman Sachs Financial Square Government Fund. The Fund seeks to maximize current income to the extent consistent with the preservation of capital and the maintenance of liquidity by investing exclusively in high quality money market instruments. The Fund only invests in U.S. government securities and repurchase agreements relating to such securities.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A) Basis of Accounting

The accompanying financial statements of the Cenlar Capital Corporation Employee's Stock Ownership Plan have been prepared on an accrual basis and present the net assets available for benefits and changes in those net assets.

B) Investment in Cenlar Capital Corporation's Common Stock

Cenlar Capital Corporation is a closely-held corporation and there is no established market for its stock. The common stock value is based upon fair value. See Note 5 for discussion of fair value measurements. Dividend income is accrued on the dividend declaration date.

C) Use of Estimates

The preparation of financial statements, in conformity with U.S. generally accepted accounting principles (GAAP), requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

D) Risks and Uncertainties

The Plan investments include the Company's common stock, which is exposed to various risks such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows and/or other such techniques. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in the estimations and assumptions process, changes in the value of the common stock may occur in the future and such changes could materially affect the amounts reported in the statement of net assets available for benefits. Such changes will be reflected in the financial statements in future periods.

E) Operating Expenses

All expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

NOTE 3: TAX STATUS

The Plan has received a determination letter from the IRS dated September 19, 2022, stating that the Plan is qualified under Section 401(a) of the Code, and, therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken

an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 4: INVESTMENTS

The Plan's investments are held in a trust administered by the Trustee.

NOTE 5: FAIR VALUE MEASUREMENT

FASB ASC Topic 820, "Fair Value Measurement and Disclosures," establishes a framework for measuring fair value. Fair value, also referred to as an exit price, is defined as the price that would be received for an asset or paid to transfer a liability in an orderly transaction between market participants on the measurement date. The fair value accounting guidance provides a three-level fair value hierarchy for classifying financial instruments. This hierarchy is based on the markets in which the assets or liabilities trade and whether the inputs to the valuation techniques used to measure fair value are observable or unobservable. The fair value measurement of a financial asset or liability is assigned a level based on the lowest level of any input that is significant to the fair value measurement in its entirety.

The three levels of the fair value hierarchy are described below:

- Level 1 Inputs – Valuation is based on quoted prices (unadjusted) in active markets for identical assets or liabilities.
- Level 2 Inputs – Valuation is based on observable market-based inputs, other than quoted prices in active markets for identical assets or liabilities, quoted prices in markets that are not active, or models using inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.
- Level 3 Inputs – Valuation is generated from techniques that use significant assumptions not observable in the market.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as compared to prior periods.

Money Market Funds: The Company has investments in money market accounts. Fair value inputs for these investments are known and observable through daily published floating net asset values.

Cenlar Capital Corporation's Common Stock: The Cenlar Capital Corporation common stock held by the Plan is valued at estimated fair market value based upon an independent appraisal. The appraiser utilizes methodologies it has determined to be most appropriate including derivation of adjusted income statements, development of cost of capital, income

statement projection, discounted cash flows, guideline public company overview, guideline public company method and summary of restricted stock studies.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

At December 31, 2024, the Plan held 1,083,615 shares of common stock of the Company, which had an estimated fair value of \$65,558,691. The estimated fair value of the common stock increased \$6,473,315 during 2024, following distributions of \$5,988,334 and unrealized gains of \$12,461,649. The estimated fair value of the common stock decreased \$1,205,824 during 2023. At December 31, 2024 and 2023, accounts of the participants were allocated 1,083,614.73 and 1,205,824 shares of common stock respectively.

The Company does not have significant concentrations of credit risk, as the stock of Cenlar Capital Corporation represents the majority of investment balances.
