NOTE 1: DESCRIPTION OF THE PLAN

The following description of the Ad Art Company 401(k) Plan, (the Plan) provides only general information. Participants should refer to the Plan document for a more comprehensive description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of the R.J. Acquisition Corp. dba the Ad Art Company (the Company and the Plan Sponsor), who may participate in the plan after three months of service and are age eighteen or older. An employee who has met the eligibility requirements can enter the Plan immediately. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan administrative committee is responsible for the operation and administration of the Plan.

Effective March 27, 2020, the Plan administratively adopted the provisions of the Coronavirus Aid, Relief, and Economic Security (CARES) Act, related to participant loans and distributions. The Organization has until December 31, 2025, to amend the Plan for changes allowed by the CARES Act. The Plan has not been formally amended to adopt these provisions as of December 31, 2024.

Contributions

Participants may make pre-tax contribution to the Plan and or Roth 401(k) contributions up to the maximum allowed by law. However, participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute Roll Over contribution, which represents amounts representing distribution from other qualified plans.

Participants direct the investment of all contributions into various investment options offered by the Plan

Participant Accounts

Each participant's account is credited or charged with his or her contributions and an allocation of Plan earnings or losses. Each participant's account is charged with an allocation of management fees. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefits that can be provided from participant's vested account.

Investment Options

The Plan currently offers diversified investment funds as investment options for participants. The participants may change their investment options at any time.

Vesting

Participants are immediately vested in all contributions plus actual earnings thereon.

Payments of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account either a lump-sum amount, or transfer the vested balance to a qualified plan, or leave the vested balance in the Plan. For participant with vested balance account less than \$5,000 will receive the value to the vested interest in his or her account as a lump-sum distribution. The Plan also allows in-service for participants over the age requirements and hardship withdrawals before retirement age for qualifying circumstances defined in the Plan agreement.

Notes Receivable from Participants

Participants may borrow from their account balances, provided that the loan does not exceed 50% of their vested account balance a minimum of \$1,000 up to a maximum of \$50,000, at the date of the loan application, and are generally segregated investments of the participants borrowing the money. The loans are secured by the vested balance in the participant's account and bear interest at local prevailing rates. Borrowers repay principal and interest over five years or less via regular payroll deductions, or a reasonable period of time longer than five years for the purchase of a primary residence.

Administrative Expenses

The administrator's expenses were paid by the Company. The trustee fees of basis points of assets invested were paid directly from these assets. Additional fees will also be applicable on benefit disbursements, loans, and periodic benefit payments, which are charge on participants' accounts.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in the employer contributions.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain amounts and disclosures. Accordingly actual results could differ from those estimates.

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP") as set forth by the Financial Accounting Standards Board (the "FASB").

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

Date of Management's Review

Subsequent events were evaluated through October 14, 2025, which is the date the financial statements were available to be issued.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis.

Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net realized and unrealized depreciation and appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year. See Note 3 for discussion on fair value measurements and trustee certification.

Payments of benefits and Corrective distributions

Benefits are recorded when paid. Corrective distributions are recorded when incurred.

NOTE 3: SUMMARY OF UNAUDITED INFORMATION

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. NOTE 4: INVESTMENTS

All Plan investments are participant-directed and held by the Trustee as of December 31, 2024 and 2023. Participants can direct their accounts among various mutual funds and a money market fund.

NOTE 5: FAIR VALUE MEASUREMENTS

ASC 820, *Fair Value Measurements*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). All of the Plan's investments were valued at Level One of fair value measurement hierarchy at December 31, 2024 and 2023. Under Level One, imputes to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 1 Fair Value Measurement: The fair value of Registered Investment companies (mutual funds) is valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. The money market fund and mutual funds are valued at quoted market prices which are available on active markets and, therefore, are classified as Level 1 within the valuation hierarchy. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 6: TAX STATUS

The Internal Revenue Service has determined and informed the Employer by a letter dated March 31, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The plan has been amended since receiving the determination letter. However, the plan administrator believes the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not based on the technical merits, to be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.

NOTE 7: RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

Some of the Plan's assets are invested in securities of foreign companies, which involve special risks and considerations not typically associated with investing in U.S. companies. These risks include devaluation of currencies, less reliable information about issuers, different securities transaction clearance and settlement practices, and possible adverse political and economic developments. Moreover, securities of many foreign companies are their markets may be less liquid and their prices more volatile than securities of comparable U.S. companies.

NOTE 8: SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 15, 2025, the date which the financial statements were available to be issued. Except as disclosed, there were no other subsequent events note that would require adjustments to or disclosure in these financial statements. The effects of the global pandemic COVID-19 in the market have generally been mitigated in U.S. markets, however, the impact of the COVID-19 on foreign markets continues to evolve. The Company is not able currently to estimate its impact on the Plan's assets in foreign companies.

NOTE 9: PARTY-IN-INTERST TRANSACTIONS

A party-in-interest is defined as a fiduciary or employee of the Plan, any person who provides service to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee organization, or a relative of such persons mentioned. However, there were no transactions with these entities other than the funding of contributions to the Plan.
