Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Onpoint Industrial Services, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Onpoint Industrial Services, LLC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Onpoint Industrial Services, LLC 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Onpoint Industrial Services, LLC 401(k) Plan Notes to Financial Statements

Note 1 – Description of Plan

General – The following is a description of the Onpoint Industrial Services, LLC 401(k) Plan (the Plan) and provides only general information. For a more complete description of the Plan's provisions, participants should refer to the Plan document. The Plan was established on April 1, 2015, as the Creative Resources Group, LLC 401(k) Plan. Effective January 1, 2017, in conjunction with a plan merger, the Plan was restated, and the Plan name was changed to Onpoint Industrial Services, LLC 401(k) Plan.

Effective March 15, 2021, the Plan Sponsor's Parent (Onpoint Industrial Holdings, LLC) and CertifiedSafety, Holdings, Inc., contributed all assets and liabilities of Onpoint Industrial Services, LLC; CertifiedSafety, LLC; and Calculated Controls, LLC, into a new partnership through the formation of Onpoint Parent Holdings, LLC. The CertifiedSafety 401(k) Plan assets were transferred into the Plan on August 18, 2021. The Calculated Controls, LLC 401(k) Plan assets were transferred into the Plan on March 7, 2022.

The Plan is a defined contribution plan covering substantially all full-time employees of Onpoint Industrial Services, LLC (the Company or Employer) and subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Custodian and administration – Voya Retirement Insurance and Annuity Company (Voya, or the Custodian) serves as the Custodian of the Plan. Duties of the Custodian include, among others, receiving contributions, collecting income, reinvesting the trust fund, and making payments from the trust fund as directed. The term "trust fund" refers to all assets, of any nature, held from time to time by the Custodian under the trust, without distinction between contributions and income. Creative Retirement Solutions serves as recordkeeper of the Plan. The duties of the recordkeeper include providing certain administrative services to the Plan, preparation of quarterly participant reports, and compliance testing.

Eligibility – All employees of the Company, except for those covered by a collective bargaining arrangement and non-resident aliens, are immediately eligible to participate in the Plan.

Contributions

Participant contributions – Each year, participants may contribute between 1% and 100% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Employer profit sharing – The Company may elect to make discretionary profit sharing contributions to the Plan for participants. There were no discretionary profit sharing contributions for the year ended December 31, 2024.

Employer matching contributions – The Company may elect a discretionary amount or percentage matching contribution. Beginning August 31, 2020, the Company approved a discretionary match of \$0.25 on the dollar to the first 6% of employee contributions. The matching discretionary contribution is on regular wages earned and overtime wages are excluded. For the year ended December 31, 2024, there was approximately \$202,000 in Employer matching discretionary contributions contributed to the Plan.

Onpoint Industrial Services, LLC 401(k) Plan Notes to Financial Statements

Contributions are subject to regulatory limitations.

Participant accounts – Each participant’s account is credited with the participant’s contributions and Company matching contributions, as well as allocations of the Company’s profit sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Participants are immediately vested in their voluntary contributions (including rollovers) and profit sharing contributions, plus actual earnings or losses thereon. Participants vest at 25% per year after one full year of service and each year thereafter, and are fully vested after four full years of service in the Company’s employer match and related earnings or losses thereon.

Benefit payments – A participant is eligible to receive benefit payments in the amount equal to the value of the participant’s vested account upon termination of service due to retirement, death, disability, resignation, or discharge. A participant may elect to receive either a lump-sum distribution or a single sum distribution of their vested account balance payable in cash or rolled over into a qualified retirement plan. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

In-service withdrawals of vested balances may be elected by participants who have reached 59½ years of age. The Plan also permits withdrawals of active participants’ contributions only in amounts necessary to satisfy financial hardship as defined by the Plan document.

Forfeitures – If a participant terminates employment before having a fully vested interest in the Company’s matching accounts, the non-vested balance of the account will be forfeited. Forfeitures may be used to reduce future Employer matching contributions. At December 31, 2024 and 2023, the Plan had \$19,608 and \$7,653 in forfeited non-vested accounts, respectively. For the years ended December 31, 2024 and 2023, Company discretionary matching contributions were reduced by forfeitures of \$22,188 and \$14,388, respectively.

Notes receivable from participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000 reduced by the balance of any outstanding loans. Such loans are secured by the participant’s vested account balance. All loans must be repaid within a period of five years, unless the loan is used to purchase a principal residence, in which case, the loan must be repaid within a reasonable period of time not to exceed thirty years. The notes receivable bear interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator. As of December 31, 2024, interest rates on outstanding notes receivable from participants ranged from 4.25% to 9.50% with various maturities through March 2051. Principal and interest are paid ratably through payroll deductions for current employees and remitted directly to the Custodian. A participant may have a maximum of two loans outstanding at any time.

Onpoint Industrial Services, LLC 401(k) Plan Notes to Financial Statements

Note 2 – Summary of Significant Accounting Policies

Basis of accounting – The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) using the accrual method of accounting.

Use of estimates – The preparation of financial statements in conformity with generally accepted accounting principles requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment valuation – The investments are reported at fair value and contract value. The Plan's Custodian, Voya, certifies the contract value of the guaranteed investment contract and the fair value of all other investments. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the exit price) in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Contract value is the relevant measurement for assets invested in fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Income recognition – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation in fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

Contributions

Contributions from participants and corresponding matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

Administrative fees – Expenses incurred in the administration of the Plan, to the extent not paid by the Employer, are charged to and paid from the Plan's assets. Expenses that are paid directly by the Employer are excluded from these financial statements. Expenses related to the administration of notes receivable from participants, and other participant-directed expenses, are charged directly to participant's accounts and are included in administrative expenses of the Plan on the statement of changes in net assets available for benefits. Investment related expenses are included in net appreciation or depreciation of the fair value of investments.

Notes receivable from participants – Notes receivable from participants are measured at their amortized cost, which represents unpaid principal balance plus any accrued but unpaid interest. Delinquent notes are treated as distributions based on the terms of the Plan document. Note balances for terminated employees are payable upon termination of employment. For the year ended December 31, 2024, the Plan had approximately \$70,000 in deemed distributions for delinquent notes. No allowance for credit losses has been recorded as of December 31, 2024.

Onpoint Industrial Services, LLC 401(k) Plan Notes to Financial Statements

Payment of benefits – Benefits are recorded when paid.

Excess contributions payable – Excess contributions payable represent amounts refunded to participants after year-end to comply with regulatory contribution limitations.

Note 3 – Certified Investment Information

The following information related to investments was obtained by management and agreed to or derived from information certified as complete and accurate by Voya, a qualified institution:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments and interest income on notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments reflected on the schedule of assets (held at end of year) as of December 31, 2024.

Note 4 – Fair Value Measurements

Pooled separate accounts – Units held in pooled separate accounts (PSAs) are valued using the net asset value practical expedient (NAV practical expedient) of the PSA as reported by the account managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the PSA, minus its liabilities, and then divided by the number of units outstanding.

Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 – Guaranteed Investment Contract with Voya

The Plan entered into a fully benefit-responsive investment contract (FBRIC) with Voya. Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 10%. The crediting rate is reviewed on a quarterly basis for resetting. The FBRIC does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The contract meets the FBRIC criteria and is therefore reported at contract value. Contract value is the relevant measure for FBRICs because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations, which may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the Plan's ability to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan and discontinue its contributions at any time, subject to the provisions of ERISA. If the Plan is terminated, amounts allocated to a participant's account become fully vested.

Note 7 – Income Tax Status

The Plan document is a volume submitter defined contribution plan that received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the Plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

In accordance with guidance on accounting for uncertainty in income taxes, the Plan Administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. It is reasonably possible, given the level of risk associated with investment securities, that changes in the values of the investments in the near term could materially affect a participant's account balance and the amounts reported in the statement of net assets available for benefits.

Note 9 – Party-in-Interest Transactions

The Plan paid expenses related to the Plan's operations and investment management to various service providers. During the year ended December 31, 2024, the Plan invested in various registered investment companies managed by the Custodian. These transactions qualify as party-in-interest transactions as defined by ERISA. Consequently, such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA.

Note 10 – Delinquent Participant Contributions

As disclosed in the accompanying supplemental schedule, certain employee deferrals were not remitted to the Plan within the timeframe required by the Department of Labor. The Company has determined the amount of related lost earnings and has remitted these amounts to participants' accounts.

Note 11 – Reconciliation to Form 5500

The Form 5500 has certain items that differ from amounts shown on the accompanying financial statements. These differences relate to classification only and have no effect upon net assets available for benefits for either period.

Note 12 – Subsequent Events

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits but arose after the statement of net assets available for benefits date and before the financial statements are available to be issued.

The Plan has evaluated subsequent events through October 14, 2025, the date which these financial statements were available to be issued.
