## Independent Auditors' Report

### **The Plan Committee of St. John's Riverside Hospital 403(b) Retirement Plan**

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of the St. John's Riverside Hospital 403(b) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institutions).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### ***Opinion***

### **1. Description of Plan**

The following description of the St. John's Riverside Hospital 403(b) Retirement Plan (formerly St. John's Riverside Hospital Voluntary Supplementary Tax Deferred Annuity Plan) (the "Plan") is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan covering substantially all employees of St. John's Riverside Hospital (the "Sponsor" or "Employer"), except as noted below. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Effective January 1, 2023, the Plan was amended in that the Employer will no longer have an obligation to fund or match any contributions related to the employees who are members of the St. John's Riverside Hospital New York State Nurses Association Collective Bargaining Unit.

#### ***Eligibility***

For purposes of salary deferral contributions, an employee is eligible for participation in the Plan upon their first day of employment. For purposes of salary deferral contributions, an excluded employee is any employee who normally works less than 20 hours per week or is a student performing services described in Internal Revenue Code ("IRC") section 3121(b)(10).

For purposes of Employer contributions, an employee is eligible upon obtaining 21 years of age or more and completing one year of service. There are two formulas for calculating the Employer match, which is referred to in the subsequent notes as "formula 1" and "formula 2".

For purposes of Employer matching contributions formula 1, an excluded employee is any employee who is a member of the 1199 SEIU Union and Local 30 of the International Union of Operating Engineers, employees of St. John's Riverside Hospital and Andrus Pavilion hired after July 1, 2007, employees of St. John's Riverside Hospital, Park Care Pavilion and Community Hospital at Dobbs Ferry, physicians whose contracts preclude the receipt of matching contributions, and medical residents.

For purposes of Employer matching contributions formula 2, an excluded employee is any employee who is a member of the 1199 SEIU Union and Local 30 of the International Union of Operating Engineers, employees of St. John's Riverside Hospital and Andrus Pavilion hired before July 1, 2007, employees of the Community Hospital at Dobbs Ferry Pavilion with 13 years or more of service as of December 31, 2009, physicians whose contract preclude the receipt of matching contributions, and medical residents.

***Eligibility (continued)***

For purposes of Employer non-elective contributions, an excluded employee is any employee who is a member of the 1199 SEIU Union and Local 30 of the International Union of Operating Engineers, and employees of St. John's Riverside Hospital and Andrus Pavilion hired before July 1, 2007, and medical residents.

***Contributions***

Each year participants may elect to make deductions on a pre-tax or Roth basis from their eligible compensation as defined by the Plan document. Participants who have attained age 50 before the end of the plan year, are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. A participant may elect to increase, decrease or suspend their contributions according to procedures established by the Company. There is an annual limit as to the amount that can be contributed that is determined by the IRC.

For purposes of Employer matching contributions formula 1, an eligible participant will receive a matching contribution in the amount of 100% of the first 2% of their eligible compensation that is contributed by the participant to the Plan.

For purposes of Employer matching contributions formula 2, an eligible participant will receive a matching contribution in the amount of 100% of the first 3% of their eligible compensation that is contributed by the participant to the Plan.

For purposes of Employer non-elective contributions, an eligible participant will receive a non-elective contribution in the amount of 3% of their eligible compensation. A participant must be employed as of the last day of the Plan year quarter to be eligible to receive a non-elective contribution.

Former employees of Community Hospital at Dobbs Ferry with at least 13 years of service as of December 31, 2009, are eligible to receive a matching contribution in the amount of 100% of the first 4% of their eligible compensation that is contributed by a participant to the Plan.

***Vesting***

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in Employer matching and non-elective contributions are as follows:

***Participant Accounts***

Each participant's account is credited with the participant's contributions and allocations of (a) the Employer's contributions and (b) Plan earnings (losses) thereon. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Forfeitures***

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$226,265 and \$58,146. These accounts will be used for Employer contributions or administrative expenses. During 2024, no forfeitures were used to reduce Employer contributions and \$424 were used to reduce administrative expenses.

***Plan Expense Account***

The Plan and Empower Annuity Insurance Company have entered into a revenue sharing arrangement whereby a portion of the revenue earned by certain funds is passed through to the Plan for payment of permitted Plan expenses. In order for the Plan to receive credits as a result of this revenue sharing arrangement, and to use this credit to pay Plan expenses, the Company created the Plan Expense Account. The Plan Expense Account is an account within the Plan and is used to record keep the redistribution of Plan-generated fund revenue that exceeds the costs associated with Plan administration. The Plan Expense Account balance was \$82,491 and \$112,616 at December 31, 2024 and 2023. During 2024, administrative expenses incurred by the Plan were reduced by \$121,006 from the Plan Expense Account and \$80,000 was allocated back to participants.

***Payment of Benefits***

Upon termination of service due to death, disability, retirement or other reason, a participant is entitled to receive a distribution in the amount equal to the value of the participant's vested interest in his or her account. Prior to termination or retirement age, a participant is entitled to receive a distribution for a hardship claim or attainment of age 59 ½ as defined in the Plan document.

***Notes Receivable from Participants***

The Plan offers a loan feature whereby a participant (borrower) enrolled in the Plan may borrow a minimum amount of \$1,000 up to a maximum of 50% of their balance or \$50,000 (whichever is less). Participant accounts are reduced by the loan amount for participants who have accounts with State Street Bank and Trust Company ("State Street") or Empower Annuity Insurance Company. The loans are secured by the balance in the participant's account and bear interest at rates at the prime interest rate plus 1 percentage point. Principal and interest are paid ratably through payroll deductions.

***Loans to Participants/Collateralized Assets***

Loans to the participant who have accounts with Metropolitan Life Insurance Company (“MLIC”) or Lincoln Life and Annuity Company of New York (“Lincoln”) are made directly from MLIC and Lincoln and the participant’s account is not reduced by the loan amount, but serves as security for the loan. The loan amount is moved into a fixed income collateral account within the borrower’s account. The loan must be repaid directly to MLIC or Lincoln within a five-year period in substantially equal payments (not less frequently than quarterly). The five-year repayment period will not apply to a loan that is used to acquire a principal residence of the borrower. If the borrower does not repay the loan and related interest due in accordance with the schedule set forth in the promissory note or other writing permitted by applicable law representing the loan, their loan will be deemed in default. At December 31, 2024, the interest rates on these loans ranged from 4.00% to 6.75% with maturities through 2027. At December 31, 2023, the interest rates on these loans ranged from 4.00% to 8.00% with maturities through 2027. At December 31, 2024 and 2023, 5 and 4 participants had defaulted loan balances that totaled \$59,387 and \$59,257.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accounts of the Plan are maintained, and the accompanying financial statements have been prepared, on the modified cash basis, which is a basis of accounting other than accounting principles generally accepted in the United States of America (“U.S. GAAP”). Under this basis, investment income is recognized when received and disbursements are recognized when made, except for investments which are reflected at fair value. Accordingly, the financial statements are not intended to present the net assets available for benefits and changes in net assets available for benefits of the Plan in conformity with U.S. GAAP.

***Use of Estimates***

The preparation of financial statements requires management to make certain estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

***Investment Valuation and Income Recognition***

All investments of the Plan are stated at fair value, except for certain guaranteed investment contracts and certain pooled separate accounts, which are stated at contract value.

Mutual funds are valued at fair value based on the daily closing price as reported by the fund. Mutual funds held by the Plan are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. These funds are deemed to be actively traded.

The Empower Guaranteed Income Fund, the Lincoln Fixed Account, the TFLIC Fixed Fund and the TFLIC Stable Fund (collectively the "TFLIC Insurance Company/General Account") are guaranteed investment contracts that are valued at contract value, which represents deposits made to the contracts, plus earnings at guaranteed crediting rates, less withdrawals and fees. The Mutual of America Interest Accumulation Account and the MLIC Fixed Interest Account are guaranteed investment contracts that are valued at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit worthiness of the issuer.

Investments in separate accounts are reported at fair value based on the value reported to the Plan by the insurance company, which represents the fair value of the underlying investments comprising the accounts. The TFLIC Government Fixed Fund is a pooled separate account and is valued at contract value, which represents the fair value of the underlying portfolio, accrued interest on the underlying portfolio assets, the fair value of the contract, and the adjustments to contract value.

Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Purchases and sales of securities are recorded on a trade-date basis. Interest and dividends are recorded when received.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. Until a distributable event occurs, the loan will continue to have a balance and accrue interest.

***Payment of Benefits***

Benefit payments are recorded when paid.

***Expenses***

Certain expenses of maintaining the Plan are paid by the Employer and are excluded from these financial statements. Investment related expenses are included in net appreciation in value of expenses.

***Reclassifications***

Certain 2023 amounts have been reclassified to conform to the 2024 presentation.

***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 14, 2025.

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements (modified cash basis) and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) (modified cash basis) including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in value of investments, interest and dividends, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Annuity Insurance Company (“EAIC”), Empower Trust Company, LLC, State Street Bank and Trust Company (“State Street”), Transamerica Financial Life Insurance Company (“TFLIC”), Mutual of America Life Insurance Company (“Mutual of America”), Metropolitan Life Insurance Company (“MLIC”), and Lincoln Life and Annuity Company of New York, qualified institutions.

**5. Guaranteed Investment Contracts**

***Guaranteed Income Fund, at Contract Value***

The Guaranteed Income Fund (the "Fund") is a group annuity product issued by EAIC and is fully benefit responsive. EAIC maintains the contributions in a general account, which is credited with earnings and charged with participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Generally, there are no events that could limit the ability of the Plan to transact at contract value. Empower is contractually obligated to pay the principal and specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with EAIC. Such interest rates are announced in advance and guaranteed for a six month period.

The Fund represents approximately 13% and 15% of the Plan's net assets available for benefits at December 31, 2024 and 2023. The credit risk of Empower was evaluated by nationally recognized statistical rating agencies as follows: A.M. Best (A+ as of June 2025), Moody's Investors Service (Aa3 as of June 2025), Standard and Poor's (AA as of June 2025) and Fitch Ratings (AA- as of June 2025).

***TFLIC Fixed Fund, at Contract Value***

The TFLIC Fixed Fund ("Fixed Fund") is a fully benefit responsive investment contract, which provides participants with book value distributions at retirement and other events as described in the group annuity contract. Both principal and interest are guaranteed by TFLIC. The Fixed Fund is supported by TFLIC's general account. The general account of TFLIC invests in investment grade fixed income securities, including U.S. Government, Agency, and corporate issues; as well as individually underwritten mortgage loans, and private placements. Interest is declared quarterly for new deposits received during that quarter and are guaranteed for the balance of that calendar year. Renewal rates are declared annually on a calendar year basis for existing assets.

No monies may be transferred by participants to fixed income funds (competing funds). Funds transferred to non-fixed income funds may not be transferred to fixed income funds or back to the Fixed Fund for 90 days. Monies transferred back to the Fixed Fund or withdrawn within the 90 day period are subject to a 5% charge. Monies withdrawn or transferred by the Employer and monies withdrawn by participants not due to benefit withdrawals, hardships and loans may be subject to a withdrawal charge.

Because the Fixed Fund is benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the Fixed Fund. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

***TFLIC Stable Fund, at Contract Value***

The TFLIC Stable Fund ("Stable Fund") is a fully benefit responsive investment contract, which provides participants with book value distributions at retirement and other events as described in the group annuity contract. Both principal and interest are guaranteed by TFLIC. The Stable Fund is supported by TFLIC's general account. The general account of TFLIC invests in investment grade fixed income securities, including U.S. Government, Agency, and corporate issues; as well as individually underwritten mortgage loans, and private placements. Interest is declared quarterly for new deposits received during that quarter and are guaranteed for the balance of that calendar year. Renewal rates are declared annually on a calendar year basis for existing assets. The underlying guaranteed rate in effect through segment maturity date.

No monies may be transferred by participants to fixed income funds (competing funds). Monies transferred to non-fixed income funds may not be transferred to fixed income funds or back to the Stable Fund for three months. Monies withdrawn or transferred from the Stable Fund by the Employer at any time and/or by participants during the 6 month period preceding contract suspension may be subject to restriction and/or adjustment in accordance with contract provisions.

Because the Stable Fund is benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the Stable Fund. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Fixed Fund and Stable Fund (collectively the "TFLIC Insurance Company/General Account") represents approximately 6% and 8% of the Plan's net assets available for benefits at December 31, 2024 and 2023. The credit risk of TFLIC was evaluated by nationally recognized statistical rating agencies as follows: A.M. Best Company (A as of January 2025), Moody's Investors Service (A1 as of December 2024) and Standard and Poor's (A+ as of March 2025).

***Lincoln Fixed Account, at Contract Value***

The Lincoln Fixed Account provides a guarantee of principal and interest. Assets in the Fixed Account are part of the general assets of the issuing company and are subject to the claims-paying ability of that company.

Contributions allocated to the Lincoln Fixed Account are guaranteed to be credited with a minimum interest rate, as specified in the contract. Lincoln has an internal committee that reviews and sets interest rates quarterly based on a variety of proprietary factors. Lincoln's standard crediting methodology is to apply a portfolio interest rate to the Lincoln Fixed Account. That is, a single interest rate applies to the entire balance of the participant's Lincoln Fixed Account. The declared portfolio interest rate is published quarterly in advance of the quarter for which the rate will be effective. The rate of interest actually credited to the Fixed Account will be the greater of the declared rate of interest or the guaranteed minimum interest rate specified in the contract. The standard guaranteed minimum interest rate is 3.00%. A participant may transfer or withdraw all or a portion of his or her Fixed Account balance without limitation.

The credit risk of Lincoln Life was evaluated by nationally recognized statistical rating agencies as follows: Standard & Poor's (A+ as of July 2024), Moody's Investors Service (A2 as of August 2025), A.M. Best Company (A as of February 2025), and Fitch Ratings (A+ as of July 2025).

The Lincoln Fixed Account is benefit-responsive and is reported at contract value on the statements of net assets available for benefits.

***Mutual of America Interest Accumulation Account, at Fair Value***

Amounts placed in the Mutual of America Interest Accumulation Account ("Interest Accumulation Account") are credited with interest at a rate determined by Mutual of America. Mutual of America guarantees to credit interest for the life of the contract to amounts in the Interest Accumulation Account of their general account at a rate of at least equal to the greater of: (1) any contractual minimum guarantee provided by the contract; or (2) the minimum rate required by applicable state law or, if no state law minimum rate is applicable to a contract, the minimum guaranteed credited interest rate will be set pursuant to National Association of Insurance Commissioners ("NAIC") standard non-forfeiture law. The NAIC minimum rate is determined in accordance with a formula, and cannot be less than 0.15% or more than 3.00%. Mutual of America determines whether the application of the formula will change the minimum guaranteed rate each November, and any change is effective the following January 1 for that calendar year. The interest rate under that contract will not go below that amount regardless of the minimum rate that is set for a calendar year. In Mutual of America's sole discretion, they may credit a higher rate of interest to a participant's contract in the general account, although they are not obligated to credit interest in excess of the minimum guaranteed rate. Mutual of America compounds interest daily on the contract amounts in the general account to produce an effective annual yield that is equal to the stated interest rate.

The principal and previously credited interest is guaranteed by Mutual of America. This guarantee is subject to Mutual of America's financial strength and claims-paying ability. The credit risk of the issuer was evaluated by nationally recognized statistical rating agencies as follows: A.M. Best (A- as of April 2025), Standard and Poor's (A as of June 2025), and Fitch (BBB+ as of April 2025).

The Interest Accumulation Account is non benefit-responsive and is reported at fair value on the statements of net assets available for benefits.

**5. Guaranteed Investment Contracts (*continued*)**

***MLIC Fixed Interest Account, at Fair Value***

The MLIC Fixed Interest Account (the "Fixed Interest Account") is guaranteed by MLIC and is backed by the full faith and credit of MLIC's general account. The general account invests primarily in bonds, commercial, agriculture and real estate mortgages, real estate and corporate equities. MLIC will declare and guarantee an interest rate for each new contribution. MLIC will declare an interest rate for each new contribution and its accumulated earnings. The interest rates credited are based on a number of factors, including, but not limited to, the level of net investment income that MLIC can earn on its newly purchased general account assets, the absolute level of interest rates, the shape of the yield curve, how interest rates have moved since the inception of the contract, and the interest rates on alternative investments. The credit risk of MLIC was evaluated by nationally recognized statistical rating agencies as follows: Standard & Poor's (AA- as of August 2025), Moody's Investors Service (Aa3 as of August 2025), A.M. Best Company (A+ as of August 2025) and Fitch Ratings (AA- as of August 2025).

The Fixed Interest Account is non benefit-responsive and is reported at fair value on the statements of net assets available for benefits.

**6. TFLIC Government Fixed Fund, at Contract Value**

The TFLIC Government Fixed Fund ("Government Fixed Fund") is an actively managed guaranteed pooled separate account of TFLIC. Both principal and interest are guaranteed by TFLIC. Interest is declared quarterly for new deposits received during that quarter and are guaranteed for the balance of that calendar year. Renewal rates are declared annually on a calendar year basis for existing assets.

No monies may be transferred from the Government Fixed Fund by participants to fixed income funds (competing funds). Monies transferred to non-fixed income funds may not be transferred to fixed income funds or back to the Government Fixed Fund for 90 days. Monies transferred back to the Government Fixed Fund or withdrawn within the 90-day period are subject to a 5% charge. Monies withdrawn or transferred by the Employer and monies withdrawn by participants not due to benefit withdrawals, hardships and loans may be subject to a withdrawal charge. Participants are generally permitted to make benefit distributions at contract value.

Because the Government Fixed Fund is benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the Government Fixed Fund. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

**7. Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants would become 100% vested in their Employer contributions.

**8. Tax Status**

The Employer has adopted a volume submitter plan document which is intended to satisfy the Internal Revenue Service's ("IRS") final 403(b) regulations. The volume submitter plan document preparer received an opinion letter dated September 21, 2022. The Plan has since been amended, since receiving the opinion letter, however, the Employer believes that the Plan, as amended, is designed and currently being operated in accordance with applicable sections of the IRC.

U.S. GAAP require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

**9. Parties-in-Interest Transactions**

Certain investments are managed by EAIC, State Street, TFLIC, Mutual of America, MLIC and Lincoln. These parties are the trustees and custodians of the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Transamerica Retirement Solutions Corporation and Empower Retirement Services are the record-keepers for the Plan. These parties are the record-keepers of the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

Participants may obtain loans that are issued directly from Lincoln Life and MetLife to the participant. As security, a portion of the participant's account in the Plan serves as collateral for the loan in case of default. Therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

**10. Prohibited Transaction**

During the 2023 and 2024 plan years, the Employer failed to remit to the Plan certain participants' contributions and loan repayments amounting to \$259,039 within the period described by the Department of Labor regulations. Delays in remitting the contributions to the Plan were due to administrative oversight. The Employer is in the process of making the necessary corrections to satisfy both the Department of Labor and IRS guidance for \$117,848 of the delinquent contributions. In March 2025, the Employer made the necessary corrections to satisfy both the Department of Labor and IRS guidance for \$141,191 of the delinquent contributions.

**11. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**12. Financial Position of Plan Sponsor**

The plan administrator has informed us that the Employer has assumed at this point, that as of December 31, 2024 and for the year then ended, as a result of their financial condition and performance, there is substantial doubt about the Employer's ability to continue as a going concern.
