We have performed audits of the financial statements of the Mortgage Connect LP 401(k) Profit Sharing Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) Audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Mortgage Connect LP 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General - The Plan is a qualified, defined contribution plan covering employees of the following entities:

- Mortgage Connect LP (MCLP)
- Mortgage Connect Escrow, Inc. (MCE), a wholly owned subsidiary of MCLP
- Mortgage Connect of Texas, LLC (MCT), a wholly owned subsidiary of MCLP
- Mortgage Connect of Alabama (MCA), a wholly owned subsidiary of MCLP
- Valuation Connect, LLC (VCT), a related party of MCLP
- Mortgage Connect Document Solutions, LLC (MCDS), a wholly owned subsidiary of MCLP
- Connect Post & Publications LLC (CPP), a wholly owned subsidiary of MCLP
- Inspire Closing Services, LLC (Inspire), a wholly owned subsidiary of MCLP
- Inspire Closing Services of Texas, LLC (Inspire TX), a wholly owned subsidiary of Inspire
- Title Connect, Inc. (TC), a wholly owned subsidiary of MCLP
- Mortgage Connect of Louisiana, a wholly owned subsidiary of MCLP
- Default, a wholly owned subsidiary of MCLP
- MC GP, Inc., general partner of MCLP
- Townsgate Appraisal Management Company, LLC (AMC), a related party of MCLP
- Townsgate Closing – MCDS, a related party of MCLP
- Townsgate Escrow, a related party of MCLP
- Townsgate Closing of Texas, a related party of MCLP
- Townsgate Closing of Alabama, a related party of MCLP
- Townsgate Closing of Arkansas, a related party of MCLP
- Townsgate Closing of Louisiana, a related party of MCLP
- Townsgate Closing of Utah, a related party of MCLP
- Townsgate Appraisal Company of Utah, a related party of MCLP

MCLP and each of the above entities are collectively referred to as “the Company.”

Eligible employees may make salary deferrals upon the date of hire and there is no age requirement. Eligible employees must satisfy one year of employment to be eligible for both the employer match and the discretionary profit-sharing contribution. Additionally, an employee must be at least 21 years old, meet the eligibility requirements above and be employed on the last day of the Plan year to receive the discretionary profit-sharing contribution. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan includes an automatic enrollment feature of 3% for all newly eligible participants. These salary deferrals are invested in the American Funds Moderate Growth and Income Portfolio R6 unless another election is made by the participant.

NOTE 1 - DESCRIPTION OF PLAN (Continued)

Contributions - Employees may enter the Plan at any time during a Plan year and may contribute to the Plan under a salary deferral arrangement. An eligible participant may elect to contribute a specific percentage of their compensation to the Plan. Contributions are subject to certain limitations as defined by the Internal Revenue Code (IRC). In addition, in any calendar year in which a participant is age 50 or above, an additional catch-up contribution may be made. Participants may also contribute amounts representing distributions from other qualified plans (rollovers).

The Company may make flexible discretionary matching contributions for eligible participants based on its own formula. Additionally, the Company may provide discretionary profit-sharing contributions. No such contributions were made to the Plan in 2024.

Participant Accounts - Each participant's account is credited with the participant's contributions and Company contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of participants' accounts is based on years of continuous service. A participant is vested 25% each year after one year of credited service. A participant will be 100% vested after four years of credited service. Participants automatically become fully vested with respect to employer contributions upon death, permanent disability or upon reaching early retirement age.

Notes Receivable From Participants - Participants may borrow up to the lesser of 50% of their individual vested account balance or \$50,000, reduced by the participant's highest outstanding loan balance during the prior 12 months. The minimum amount a participant may borrow is \$1,000. A participant may have one outstanding loan at any time. Loan repayment terms may not exceed 60 months unless the loan is granted for the purpose of acquiring the participant's principal residence. In such instances, repayment can be over a reasonable period that may not exceed 30 years. Loans are collateralized by the vested interest in the participant's account and bear interest at a rate commensurate with local market rates for similar loans. Principal and interest are paid ratably through biweekly payroll deductions.

Payments of Benefits - Upon termination of service due to death, disability or retirement, a participant may elect to receive the value of the vested interest in his or her account in the form of a lump-sum distribution. The Plan allows for in-service withdrawals at age 59½ and hardship distributions, subject to Plan provisions. If a participant terminates employment and the participant's vested account balance does not exceed \$7,000, the Plan Administrator will authorize the benefit payment without the participant's consent.

Forfeited Accounts - At December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$90,000 and \$213,000, respectively. Forfeitures may be used to reduce amounts required to be contributed by the Plan. The Plan utilized approximately \$119,000 of forfeitures to reduce employer contributions during the year ended December 31, 2024.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of significant accounting policies consistently applied by management in the preparation of the accompanying financial statements follows:

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note 3 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are also included in administrative expenses.

Excess Contributions Payable - Amounts payable to participants as of December 31, 2024 and 2023 represent contributions in excess of amounts allowed by the Internal Revenue Service (IRS) for the Plan years ended December 31, 2024 and 2023, adjusted by investment earnings or losses related to these excess contributions. The amounts have been recorded as a liability with a corresponding deduction from participant contributions.

Subsequent Events - Subsequent events were evaluated through October 15, 2025, which is the date the financial statements were available to be issued.

NOTE 3 - FAIR VALUE MEASUREMENT

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trust - Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value and is based on the fair value of the underlying investments held by the fund, less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. At December 31, 2024 and 2023, there were no unfunded commitments and participant investments are redeemable on a daily basis without restriction. There is no redemption notice period for this fund.

The preceding methods described might produce a fair value calculation that might not be indicative of net realizable value or reflective of future fair values. Further, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 - CERTIFIED INVESTMENTS (UNAUDITED)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (Reliance), the trustee of the Plan.

NOTE 5 - RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by Reliance; therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in administrative expenses. The Company pays directly most other fees, except for those associated with the administration related to the Plan's operations.

NOTE 6 - PLAN TERMINATION

Although it has not expressed an intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 7 - TAX STATUS

The Plan is a non-standardized prototype plan of Dunbar, Bender & Zapf, Inc., which obtained a letter dated October 6, 2020 wherein the IRS stated its opinion that the form of the prototype plan is acceptable under Section 401 of the IRC for use by employers for the benefit of their employees. The Plan has since been amended. The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC; therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a taxing authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes that the Plan is no longer subject to income tax examinations for the years prior to 2021.
