Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1 – Description of Plan

The following description of the Meade Holdings 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, sponsored by Meade Holdings, LLC (the “Sponsor”), covering full-time and part-time employees of Caudill Hill Ventures, LLC (the “Company”) who are eighteen years of age and two months of service, with the exception of nonresident aliens, residents of Puerto Rico, leased employees, union employees, and part-time/temporary/seasonal employees whose regular schedule service is less than 1,000 hours in the relevant eligibility period. If any such excluded part-time/temporary/seasonal employee actually completes a year of service, then the employee will no longer be part of the excluded class. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan allows eligible participants to enter the first day of each month into the Plan.

Contributions

Each year, participants may contribute up to 100% of pretax or after-tax annual compensation, not to exceed annual limits established by the *Internal Revenue Code (IRC)*, as defined in the Plan. Participants who have attained age fifty before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Plan is an Eligible Automatic Contribution Arrangement (EACA) with an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to be a participant in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan allows for discretionary match and discretionary profit-sharing contributions based on eligible compensation as determined annually by the Sponsor. For the year ended December 31, 2024, the Sponsor matched 50% of participant deferrals, up to a maximum of 6% of eligible compensation with an additional discretionary profit-sharing match of 63.77% of participant deferrals, up to a maximum of 3% of eligible compensation. To qualify for additional discretionary profit-sharing contributions, participants must have 1,000 hours of service and be employed on the last day of the plan year. Contributions are subject to certain limitations as prescribed annually by the Internal Revenue Service (IRS).

Participant Accounts

Each participant's account is credited with the participant's contribution, the Sponsor's discretionary matching contribution (if any), the Sponsor's discretionary profit-sharing contribution (if any), an allocation of Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Sponsor's discretionary matching contributions and discretionary profit-sharing contributions portions of their accounts plus actual earnings thereon is based on years of continuous service. Prior to February 1, 2019 participants were immediately vested

in the Sponsor's discretionary matching contributions and discretionary profit-sharing contributions portions of their accounts.

Effective as of February 1, 2019, participants are 100% vested after six years of credited service, with no vesting for years of service less than two years and 20% per year for any years of service from two to six years.

Hardship Withdrawals

Hardship withdrawals are permitted pursuant to IRS regulations.

Payment of Benefits

On termination of service due to disability or retirement, a participant or in case of death a participant's beneficiary may elect to receive a lump-sum amount, direct rollover to another qualified plan, or a partial distribution (but only with respect to required minimum distributions and in-service distributions) equal to the value of the participant's vested interest in his or her account. For vested balances of \$7,000 or less, participant consent is not required for the distribution.

Forfeitures

Forfeitures of nonvested accounts may be used to pay plan expenses or reduce future employer contributions. Forfeited nonvested accounts totaled \$10,076 and \$60,980 as of December 31, 2024 and 2023, respectively. Forfeitures of \$59,219 were used during the year ended December 31, 2024 to restore participant balances where forfeitures were withheld erroneously for participants terminated as a result of the partial plan termination in 2023.

Administration

The Sponsor administers the Plan with an officer and an employee of the Sponsor acting as Trustees for the Plan. The Plan's assets are in the custody of Reliance Trust Company and Standard Insurance Company.

Administration Expenses

Although not required to do so, the Sponsor paid certain administrative expenses of the Plan except for loan origination fees, single sum benefit payment fees for a distribution, qualified domestic relations order fees, and quarterly participant based and asset-based fees.

Note 2 – Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Cash and Cash Equivalents

The Plan's cash consists of short term funds held in accounts with the trustee which have not yet been processed for distributions to participants.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

Management has evaluated subsequent events through October 9, 2025, the date at which the financial statements were available to be issued.

Note 4 – Fair Value Measurements

FASB ASC 820, Fair Value Measurements, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were used only when Level 1 or Level 2 inputs were not available.

The fair values of mutual funds are based on quoted net asset values of the shares held by the Plan at year-end.

Note 5 – Fully Benefit-Responsive Investment Contract with Insurance Company

The Plan invests in a traditional investment contract through Standard Insurance Company. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contract because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. The following represents the total contract value of these investment contracts held by the Plan.

The traditional investment contract held by the Plan is a Deposit Administration Contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but generally will not be less than 1%. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

- The Plan's failure to qualify under Section 401(a) of the *IRC* or the failure of the trust to be tax-exempt under Section 501(a) of the *IRC*
- Premature termination of the contract
- Plan termination or merger
- Changes to the Plan's prohibition on competing investment options
- Plan Sponsor events that significantly affect the Plan's normal operations

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

- An uncured violation of the Plan's investment guidelines
- A breach of material obligation under the contract
- A material misrepresentation
- A material amendment to the agreements without the consent of the issuer

Note 6 – Related Party Transactions

Plan participants may direct their investments in funds issued and managed by the Plan's custodians, Reliance Trust Company and Standard Insurance Company. These transactions qualify as party-in-interest transactions. Fees paid to service providers by the Plan for administrative services amounted to \$90,682 for the year ended December 31, 2024.

Certain administrative functions are performed by officers or employees of the Companies. These employees are also Plan participants. No such officer or employee receives compensation from the Plan.

Note 7 – Tax Status

The Plan adopted a non-standardized pre-approved Plan Sponsored by Standard Retirement Service, Inc., and has not requested a determination letter but rather has relied upon the IRS opinion letter dated June 30, 2020, in which the IRS

stated that the Plan is designed in accordance with applicable sections of the *IRC*. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the *IRC* and, therefore, believe that the Plan is qualified.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

Note 8 – Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

During 2023, the Plan Sponsor sold a portion of its operations, leading to a partial Plan termination. As a result, affected employees became immediately and fully vested in any unvested portion of the Company's matching funds at the time of termination.
