## **INDEPENDENT AUDITOR'S REPORT**

To the Investment Oversight Committee and  
Pension Investment Committee of the

### **Opinion**

We have audited the financial statements of Northside Hospital 403(b) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. ## NOTES TO FINANCIAL STATEMENTS

AS OF DECEMBER 31, 2024 AND 2023, AND FOR THE YEAR ENDED DECEMBER 31, 2024

---

### 1. DESCRIPTION OF THE PLAN

The following description of the Northside Hospital 403(b) Retirement Plan (the “Plan”) provides only general information. Refer to Plan document for a more complete description of Plan provisions.

**General**—The Plan is a defined contribution plan covering all salaried employees of Northside Hospital, Inc. (the “Company,” or the “Plan Sponsor”). The Plan is subject to the provisions of the Department of Labor’s (DOL’s) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is administered by the management of the Company with the assistance of the Investment Oversight Committee and the Pension Investment Committee.

Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (“Principal”), Corebridge Financial /AIG (formerly the Variable Annuity Life Insurance Company) (“VALIC”), and Lincoln Financial Group (“Lincoln”) serve as the custodians (or as applicable, insurance company) of the Plan and provide certain recordkeeping services.

Some administrative functions are performed by employees of the Company. No compensation is remitted to the Company for these services.

**Eligibility**—Employees are eligible to participate in the Plan on the day that they become an employee and reach age 18 or older.

**Contributions**—Each year participants may elect to contribute a percentage of their annual compensation, as defined in the Plan, subject to certain Internal Revenue Code (IRC) limitations. The Company contributes 50% of the first 4% of base compensation that a participant contributes to the Plan. Additional amounts may be contributed at the discretion of the Company’s Board of Directors. No such additional discretionary contributions were made for the year ended December 31, 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

**Participant Accounts**—Individual accounts are maintained for each Plan participant. Each participant’s account is credited with the participant’s contributions, the Company’s matching contributions, and allocations of the Company’s discretionary contributions, participant forfeitures, and Plan earnings, and charged with withdrawals and an allocation of Plan losses and administrative expenses. Allocations are based on participant earnings or account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Investments**—Participants direct the investment of their contributions into various investment options offered by the Plan. Company contributions are invested as directed by the participants. The Plan currently offers various mutual funds, a guaranteed investment contract (GIC), and a fixed option under a group annuity contract as investment options for participants.

**Vesting**—Participants are vested immediately in their contributions, plus actual earnings thereon. Vesting in the Company’s contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after three years of credited service.

**Notes Receivable from Participants**—Participants may borrow from their accounts up to a maximum of \$50,000 or 50% of their account balance, whichever is less. The loans are secured by the balance in the participant’s account and bear interest at rates commensurate with local prevailing rates at the time the funds are borrowed, as determined by the Company. Principal and interest are paid ratably through payroll deductions. Loan terms shall not exceed five years unless the loan is used to purchase a principal residence. Participants may not have more than one loan outstanding at any time. As of December 31, 2024 and 2023, participant loans have various maturities at interest rates ranging from 3.25% to 8.50%.

**Benefit Payments**—On termination of service, a participant may generally elect to receive either a lump-sum amount equal to the value of the participant’s vested interest in his or her account or monthly, quarterly, semiannual, or annual installments based on the participant’s individual elections.

**Hardship Withdrawals**—As permitted by the Internal Revenue Code (IRC), a participant may request a financial hardship withdrawal if they experience a severe financial hardship. The financial hardship withdrawal may not exceed the amount of the financial hardship or the value of the vested portion of the participant’s balance, whichever is less.

**Forfeited Accounts**—At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$736,829 and \$31,972, respectively. These accounts will be used to reduce future employer contributions or pay plan administrative expenses. During 2024, employer contributions and administrative expenses were reduced by \$1,819,733 from forfeited nonvested accounts.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting**—The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Use of Estimates**—The preparation of financial statements in conformity with GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**—The Plan’s investments are stated at fair value, except for the fully benefit-responsive GIC and group annuity contracts, which are reported at contract value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion on fair value measurements. Contract value is the amount Plan participants would receive if they were to initiate permitted transactions under the terms of the Plan, see Note 4.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes both realized and unrealized gains and losses on investments.

**Notes Receivable from Participants**—Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions based on the terms of the Plan document.

**Payment of Benefits**—Distributions to participants are recorded when paid.

**Administrative Expenses**—Administrative expenses of the Plan are paid by the Plan or the Plan Sponsor, as provided in the Plan document. Certain investment management fees are included as a reduction of investment return and not reflected separately in the statement of changes in net assets available for benefits.

**Risks and Uncertainties**—The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Market risk include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the Plan’s financial statements. The Plan’s exposure to a concentration of credit risk is limited by the diversification of investments across a variety of participant-directed fund elections. Additionally, the investments within each participant-directed fund election are further diversified into a variety of financial instruments. Investment decisions are made, and the resulting risks are borne, exclusively by the Plan participants who made such decisions.

### 3. FAIR VALUE MEASUREMENTS

ASC 820, Fair Value Measurements and Disclosures provides a framework for measuring fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value, as follows:

Level 1, which refers to securities valued using unadjusted quoted prices from active markets for identical assets;

Level 2, which refers to securities not traded on an active market but for which observable market inputs are readily available;

Level 3, which refers to securities valued based on significant unobservable inputs.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

**Asset Valuation Techniques**—Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual Funds**—Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds publish their daily net asset value and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**VALIC Fixed Option Separate Accounts and Lincoln Group Separate Account**—Values are readily determinable and are based on the fair value of the investments in the accounts. The investments in the separate accounts are mutual funds created for use in insurance products. Participants can trade the separate accounts daily at the published NAV.

**Guaranteed Investment Contract-Principal Life Insurance Company**—The Plan had a fully benefit responsive GIC with Principal Life Insurance Company (PLIC), an affiliate of the Plan’s custodian. The GIC was sold in September 2024 and participant balances were redirected or mapped to the Lincoln Stable Value Separate Account.

**Unallocated Investment Contracts**—The VALIC group annuity contracts (fixed option) are unallocated investment contracts with a guaranteed rate of return. The insurance company is contractually obligated to repay the principal and a specified interest rate that is guaranteed to participants. VALIC’s group annuity contracts (fixed option) are fully-benefit responsive investment contracts which are general obligations of VALIC and are stated at contract value. Investment income of the VALIC group annuity contracts (fixed option) is presented on a contract value basis.

The Lincoln group annuity contract (fixed option) is an unallocated investment contract with a guaranteed rate of return. The insurance company is contractually obligated to repay the principal and a specific interest rate to participants (not less than 3.5% per year). The Lincoln group annuity contract (fixed option) is a fully benefit-responsive investment contract which is a general obligation of the Lincoln Financial Group and is stated at contract value. Investment income of the Lincoln group annuity contract (fixed option) is presented on a contract value basis.

In September 2024, the Plan entered into a contract with Lincoln National Life Insurance Company to purchase the Lincoln Stable Value Separate Account (SVSA) investment. The SVSA is a group fixed annuity contract custodied by Principal Trust Company and is an unallocated investment contract with a guaranteed rate of return. The Plan does not own the underlying assets of the SVSA. The insurance company is contractually obligated to repay the principal and a specific interest rate to participants (not less than 4.08% per year). The SVSA is a fully benefit-responsive investment contract which is a general obligation of Lincoln National Life Insurance Company and is stated at contract value. Investment income of the SVSA is presented on a contract value basis.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

- The Plan’s failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code
- Premature termination of the contracts
- Plan termination or merger
- Changes to the Plan’s prohibition on competing investment options
- Bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan’s normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

**5. RELATED-PARTY AND EXEMPT PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Principal, VALIC and Lincoln, the custodians (or as applicable, insurance company) and recordkeepers of the Plan. Therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid for investment management services were included as a reduction of the return earned on each fund.

Notes receivable from participants also qualify as party-in-interest transactions. These transactions are not considered “prohibited transactions” under Section 408(b) of the IRC and are not prohibited by ERISA.

**6. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**7. FEDERAL INCOME TAX STATUS**

The Plan uses a prototype plan document sponsored by Principal. Principal received an opinion letter from the Internal Revenue Service (IRS), dated March 31, 2017, which states that the prototype document satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. The Plan itself has not received a determination letter from the IRS.

The Plan has been designed to qualify under Section 403(b) of the IRC. The terms of the Plan have been prepared to conform with the sample language provided by the IRS in Revenue Procedure 2007-71. The Plan is required to operate in conformity with the IRC to maintain the tax-exempt status for plan participants under Section 403(b).

The Company and Plan management believe that the Plan is currently designed and operated in compliance with the applicable requirements of the Code, and that the Plan continues to be tax exempt. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

**8. SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements are available to be issued. There were no subsequent events that require adjustment to or disclosure in the financial statements.
