We were engaged to perform audits of the financial statements of March of Dimes Inc. 403(b) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

**Disclaimer of opinion**

We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matter described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

**Basis for disclaimer of opinion**

The Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the financial statements may have been affected by these conditions.

**Responsibilities of management for the financial statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**Auditor's responsibilities for the audit of the financial statements**

Our responsibility is to conduct an audit of the Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditor's report. However, because of the matter described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits.

**Other matter – supplemental schedule required by ERISA**

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. Because of the significance of the matter described in the Basis for Disclaimer of Opinion section of our report, it is inappropriate to and we do not express an opinion on the supplemental schedule referred to above.

**NOTE 1 - DESCRIPTION OF PLAN**

***General***

The following description of the March of Dimes Inc. 403(b) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

The Plan is a defined contribution retirement plan for eligible employees of the March of Dimes Inc. (March of Dimes) and operates under Section 403(b) of the Internal Revenue Code (the Code). The March of Dimes is the Plan Administrator. The Plan was originally established on January 1, 1975 and has been subsequently amended. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan is separate from other retirement plans offered by the March of Dimes which are: The Retirement Plan for National Office and Field Staff Employees of the March of Dimes Foundation and the March of Dimes Inc. 401(a) Plan.

Effective April 1, 2022, the Plan was amended to change the name of the Plan from the March of Dimes Inc. 403(b) Retirement Savings Plan to the March of Dimes Inc. 403(b) Plan.

In November 2007, the Department of Labor (DOL) issued amended regulations eliminating an exemption granted to 403(b) plans from the annual Form 5500 reporting and disclosure requirements under Part 1 of Subtitle B of Title I of ERISA. Prior to the amended regulations, the Plan was not viewed as a separate reporting entity. Historically the Plan was viewed as a collection of individual contracts with which participants could engage in a range of actions with limited involvement, if any, by the Plan sponsor. Accordingly, various custodial accounting and recordkeeping reports related to the Plan's 403(b) annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009 were not sufficiently maintained. The third-party custodians were unable to provide those records to management necessary to substantiate the historical balances. Consequently, the financial statements and supplemental schedules have been prepared based on available records. As certain records were not available from the inception of the Plan, the effect, if any, on the completeness or accuracy of the Plan's financial statements cannot be determined.

***Eligibility***

Eligible employees of the March of Dimes can participate in the Plan. Eligible employees mean all employees, including seasonal and temporary employees. All employees are automatically enrolled in the Plan.

***Participant Accounts***

Individual accounts are valued daily and maintained for each of the Plan's participants to reflect the participant's contributions, the participant's share of the Plan's earnings (losses), and any related administrative expenses resulting from transactions directed by the participant. Allocations are based on participant's earnings, account balances, or specific participant transactions, as defined. The Plan allows for participants to directly invest a portion or all of their account in a brokerage account under the Plan.

***Contributions***

Participants' contributions are salary deferrals per payroll period, by a specified percentage selected by the participant in a salary reduction agreement with the March of Dimes. At its discretion, the March of Dimes may make a matching contribution to participants. The total amount of participants' contributions is subject to restrictions imposed by the Code. The limit is \$23,000 for the year ended December 31, 2024. Further,

participants who attain age 50 or older during the year are eligible to make additional “catch-up contribution” to the Plan equal to \$ 7,500 for the year ended December 31, 2024.

The March of Dimes made a matching contribution of 100% of the first 4% deferred for the year ended December 31, 2024.

***Vesting***

A participant in the Plan is fully and immediately vested in their contributions and the earnings thereon. Prior to January 1, 2022, participants became 100% vested in any employer matching contributions on the date they complete three years of service. Employer matching contributions made on or after January 1, 2022 become 100% vested upon completion of two years of service.

If a participant terminates employment with the March of Dimes before they are 100% vested in the March of Dimes’ discretionary matching contributions, the amount of funds from the March of Dimes matching contribution is forfeited. Forfeitures occurring during a plan year are used to reduce administrative expenses of the Plan, and any forfeitures remaining are used to offset future contributions. Forfeitures amounted to \$37,932 and \$102,019 for the years ended December 31, 2024 and 2023, respectively, with \$15,824 and \$125,366 of forfeitures available at December 31, 2024 and 2023, respectively. For the year ended December 31, 2024, forfeitures totaling \$41,434 were used to offset administrative expenses and \$116,082 were used to offset employer contributions.

***Benefits***

Participants may receive all or a portion of their vested account balance resulting from participant elective contributions upon termination of employment, upon becoming disabled, upon reaching 59½ years of age, or due to hardship. Participants may receive all or a portion of their vested account balance resulting from participants’ contributions and the discretionary March of Dimes matching contributions plus earnings thereon upon termination of employment.

Benefits may be paid at retirement as a lump sum or by purchasing an annuity, which has various different payment options, including single life annuity or survivor annuity.

Participants who terminate employment prior to retirement may elect to have their balance distributed in a lump sum or transferred to an individual retirement account or another employer’s qualified plan. Death benefits are paid according to the benefits election in effect at the time of death.

***Plan Administration***

The Plan is administered by the Finance and Pension Committee of the March of Dimes’ Board of Trustees, with delegated authority to certain officers and employees of the March of Dimes. Teachers Insurance and Annuity Association of America and College Retirement Equities Fund (TIAA and CREF) are the custodians for certain assets held and Fidelity Management Trust Company (Fidelity) is a custodian/recordkeeper for certain assets held.

If the borrower does not repay the loan and related interest due in accordance with the schedule set forth in the promissory note or other writing permitted by applicable law representing the loan, their loan will be deemed in default.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Presentation***

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

***Payment of Benefits***

Benefits are recorded when paid.

***Investment Valuation and Income Recognition***

Investments held by a defined contribution plan are required to be reported at fair value except for fully benefit-responsive investment contracts, which are required to be reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (Note 4).

Net appreciation in fair value of investments in the statement of changes in net assets available for benefits includes realized gains and losses on investments bought and sold and the change in unrealized gains and losses during the reporting period. Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date.

Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

***Use of Estimates***

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

**NOTE 3 - INFORMATION CERTIFIED BY THE CUSTODIANS**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, Fidelity and TIAA and CREF have certified as being complete and accurate the investment information on the statements of net assets available for benefits at December 31, 2024 and 2023, the investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the information included in the supplemental Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

Fair value is defined as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants at the measurement date. It prioritizes the inputs to the valuation techniques used to measure fair value by giving the highest priority to unadjusted quoted prices in active markets for

identical assets or liabilities (Level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are as follows:

Level 1 - Inputs that reflect unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date;

Level 2 - Inputs other than quoted prices that are observable for the asset or liability either directly or indirectly, including inputs in markets that are not considered to be active; and

Level 3 - Inputs that are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024 and 2023.

*Money Market Funds:* Valued at the quoted price based on net asset value (NAV) of shares held by the Plan at year end.

*Shares in Registered Investment Companies:* Registered investment companies consist of mutual funds, which are valued at the quoted price based on NAV of shares held by the Plan at year end, and variable annuities for which the fair values of accumulation units held by the Plan in the CREF accounts (registered investment companies held as variable annuity accounts) are based on each account's daily NAV. CREF accounts are not exchange traded. Data for NAVs are available daily to plan administrators and client investors on NASDAQ's website (Level 1) and provides sufficient corroborative evidence to ascertain the relationship between each fund's NAV and the values of individual underlying holdings. Underlying holdings are primarily valued using market quotations or prices obtained from independent pricing sources.

*Brokerage Link Accounts:* Brokerage link accounts are principally invested in registered investment companies, money market funds and common stock, which are valued at the quoted price based on the NAV of shares held by the participant at year end.

*Pooled Separate Account:* Valued at the NAV of shares held by the Plan at year end as determined by the issuer. The unit value of the fund is calculated daily and available to Plan administrators and client investors on NASDAQ's website. The NAV is derived from the fair value of the underlying real estate holdings or other real estate-related investments. Real estate holdings are valued principally using external appraisals, which are estimates of property values based on a professional's opinion. The pooled separate account sometimes holds securities as well. These are generally priced using values obtained from public independent pricing sources.

*TIAA Traditional Annuity Contracts (excluding fully benefit responsive investment contract):* TIAA Traditional Annuity Contracts are unallocated contracts. Contract value of the TIAA Traditional Annuity equals the accumulated cash contributions and interest credited to the Plan's contracts less any withdrawals. The fair value is derived from a discounted cash flow analysis and other factors.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or

assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Finance and Pension Committee of the Board of Trustees performs ongoing due diligence reviews of the Plan's investments and has retained a consultant to provide quarterly reports, including performance review.

There have been no changes in the methodologies used at December 31, 2024 and 2023. There were no transfers or reclassifications of investments between levels within the fair value hierarchy during the years ended December 31, 2024 and 2023.

For the year ended December 31, 2024, purchases of \$4,400 and sales of \$11,343 were made within the TIAA and CREF traditional annuity contracts.

**NOTE 5 - TIAA TRADITIONAL ANNUITY CONTRACTS**

The TIAA Traditional Annuity Contracts are one of the investment options that represent insurance contracts issued by TIAA, which guarantees principal and a contractually specified interest rate to account participants. The account offers the opportunity for higher returns through additional amounts that may be declared on a year-by-year basis by the TIAA Board of Trustees. The account is backed by individual bonds, commercial mortgages, real estate, stocks and other assets selected by specialized teams that target different sectors of the marketplace. The portfolio follows specific guidelines with respect to major asset classes, sectors, industries, property types, geographic regions, individual issuers/borrowers, foreign holdings, liquidity, quality and derivatives.

The TIAA Traditional Annuity is comprised of six types of contracts. The fully benefit responsive contracts are: the Group Supplemental Retirement Annuity (GSRA), the Supplemental Retirement Annuity, and the Retirement Choice Plus contracts. The non-benefit responsive contracts are: the Group Retirement Annuity (GRA), Retirement Annuity (RA) and Retirement Choice contracts. The Plan utilizes the GSRA contract, which is reported at contract value and the GRA and RA contracts, which are reported at fair value.

Under the GSRA contract, lump-sum withdrawals and transfers can be done at any time without any restrictions or charges. Under the GRA contract, lump-sum withdrawals are available only within 120 days after termination of employment and are subject to a 2.5% surrender charge. Under the RA contract, lump sum cash withdrawals are not allowed, and transfers must be paid in 10 annual installments.

The contracts use the vintage method to credit interest to the TIAA Traditional Annuity Account. Vintages are time periods that represent when money was initially invested in the TIAA Traditional Annuity Account and corresponding interest rate during that distinct time period. The Vintage method recognizes the fact that the level of prevailing interest rates available on new long-term investments will vary over time and that as the long-term investments in a specific vintage mature, they will be reinvested at different rates. When funds flow into the TIAA Traditional Annuity Account, they are immediately invested at the prevailing pay in rate for new money. The funds earn interest at the prevailing vintage rates. The vintage will always consist of two parts: the guaranteed portion and the discretionary portion. The guaranteed portion represents the minimum amount of interest that will be credited to an account, regardless of the economic environment. The discretionary portion represents interest earned over and above the guaranteed rate.

**NOTE 6 - PLAN TERMINATION**

Although the March of Dimes has not expressed any intention to terminate the Plan, the March of Dimes may discontinue its contributions under the Plan at any time and terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

**NOTE 7 - ADMINISTRATIVE EXPENSES**

Administrative expenses incurred by the Plan are first paid from account forfeitures, and any remaining cost is charged against the accounts of all participants on a pro rata basis. Administrative expenses incurred by participants are charged to the respective participant's accounts. Fees related to investment management and administrative cost from the service providers of the funds are paid using the net assets of the investment funds and are reflected as a component of net appreciation in fair value of investments on the statement of changes in net assets available for benefits.

**NOTE 8 - PARTIES-IN-INTEREST TRANSACTIONS**

Certain investments are managed by an affiliate of Fidelity or TIAA and CREF and, therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

**NOTE 9 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities in general are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in participant amounts on the accompanying statements of net assets available for benefits.

**NOTE 10 - TAX STATUS**

It is the intention of the March of Dimes that the Plan, as amended and restated, meets the requirements of ERISA and qualifies under Section 403(b) of the Code, thereby exempting the Plan from federal income taxes. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or derecognize an asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or derecognition of an asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 11 - SUBSEQUENT EVENTS**

The Plan Administrator has performed an evaluation of subsequent events through October 13, 2025, the date the financial statements were available to be issued.

Management is not aware of any subsequent events which would require recognition or disclosure in the financial statements.
