Opinion

Notes To Consolidated Financial Statements

NOTE 1. DESCRIPTION OF PLAN

The following description of the Altrust Financial Services, Inc. (the Company or Plan Sponsor) Employee Stock Ownership Plan (the Plan) provides only general information. Refer to the Plan Document for complete description of Plan provisions.

General

The Company established the Plan effective January 1, 1985. As of January 1, 2010, the Plan was amended and operates as an employee stock ownership plan (ESOP), and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (Code) and is subject to the applicable provisions of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan is a defined contribution plan covering all fulltime employees of the Company.

The Plan is administered by the Retirement Committee comprised of one or more individuals appointed by the Company's Board of Directors. An individual appointed by the Board of Directors of the Company serves as Trustee of the Plan.

Certain administrative functions are performed by officers or employees of the Company or its subsidiaries. No such officer or employee receives compensation from the Plan.

The Plan's assets, which consist principally of Altrust Financial Services, Inc. common shares, are held by the Plan Sponsor. Company contributions are managed by the Plan Sponsor, who invests cash received, as well as any interest and dividend income and makes distributions to participants.

Eligibility

Employees of the Company and its participating subsidiaries are eligible to participate in the Plan after 90 days of service or earlier in certain rehire situations. Participants who do not have at least 90 days of service during the Plan year or are not employed on the last working day of the Plan year or have not completed 1,000 hours of service during the Plan year are not eligible for an allocation of Company contributions for the year.

Contributions

Each year, eligible participants receive a contribution from the Company. The amount is discretionary and is determined on an annual basis by the Company's Board of Directors. During the year ended December 31, 2024, the Company approved a contribution totaling \$590,628. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

The Plan records employer contributions receivable when compensation is earned. In accordance with ASC 326, *Financial Instruments - Credit Losses*, no allowance for credit losses has been recorded at December 31, 2023, as employer contributions receivable have never historically incurred losses and current conditions and supportable forecasts show zero risk of nonpayment.

NOTE 1. DESCRIPTION OF PLAN (CONTINUED)

Participant Accounts

Each participant's account is credited with allocations of (a) the Company's discretionary contribution and (b) the Plan earnings (less any administrative expenses). Allocation of the discretionary contribution is based on the participants' compensation as a percentage of total covered compensation. Allocation of Plan earnings is based on the participant's account balance as a percentage of the total account balance. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. As of December 31, 2024 and 2023, there were no unallocated shares.

Vesting

If a participant's employment with the Company ends for any reason other than retirement, permanent disability or death, he or she will vest in the balances in his or her account based on total years of service with the Company. Participants are 20 percent vested after two years of service and incrementally increases by 20 percent each year of service until the participant reaches 100 percent vested after six years of service.

Benefit Payments

No distributions from the Plan will be made until a participant retires, dies (in which case payment shall be made to his or her beneficiary or, if none, his or her legal representatives), or otherwise terminates employment with the Company and its participating subsidiaries, or the participant uses the diversification provision available under the Plan.

The Plan was amended effective January 1, 2021, if the total vested value of a participant account exceeds two hundred fifty thousand dollars (\$250,000), distribution will be made in substantially equal annual installments over a period of five (5) years. Notwithstanding the foregoing, the period over which distribution of a participant's account is to occur may be increased by one year, up to five additional years, for each \$230,000 (or fraction thereof) by which the total vested value of the participant's accounts exceeds \$1,165,000. The aforementioned dollar amounts shall be subject to cost-of-living adjustments as prescribed by the Secretary of the Treasury.

Under the provisions of the Plan, the Company is obligated to repurchase participant shares, which have been distributed under the terms of the Plan as long as the shares are not publicly traded or if the shares are subject to trading limitations. No shares were repurchased by the Company from participants during 2024.

Voting Rights

Each participant is entitled to direct the Trustee on how to vote the shares of Company stock allocated to his or her account and is notified by the trustee prior to the time that such voting rights are to be exercised. The trustee shall vote any shares as to which no voting instructions have been received or which are held in a loan suspense account, if applicable, at the direction of the Retirement Committee, subject to its fiduciary duties under ERISA. In all other circumstances, the trustee shall vote all shares of Company stock as directed by the Retirement Committee.

Put Option

Under Federal income tax regulations, the employer stock that is held by the Plan and its participants that is not readily tradable on an established market, or is subject to trading limitations includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

NOTE 1. DESCRIPTION OF PLAN (CONTINUED)

Forfeited Accounts

The non-vested portion of a participant's account will be forfeited and redistributed to the remaining participants in the Plan in accordance with the provisions described in the Plan document. Forfeitures of terminated non-vested account balances allocated to remaining participants during 2024 were \$52,435. As of December 31, 2024 and 2023, there were no unallocated forfeitures.

Diversification

A diversification option is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company stock into investments that are more diversified.

Participants who are at least 55 years old with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25 percent of the number of post-1986 shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50 percent. Participants who elect to diversify can elect to receive a cash distribution or may transfer the appropriate portion of their account to the Company's 401(k) Profit Sharing Plan, which offers other investment options.

NOTE 2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). The Financial Accounting Standards Board (FASB) provides authoritative guidance regarding U.S. GAAP through the Accounting Standards Codification (ASC) and related Accounting Standards Updates (ASUs).

Use of Estimates

The preparation U.S. GAAP financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The common shares of the Company are valued at fair value on December 31, 2024 and 2023. Fair value is determined by an annual independent appraisal. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on any investments bought and sold as well as held during the year. Any dividend income is accrued on the ex-dividend date. The amount of dividends paid to the Plan by the Company was \$2,401,296 for the year ended December 31, 2024.

Payment of Benefits

Benefits are recorded when paid.

NOTE 2. SUMMARY OF ACCOUNTING POLICIES (CONTINUED)

Administrative Expenses

Expenses attributable to the general Plan administration were paid by the Plan and allocated among the accounts of all participants, in proportion to their account balances, unless paid by the Company.

Risk and Uncertainties

As of December 31, 2024 and 2023, approximately 96% of the Plan's total assets were invested in the common shares of Altrust Financial Services, Inc. The underlying value of the shares is entirely dependent on the performance of Altrust Financial Services, Inc., and the independent appraiser's evaluation of such performance.

It is reasonably possible that changes in the estimated fair value of Altrust Financial Services, Inc.'s common shares could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits.

Subsequent Events

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

NOTE 3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE 3. FAIR VALUE MEASUREMENTS (CONTINUED)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024, and 2023.

Cash and cash equivalents: Because of the nature of these assets, carrying amounts approximate fair value.

Company common shares: The fair value of the Company stock held by the Plan is valued at fair value based upon an independent appraisal. This appraisal was based upon a combination of the market and income valuation techniques consistent with prior years. The appraiser took into account historical and projected cash flow and net income, market comparables, lack of marketability, weighted average cost of capital, discount rate, and estimated fair value of Company assets and liabilities.

The valuation process involves Plan management's selection of an independent appraiser. Plan management accumulates the data for the appraiser from the audited financial statements of the Company. The appraiser prepares a preliminary report which the Board of Directors reviews in detail, discusses and approves. The results of this process are documented in the Board of Directors minutes of the Company.

NOTE 5. RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS

A portion of the Plan's assets are investments in the Company's common stock. Also, a portion of the Plan's assets are funds held in a variable interest rate checking account with Peoples Bank of Alabama. Peoples Bank of Alabama is a subsidiary of Altrust Financial Services, Inc. As the Company is the Plan sponsor, these transactions qualify as party-in-interest transactions and are also considered exempt transactions.

NOTE 6. PLAN TERMINATION

The Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon such termination, the interest of each participant in the trust fund would be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the IRS Code. Accounts of participants would become nonforfeitable. Upon termination of the Plan, the Retirement Committee would direct the trustee to pay all liabilities and expenses of the trust fund and to sell shares of financed stock held in a loan suspense account to the extent it determines such sale to be necessary in order to repay the loan, if applicable.

NOTE 7. TAX STATUS

The IRS has determined and informed the Plan sponsor by a letter dated October 24, 2016, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Tax positions are recognized only if it is "more likely than not" that the tax position be sustained in a tax examination, with a tax examination being presumed to occur. The amount recognized is the largest amount that is greater than 50% likely of being realized on examination. For tax positions not meeting the "more likely than not" test, no tax position is recorded. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
