The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

**NOTE 1 - DESCRIPTION OF PLAN**

***General***

The following description of the March of Dimes Inc. 401(a) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

The Plan is a noncontributory, defined contribution plan adopted as of December 1, 2012, and is sponsored by the March of Dimes Inc. (March of Dimes) for eligible employees. The March of Dimes is also the Plan Administrator. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan was formed to fund nonelective employer contributions, as defined in the Plan documents.

The Plan is separate from other retirement plans offered by the March of Dimes: The Retirement Plan for National Office and Field Staff Employees of the March of Dimes Foundation and the March of Dimes Inc. 403(b) Plan.

***Eligibility***

All eligible employees of the March of Dimes were able to participate in the Plan. To participate in the Plan, an eligible employee was required to complete a minimum of 1,000 hours of service as a regular employee of the March of Dimes during his/her eligibility computation period, be employed on the last day of the Plan year, and not be a member of an excluded class. An employee was a member of an excluded class if the employee was:

- A temporary employee hired for a specified period of six months or less in any calendar year;
- Employed pursuant to a collective bargaining agreement (i.e., in a union) that does not require inclusion under the Plan;
- Determined to be a leased employee or independent contractor, who perform services for the March of Dimes under an agreement with an organization not related to the March of Dimes; and
- A resident of Puerto Rico.

However, a temporary employee would have become eligible under the Plan, and no longer be a member of an excluded class, upon completion of one year of service and attainment of age 21.

***Participant Accounts***

Under a custodial agreement between Fidelity Management Trust Company (Fidelity) and the March of Dimes, a custodial account is established for each participant in the Plan. The accounts are credited with the March of Dimes' plan earnings (losses), and charged with actual or an allocation of administrative expenses based on participant's earnings, account balances, or specific participant transactions, as defined. Participants are responsible to direct their account investments based on the investment options available with Fidelity that are limited to shares of registered investment companies (mutual funds). In the event a participant fails to direct their investment election, their account will be invested 100% in the Fidelity Freedom Funds based upon the participant's date of birth.

***Vesting***

A participant becomes fully vested after three years of service (cliff vesting). There is no partial vesting under the Plan. Forfeitures, if any, are first used to reduce administrative expenses under the Plan, and any remaining forfeiture amounts are used to offset contributions due from the March of Dimes. Amounts

forfeited totaled \$0 for the years ended December 31, 2024 and 2023, respectively. Forfeitures available at the years ended December 31, 2024 and 2023 were \$276,341 and \$303,831, respectively.

Participants may receive all or a portion of their vested account balance upon termination of employment, becoming disabled or reaching 59½ years of age.

Benefits may be paid at retirement as a lump sum or by purchasing an annuity, which has various different payment options including single life annuity or survivor annuity.

Participants who terminate employment prior to retirement may elect to have their balance distributed in a lump sum or transferred to an individual retirement account (IRA) or another employer's qualified plan.

***Plan Administration***

The Plan is administered by the Finance and Pension Committee of the March of Dimes' Board of Trustees, with delegated authority to certain officers and employees of the March of Dimes. Fidelity Management Trust Company is the trustee of the Plan.

***Payment of Benefits***

The vested benefits are paid to the participants or their beneficiaries upon the participant's retirement, death, disability or termination of employment with the Plan Sponsor.

Hardship withdrawals are permitted by the Plan as defined in the Internal Revenue Code (IRC). Participants could also withdraw their vested account balance upon attaining age 59½. Minimum required distributions for participants who had reached age 73 also applied per Internal Revenue Service (IRS) regulations.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

***Payment of Benefits***

Benefits are recorded when paid.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (see Note 4).

Net appreciation in fair value of investments in the statement of changes in net assets available for benefits includes realized gains and losses on investments bought and sold and the change in unrealized gains and losses during the reporting period. Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date.

***Use of Estimates***

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and

disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

**NOTE 3 - INFORMATION CERTIFIED BY FIDELITY**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, Fidelity has certified as being complete and accurate the investment information on the statements of net assets available for benefits at December 31, 2024 and 2023, the investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the information included in the supplemental schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

Fair value is defined as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants at the measurement date. It prioritizes the inputs to the valuation techniques used to measure fair value by giving the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are as follows:

- Level 1 - Inputs that reflect unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date;
- Level 2 - Inputs other than quoted prices that are observable for the asset or liability either directly or indirectly, including inputs in markets that are not considered to be active; and
- Level 3 - Inputs that are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024 and 2023.

*Money Market Funds:* The money market fund is valued at the quoted price based on net asset value (NAV) of shares held by the Plan at year end.

*Shares in Registered Investment Companies:* Registered investment companies consist of mutual funds and are valued at the quoted price based on NAV of shares held by the Plan at year end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Finance and Pension Committee of the Board of Trustees performs ongoing due diligence reviews of the Plan's investments and has retained a consultant to provide quarterly reports, including performance review.

All of the Plan's investments are valued using Level 1 inputs as of December 31, 2024 and 2023.

#### **NOTE 5 - PLAN TERMINATION**

Effective January 1, 2019, March of Dimes no longer makes any employer contributions to the Plan. The March of Dimes may terminate the Plan subject to the provisions of ERISA. In January 2025, Plan management decided to terminate the Plan. Upon plan termination, participants will become 100% vested in their employer contributions.

#### **NOTE 6 - ADMINISTRATIVE EXPENSES**

Administrative expenses incurred by the Plan may be paid by the Plan Sponsor on behalf of the Plan by charging against the accounts of all participants on a pro-rata basis, or from account forfeitures. In 2024, administrative expenses incurred by the Plan were paid by the Plan Sponsor on behalf of the Plan. Fees related to investment management and administrative cost from the service providers of the funds are paid using the net assets of the investment funds and are reflected as a component of net appreciation in fair value of investments on the statement of changes in net assets available for benefits.

#### **NOTE 7 - PARTIES-IN-INTEREST TRANSACTIONS**

Certain investments are managed by an affiliate of Fidelity and, therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

#### **NOTE 8 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities in general are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in participant amounts on the accompanying statements of net assets available for benefits.

#### **NOTE 9 - TAX STATUS**

The IRS has determined and informed March of Dimes by a letter dated December 28, 2017, that the Plan is intended to comply with the applicable requirements of Section 401(a) of the IRC of 1986, as amended. Although the Plan has been amended since receiving the determination letter, the Plan Administrator still believes that the Plan is currently designed and being operated in compliance with applicable requirements of the IRC and, as such, is exempt from Federal income tax.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 10 - SUBSEQUENT EVENTS**

The Plan Administrator has performed an evaluation of subsequent events through October 13, 2025, the date the financial statements were available to be issued.

Except for the plan termination noted in Note 5, management is not aware of any subsequent events which would require recognition or disclosure in the financial statements.
