Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## Notes to financial statements

### 1. Description of the plan

The following brief description of the ESP Enterprises Inc. (the "Company") 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

#### General

The Plan is a defined contribution plan, qualifying under section 401(a) of the Internal Revenue Code ("IRC"), and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). The Plan was established for the purpose of providing eligible employees of the Company, and their beneficiaries' funds for retirement.

#### Eligibility

Any employee of the Company becomes an eligible participant in the Plan following their date of hire subject to the completion of one year of service and the attainment of twenty-one years of age. Employees subject to a collective bargaining agreement are not eligible to participate in the Plan. Participant's entry dates for the Plan are the first day of each month.

#### Contributions

Employee may elect to reduce Employee Compensation (defined below) and make a contribution to the Plan on a pre-tax basis. These pre-tax contributions are known as Elective Deferral Contributions. Employee may elect to defer up to 85% of Employee Plan Compensation on a pre-tax basis but must defer at least 1% of Plan Compensation. Federal law also limits the amount Employee may elect to defer under this Plan and any other retirement plan permitting Elective Deferral Contributions during any calendar year (\$23,000 in 2024). However, if Employee is age 50 or over, Employee may defer an additional amount, called a "Catch-up Contribution", of up to \$7,500 (in 2024). These dollar limits are indexed; therefore, they may increase each year for cost-of-living adjustments. The Internal Revenue Code may further restrict Elective Deferral Contribution elections by "highly compensated" Participants. Employee may elect to start, increase, reduce or totally suspend Employee elections to contribute to the Plan effective as of each pay period. The Plan allows Elective Deferral Contributions to be made as Roth Contributions. Roth Contributions are Elective Deferral Contributions that are made in the same manner as your pre-tax Elective Deferral Contributions except that Roth Contributions are made to the Plan on an after-tax basis. If certain requirements are met, a "qualified distribution" from your Roth Contribution Account in the Plan will not be taxed. Please note, Roth Contributions are "Matched Employee Contribution". The Company may match contributions you make as Roth Elective Deferral Contributions.

The Company may, in its sole discretion, make a matching contribution on your behalf if you make a "Matched Employee Contribution"

A "Matched Employee Contribution" is any Elective Deferral Contribution or Catch-up Contribution that you may make during the Plan Year. If you make a "Matched Employee Contribution" the Company may contribute to your Employer Matching Contribution Account in an amount and allocation formula as determined by the Company in its sole discretion.

## 1. Description of the plan (Continued)

### Vesting

Employee interest in your Employer Matching Contribution Account will vest based on your years of vesting service (defined below) in accordance with the following schedule:

<b>Years of vesting service</b>	<b>Percentage</b>
Less than three years	0%
Three or more years	100%

However, if the Company must make a matching contribution to your Account in order to satisfy certain non-discrimination tests required by the Internal Revenue Code, you will be 100% vested in those matching contributions.

### Loans

The Plan Administrator, in its discretion, may permit Participants to apply for a loan from the Plan. The Plan Administrator may further adopt any administrative rules or procedures that it deems necessary or appropriate with respect to the granting and administering of loans. Please contact the Plan Administrator for a copy of the Loan Procedures for more information regarding taking a loan from the Plan.

### Administrative expenses

The expenses necessary to administer the Plan, including, but not limited to, retaining necessary professional assistance from an attorney, an accountant, an actuary, or an investment advisor are paid by the Company. Participants are charged service fees for any loan or distribution transactions they request. Certain fees assessed by investment fund managers have been offset against net investment income.

## 2. Summary of Accounting Policies

### Basis of Accounting

The accompanying financial statements of the Plan have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America. Notes to Financial Statements

### **Use of Estimates**

The preparation of the Plan's financial statements in conformity with the accounting principles generally accepted in the United States of America ("US GAAP") requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments in the Plan are reported at fair value in accordance with ASC 820, Fair Value Measurements. The fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance. Any accrued but unpaid interest is de minimis. No allowance for credit losses had been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

### **Payment of Benefits**

Benefit payments to participants are recorded upon distribution.

### **3. Income Tax Status**

The Plan is intended to qualify under Section 401(a) of the Internal Revenue Code and, therefore, is exempt from federal income taxes. The Internal Revenue Service (IRS) has determined and informed the Plan sponsor that the Plan and related trust are designed in accordance with applicable tax law requirements. As such, no provision for income taxes has been included in the Plan's financial statements. The Plan sponsor believes that the Plan is currently operated in compliance with its terms and applicable requirements of the Internal Revenue Code. However, because the IRS may examine prior years, the Plan's tax-exempt status is subject to ongoing compliance with applicable provisions of the Internal Revenue Code.

### **4. Plan Termination**

The Company intends to continue the Plan indefinitely for the benefit of its employees, but reserves the right to modify, amend, or terminate the Plan at any time by resolution of its Board of Directors.

In the event of termination of the Plan, all amounts credited to participants' accounts shall be 100 percent vested and not forfeitable. All participants shall receive a total distribution of their accounts as described in the Plan.

#### 5. Investment Information Certified by the Plan's Trustee and Custodian (Unaudited)

Certain information related to the investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by LT Trust USA.

The following is a summary of the Plan's financial information that is included in the financial statements based on information certified by the trustee as complete and accurate in accordance with section 2520.103-8 of the Department of Labour's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Security Act of 1974.

#### 6. Fair Value Measurement

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature ASC 820 establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022:

**Mutual funds:** Mutual funds represent investments with various investment managers. The fair value of these investments is determined by reference to the Fund's underlying assets, which are principally marketable securities and fixed income securities. Shares held in mutual funds traded on national securities exchanges are valued at the net asset value as of December 31, 2024 and 2023.

**Stable value funds (common collective trusts):** Shares of the stable value funds are valued at quoted market prices which represent the net asset value of shares held by the Plan at year-end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. ## **7. Party-in-Interest Transactions**

Certain Plan investments are in funds and accounts that are managed by LT Trust USA, Participant loan and distribution processing fees are paid to LT Trust USA or the third-party administrator/recordkeeper by participants. The Plan paid for third party administrator fees and investment advisory fees which qualify as party-in-interest transactions. The Plan also issues loans to participants which are secured by the vested balance of the participants' accounts. Certain management fees in the form of an expense ratio charged to each investment option are paid by the Plan and deducted from earnings on investments. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

## **8. Risks and Uncertainties**

The Plan holds various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.

## **9. Subsequent Events**

During the year ended December 31, 2024, the Plan's sponsor elected to change accounting firms and engaged a new firm to perform the ERISA Section 103(a)(3)(C) audit. The change was initiated by the plan sponsor as part of its internal decision to transition accounting services.

There were no disputes or disagreements with the prior accounting firm on any matters of accounting principles, audit scope, or financial statement presentation.

## **10. Subsequent Events**

The Plan has evaluated subsequent events from the date of the statement of net assets available for benefits through October 10, 2025 the date the financial statements were available to be issued.
