Opinion

NOTE 1 - DESCRIPTION OF THE PLAN

The IBEW/NECA Sound and Communications Health and Welfare Plan (the "Plan") is a multiemployer welfare benefit plan which provides benefits to eligible participants and their eligible dependents. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established by the terms of an agreement and declaration of trust, dated December 14, 1989, between various International Brotherhood of Electrical Workers Local Unions (IBEW), various chapters of the National Electrical Contractors Association (NECA), and other contractors signatory to the Northern California and Northern Nevada Sound and Communications Agreement.

The Plan document includes detailed rules regarding Plan benefits. Participants should refer to the Plan agreement and any amendments regarding specific provisions of the Plan.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

C. Employer Contributions and Contributions Receivable

Employer contributions, as reported, are contributions made by employers on behalf of employees for months worked during the year. Employer contributions receivable is estimated based on contributions received subsequent to the end of the year. No allowance is provided for estimated uncollectible accounts.

D. Tax-Exempt Status

The Plan has received tax-exempt status from the federal government under Internal Revenue Code Section 501(c)(9) and the state of California under Revenue and Taxation Code Section 23701i. The Plan has since been amended. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for federal or state income tax has been made.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

E. Investment Valuation and Income Recognition

Plan investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of investments are recorded on the trade-date basis. Mutual fund capital gains distributions are included in dividend income. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

F. Risks and Uncertainties

Plan investments are exposed to various risks such as interest rate, market fluctuations and credit risks. Due to the level of risk associated with investments, it is at least reasonably possible that changes in the value of investments in the near term could materially affect the amounts reported in the financial statements.

G. Cash and Cash Equivalents

Cash and cash equivalents consist of cash on hand, cash deposited with financial institutions in checking and savings accounts and a money market account.

NOTE 3 - ELIGIBILITY FOR ACTIVE PARTICIPANTS

Participating employers report to the Plan hours worked by covered employees and pay contributions based on an hourly rate for bargaining unit participants. These contributions are credited to a reserve bank. A participant begins receiving coverage on the first day of the next month following the last day of any month in which a pre-determined reserve bank is accumulated. If monthly contributions on behalf of a participant exceed the amount required, the excess dollars accumulate in the reserve bank. A participant's reserve bank may be used to extend benefit coverage while the participant is unemployed or working insufficient hours to maintain coverage. Certain participants who lose eligibility may continue coverage through self-payments.

NOTE 4 - BENEFIT LIABILITIES

The estimated amount due for Claims Payable and Incurred but not Reported as of December 31 represents the Plan's estimate of Claims Incurred December 31 and prior, but paid after December 31. The estimate was calculated based on a claim lag analysis and a review of claims paid after December 31, with incurred dates prior to December 31.

The Plan provides eligibility to participants on a two month lag basis. For example, hours worked through December 31 provide coverage through February of the following year. Therefore, as of December 31 of each year certain Plan participants will have two months of accrued eligibility for which the Plan will provide them benefits. The Plan has recorded a Future Eligibility - Lag Months liability on statements of benefit obligations to recognize this obligation.

NOTE 5 - ESTIMATED OBLIGATION FOR FUTURE BENEFITS

The estimated liability for future benefits is based upon the number of equivalent eligibility months that each participant has accumulated, subject to a Plan established maximum number of months, in the Plan's reserve bank at December 31, multiplied by the monthly cost of benefits. The Plan has recorded a Participants' Accumulated Eligibility liability on the statements of benefit obligations to recognize this obligation.

NOTE 6 - FAIR VALUE MEASUREMENTS

FASB ASC 820 provides the framework for measuring fair value of the Plan's investments. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023. Mutual funds are valued based upon closing market prices for shares held by the Plan at year end.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Amounts currently payable to or for participants, beneficiaries and dependents are reported on the Form 5500 for benefits that have been earned prior to December 31, but not yet paid as of that date.

NOTE 8 - PLAN TERMINATION

Upon the termination of the Plan, the trustees shall pay any and all obligations of the Plan and apply the remaining assets in such manner as will best effectuate the purpose of the Plan.

NOTE 9 - CONCENTRATION OF CREDIT RISK

During the years ended December 31, 2024 and 2023, the Plan maintained bank accounts with cash balances in excess of the federally insured limits of \$250,000 per bank. The amount in excess of the limits was subject to risk if the financial institution did not perform. The Plan has not incurred any losses on the uninsured balances.

NOTE 10 - DUE TO/FROM OTHER TRUSTS

The Plan collects employer contributions for the Plan and employer contributions and remittances for other related entities through a lockbox system and transmits to the related entities the employer contributions and remittances collected on their behalf. Employer contributions and remittances collected on behalf of the related entities that were not transferred to the related entities as of the end of the year are recognized as amounts payable to the related entities.

The Plan has a receivable from other trusts for reimbursement of a portion of legal, delinquency collections, and payroll compliance fees paid by the Plan on behalf of the other trusts.

NOTE 11 - HEALTH REIMBURSEMENT ACCOUNT (HRA)

The Board of Trustees have established a Health Reimbursement Account Plan (HRA) for participants. The HRA is a health-care reimbursement account funded solely by employer contributions to cover qualified medical expenses for the participant and their dependents. Participants may use their HRA account to receive reimbursement for out-of-pocket medical expenses not reimbursed by insurance, such as deductibles and co-insurance, out-of-pocket health care expenses as defined by the IRS, self-pay contributions, COBRA payments and retiree premiums.


