Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Community Service Society of New York 403(b) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Community Service Society of New York 403(b) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Community Service Society of New York 403(b) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Community Service Society of New York 403(b) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

1. Description of Plan

The following description of the Community Service Society of New York 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan was established on July 1, 1999. The Plan is a contributory defined contribution plan covering all employees of Community Service Society of New York (the Plan Sponsor). All employees (whether part or full time) are eligible to enter the Plan immediately. Only non-union employees are eligible to participate for purposes of matching contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Sponsor is responsible for oversight of the plan. The Plan Sponsor also determines the appropriateness of the Plan's investment offerings and monitors investment performance.

SECURE Act

The Plan has adopted certain provisions under the Setting Every Community Up for Retirement Enhancement Act of 2022 (SECURE 2.0 Act). The Plan intends to formally execute the required Plan amendments for these provisions by December 31, 2026.

The following descriptions of the Plan below have been updated with the provisions of the SECURE 2.0 Act that impact the Plan.

Contributions

Each year, participants may contribute up to 100% of their annual compensation on a pretax basis, as defined in the Plan. Compensation is defined as basic cash compensation not including overtime and bonuses. The total contribution to the Plan may not exceed the dollar limit for tax-deferred contributions set by the Internal Revenue Code. Participants may rollover amounts from other qualified defined benefit or contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

Effective June 21, 2024, the Plan was amended to allow participants to defer all or part of their bonus compensation, however, these deferrals are not included in the calculation of the Plan Sponsor match.

After 12 months of service, the Plan Sponsor will match 50% of an eligible participant's elective deferral up to 6% of the participant's eligible compensation. Salary deferrals in excess of \$12,000 will not be matched. The participant will be entitled to this contribution even if not employed by the Sponsor on the last day of the Plan year. During the years ended December 31, 2024 and 2023, the Plan Sponsor made matching contributions in the amount of \$232,849 and \$205,787, respectively.

Participant accounts

Each participant's account is credited with the participant's contributions and the Plan Sponsor's matching contributions as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses paid by this Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

All participants are immediately 100% vested in participant and Plan Sponsor contributions plus earnings thereon.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance subject to annuity contract and Plan provisions from the Trustee of the Plan. Loan terms range from one to five years in one-year increments but up to fifteen years for the purchase of the participant's primary residence. The loans are secured by the balance in the participant's account and bear interest at a reasonable rate of interest determined by taking into account interest rates being charged at the time of the loan. Principal and interest are paid ratably through bi-weekly payroll deductions. If the participant fails to make payments, the loan is considered in default and is accounted for as a distribution.

Payment of benefits

On termination of service due to death, disability, retirement or other reasons and if the vested benefit in the Plan does not exceed \$5,000, then benefits may only be distributed in the form of a lump-sum payment. If the vested benefit in the Plan exceeds \$5,000, participants may elect to receive a payout as a lump sum payment and/or installment payments. The Plan also permits withdrawals of vested account balances upon the attainment of age 59½, or in the event of a hardship, as defined by the Plan.

2. Summary of accounting policies

Basis of accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Contributions

Contributions from Plan participants and from the Plan Sponsor are recorded in the year in which participant compensation is earned.

2. Summary of accounting policies (continued)

Investment valuation and income recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by investment advisors, custodians, and insurance company. See Note 8.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payments of benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

3. Tax status

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (the Code). The Plan Administrator believes that the Plan was designed and is being operated in compliance with the applicable requirements of the Code. The terms of the Plan have been prepared to conform to the listing of 403(b) plans that have been pre-approved by the Internal Revenue Service. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for Plan participants under Section 403(b).

3. Tax status (continued)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. As of December 31, 2024, the Plan Administrator believes that based on evaluation of the Plan's tax positions that any liability as a result of uncertain tax positions would not be material. Management continually evaluates expiring statutes of limitations, changes in tax law, and new authoritative rulings to assist in evaluating the Plan's tax positions. Accrued interest and penalties associated with uncertain tax positions, if any, would be recognized as part of the income tax provision. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

4. Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits. The Plan maintains its investments with an investment manager. Exposure to credit risk is reduced by placing such investments in high quality financial institutions and by following an investment strategy which utilizes a wide range of diversified funds.

5. Certified investments

We have been informed by the Plan Administrator that Reliance Trust Company, Custodian FBO Pentegra Trust Company (Pentegra), Trustee, held the Plan's investment assets and executed investment transactions from January 1, 2023 to October 15, 2023, and Delaware Charter Guarantee & Trust Company D/B/A Principal Trust Company, held the Plan's investment assets and executed investment transactions from October 15, 2023 to December 31, 2024. Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Pentegra and Principal Trust Company (the trustees of the Plan).

6. Plan termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the entire account balance will be distributed to the participants.

7. Transactions with parties-in-interest

Certain Plan investments are managed by Principal Trust Company. Principal Trust Company is the trustee and recordkeeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Indirect fees paid by the Plan for said services are included as a reduction in the net change in fair value of investments. Investment advisory and administrative expenses relating to the maintenance of the Plan are paid from the Plan assets. Direct fees paid by the Plan during the year ended December 31, 2024 were \$55,862.

The Plan Administrator pays for professional fees relating to services provided to the Plan. Fees paid on behalf of the Plan during the year ended December 31, 2024 were \$24,678. The Plan Sponsor also provides certain accounting and administrative services to the Plan for which no fees are charged.

8. Fair value measurement of investments

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1), and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are as follows:

Level 1 – Inputs that reflect unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date;

Level 2 – Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs that are unobservable.

Inputs are used in applying the various valuation techniques and broadly refer to the assumptions that market participants use to make valuation decisions, including assumptions about risk. Inputs may include price information, volatility statistics, specific and broad criteria data, liquidity statistics, and other factors. An investment's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

8. Fair value measurement of investments (continued)

However, the determination of what constitutes “observable” requires significant judgment by the Plan. The Plan considers observable data to be that market data which is readily available, regularly distributed or updated, reliable and verifiable, not proprietary, provided by multiple, independent sources that are actively involved in the relevant market. The categorization of an investment within the hierarchy is based upon the pricing transparency of the investment and does not necessarily correspond to the Plan’s perceived risk of that investment.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Investments in registered investment companies are valued at the daily closing price as reported by the fund and are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. These funds held by the Plan are allocated between Level 1 and 2 hierarchy depending upon the availability of, or lack thereof, observable inputs.

9. Investment contracts with insurance companies

The Principal Guaranteed Option (PGO) is a benefit-responsive single group annuity contract issued by Principal. By definition, the PGO group annuity contract is an insurance contract. The account is credited with contributions and actual earnings and charged for participant withdrawals. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The PGO is a single group annuity contract with a fixed rate of interest. It is not a portfolio of contracts whose yields are based on changes in fair value of underlying assets as would be found in a Stable Value Fund. As a result, the average yield earned by the Plan is the yield (i.e. interest credited) on the group annuity contract.

As described in Note 2, because the guaranteed investment contract is fully benefit-responsive, the contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Changes in future interests crediting rates will not affect the amount reported as an adjustment from fair value to contract value on the statement of net assets available for benefits for the portion of net assets attributable to fully benefit-responsive investment contracts. The contract does have a surrender charge if terminated by the contract holder or the plan terminates its interest in such contract within certain time periods.

Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less withdrawals. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuers or otherwise. The crediting interest rate is based on an agreed-upon formula with the issuer, but cannot be less than zero. Under the terms of the existing contract, the crediting rate is currently reset on a semi-annual basis.

Certain events limit the Plan's ability to transact at contract value with Principal. Such events include the following: (a) amendments to the Plan document (including complete or partial Plan termination or a merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan Sponsor or other Plan Sponsor events that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the Employee Retirement Income Security Act of 1974. The Plan Administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with the Plan participants, is probable.

Investment contracts with insurance companies at December 31, 2024 and 2023 totaled \$1,746,557 and \$1,712,076, respectively.

10. Subsequent events

Subsequent events have been evaluated through October 13, 2025, which is the date the financial statements were available to be issued. The Plan is not aware of any material subsequent events.
