Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of St. Ann's Home, Inc. Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

1 – DESCRIPTION OF THE PLAN

General

St. Ann's Home, Inc. Retirement Plan (formerly St. Ann's Home, Inc. Retirement Plan Trust) (the "Plan") is a defined contribution retirement plan that was established on January 1, 1984 for the benefit of employees of St. Ann's Home, Inc. (the "Organization"). The Plan is funded by contributions from its participants and the Organization and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Effective May 1, 2023, the Plan legally changed its name from St. Ann's Home, Inc. Retirement Plan Trust to St. Ann's Home, Inc. Retirement Plan.

The following description of the Plan provides general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

Administration of the Plan

The Plan is administered by the Organization.

Eligibility for Participation

Prior to May 1, 2023, participants were eligible to make voluntary deferral contributions after completing one year of service that included at least 650 hours and having attained the age of 18. Effective May 1, 2023, participants are eligible to make voluntary deferral contributions after completing two months of service and having attained the age of 18. Participants are eligible to receive employer profit sharing contributions after completing two years of service that includes at least 650 hours in each year and having attained the age of 18. Per diem and temporary employees are not eligible to participate in the Plan. As of January 1, 2024, residents of Puerto Rico are not eligible to participate in the Plan.

Employee Elective Deferred Contributions

Prior to May 1, 2023, participants could defer up to 90% of their annual earnings to the Plan as contributions, subject to the limitations outlined in Internal Revenue Code Section 401(k). Effective May 1, 2023, participants can defer up to 100% of their annual earnings to the Plan as contributions, subject to the limitations outlined in Internal Revenue Code Section 401(k). Employee contributions in the form of rollovers and transfers from other qualified retirement plans are allowed as defined in the Plan document.

Employer Non-elective Contributions

The Organization may make non-elective contributions on behalf of eligible participants. Such contributions are allocated based on new comparability groups in a manner determined by the Organization.

Vesting

Participants are immediately vested in their voluntary contributions and employer contributions plus actual earnings thereon.

Participant Accounts

Accounts are maintained for each participant. Accounts are increased for contributions and for an allocation of investment income based on the relationship of each participant's account within each investment fund to the total fund. Accounts are decreased for withdrawals made by participants, administrative expenses, and for an allocation of investment losses based upon the relationship of each participant's account within each investment fund to the total fund.

Investment Options

The Plan was established with Ascensus Trust Company (“Ascensus”) as its trustee. Upon enrollment into the Plan, a participant may direct employee and employer contributions in whole number percentages into a variety of Ascensus investment options. Upon termination of employment, a participant may withdraw their account or transfer the account to another qualified plan.

Notes Receivable from Participants

A participant may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may not have more than two notes outstanding at any given time. Notes receivable from participants are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing lending interest rates. Principal and interest are paid ratably through payroll deductions.

In-service Withdrawals

Participants may make withdrawals prior to termination of employment under the following circumstances:

- Hardship as defined by the Internal Revenue Code or in the Plan document
- Attainment of age 59 ½
- Effective May 1, 2023, withdrawal from a participant's rollover contributions account

Retirement Benefits

The normal retirement age under the Plan is age 65. Certain participants may be eligible for early retirement at age 55 subject to the provisions in the Plan document. Effective May 1, 2023, a participant who becomes disabled as defined in the Plan document is eligible for disability retirement.

Payment of Benefits

Upon termination of service from the Organization, a participant may elect to receive the vested portion of his/her account in the form of a lump sum payment. A distribution on account of death may be made using extended payments. If a participant's account balance is less than \$5,000 at the time they become entitled to a distribution, such account may be paid in a lump sum to the participant.

Timing of Distributions

Distributions described above shall be made as soon as reasonably practicable following the date the participant's application for distribution is received by the trustee. As of December 31, 2024 and 2023, there were no distributions payable to participants.

Administrative Expenses

Certain administrative expenses incurred by the Plan are paid by the Organization. However, certain administrative expenses are paid by the Plan.

Participant-Directed Contributions, Withdrawals and Transfers

The election to allocate contributions between the investment options, and any decision to change such allocation, is made by each participant as permitted by the trustee. Withdrawals and transfers are recorded at the time such transactions take place.

2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared utilizing the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan Administrator to make significant estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting period, and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investments

Investments are carried at fair value, as determined by quoted market prices. Security transactions are accounted for as of the date the securities are purchased or sold (trade date). Interest income is recorded as earned and may include amortization of discount and premium. Dividend income is recorded on the ex-dividend date or, for certain foreign securities, as soon as the investment funds are informed of the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains (losses) on investments bought and sold as well as held during the year.

Each participant's assets are jointly invested and the return on assets is allocated among the participants and recorded as income or loss.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Risks and Uncertainties

The Plan provides for various investment options in a variety of mutual funds that are investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the accompanying Statements of Net Assets Available for Benefits.

Subsequent Events

The Plan Administrator evaluated events that occurred after December 31, 2024, the date of the Statement of Net Assets Available for Benefits, but before the date the financial statements were available to be issued, October 14, 2025, for potential recognition or disclosure in the financial statements. The Plan Administrator did not identify any subsequent events that had a material effect on the accompanying financial statements.

3 – INFORMATION CERTIFIED BY TRUSTEE

Unaudited information included in the Plan's financial statements and supplemental Schedule of Assets (Held at End of Year) was prepared by the Plan's trustee and furnished to the Plan Administrator and includes all Plan assets (except for the effects of participant and employer contributions receivables, if any) and all investment transactions. The Plan Administrator has obtained certifications from the trustee that such information is complete and accurate.

4 – FAIR VALUE MEASUREMENTS

The Plan applies the provisions of GAAP regarding fair value measurements and related disclosures. The provisions establish a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), a lower priority to significant other observable inputs (Level 2 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Basis of Fair Value Measurement

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Mutual funds and money market funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Loan repayments including principal and interest are made on a weekly basis. Each loan is secured by the borrower's interest in the Plan and bear interest at a rate commensurate with the local prevailing lending interest rate.

6 – PLAN TERMINATION

Although it has expressed no intent to do so, under the Plan, the Organization has the right to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of a termination of the Plan, each participant will be entitled to a lump sum distribution.

7 – INCOME TAX STATUS

Ascensus obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that Ascensus's prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Organization has adopted Ascensus's prototype plan. The Plan has been amended since receiving the determination letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

8 – PARTY-IN-INTEREST TRANSACTIONS

Plan investments consist of accounts held by Ascensus. Ascensus is the trustee of the Plan's assets and, therefore, these transactions qualify as party-in-interest. The Plan paid administrative fees to Ascensus during the years ended December 31, 2024 and 2023.

The Organization provides certain administrative and accounting services at no cost to the Plan. The Organization also pays for certain administrative costs of the Plan.
