Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the InterDent Service Corporation 401(k) Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 2 to the financial statements, is complete and accurate.

Opinion

NOTE 1 - DESCRIPTION OF THE PLAN AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Plan Description

The following description of the InterDent Service Corporation 401(k) Plan and Trust (the “Plan”) is provided for general information purposes only. More complete information regarding the Plan’s provisions may be found in the Plan document.

A. General

Headquartered in El Segundo, California, InterDent Service Corporation (InterDent or the Company) through its subsidiaries is a leading provider of dental practice management services to multi-specialty dental professional corporations and associations in the United States. The Plan is a defined contribution plan, which is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Employees of InterDent are eligible to participate in the Plan upon completion of 60 days of service and attainment of age 20½, and eligible for profit sharing contributions upon completion of 60 days of service.

B. Contributions

Participants may contribute 90% of their compensation as defined in the Plan, subject to Internal Revenue Code (the “Code”) limitations. Participants may also rollover amounts representing distributions from other qualified plans. Participants may contribute a maximum of \$23,000 to the Plan for 2024. Catch-up contributions are also allowed. Effective July 1, 2024, eligible participants will be automatically enrolled into the Plan at a contribution rate of 5% and the Plan will automatically increase pre-tax election by 1%, not to exceed 6% of compensation.

The Company, at its discretion, may make matching contributions. The Company elected to make matching contributions to the Plan for 2024 in the amount of \$1,296,882.

C. Vesting

Participants are immediately vested as to their contributions, rollover contributions, and actual earnings thereon. Vesting in the Company’s contributions plus actual earnings thereon is based on years of continuous service according to the following schedule:

A participant also becomes fully vested in Company contributions, if any, upon death or permanent disability while an employee of the Company, upon attaining normal retirement age, or upon termination of the Plan. QNECs are always 100% vested.

Any portion of a participant’s account that is not vested shall be forfeited upon distribution of the vested portion. First, forfeitures shall be used to reduce future Company contributions; second, any remaining forfeitures shall be used to offset the Plan’s administrative costs and third, any remaining forfeitures shall be allocated to participants. Forfeitures totaled \$107,706 in 2024; \$63,550 used to offset Company contributions and \$41,413 was used to offset plan expenses. Forfeitures totaling \$94,853 and \$80,230 were included in net assets as of December 31, 2024 and 2023, respectively.

D. Payment of Benefits

Benefit distributions under the Plan may be made in the form of a single lump-sum payment or installment payments, and are recorded when paid. Normal retirement age is 65; early retirement is allowed at age 55 for participants who have completed three years of service. Benefits may also be paid upon death, disability, termination of employment or termination of the Plan.

E. Participant Accounts

Each participant's account is credited with the participant's contributions, rollover contributions, an allocation of the Company's contributions, if any, and Plan earnings. Allocations are based on participant earnings or account balances.

F. Notes Receivable from Participants

A participant may secure a loan from his or her account in an amount greater than \$1,000, not to exceed the lesser of 50% of the vested account balance or \$50,000, reduced by the highest outstanding loan balance during the previous 12 months. Repayments are applied to the borrower's account. Loans bear interest at a reasonable rate, commensurate with rates charged by commercial lenders under similar circumstances. At December 31, 2024, interest rates on loans ranged from 4.25% to 9.50%.

G. Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

H. Use of Estimates

The preparation of the financial statements in conformity with GAAP requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

I. Administrative Expenses

Most administrative expenses are paid by the Company.

J. Investment Valuation and Income Recognition

Investments held by an employee benefit plan are required to be reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value represents contributions made under a contract, plus earnings, less participant withdrawals and administrative expenses.

Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net

GAAP establishes a fair value hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market.

Level 1 – Inputs are quoted prices in active markets.

Level 2 – Inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data.

Level 3 – Inputs are generally unobservable and typically reflect management’s estimates of assumptions that market participants would use in pricing the asset or liability.

L. Risks and Uncertainties

The Plan provides for various investment options in any combination of investments offered by the Plan. Investments are exposed to various risks, such as interest rate, market and credit risks. Due to the risk associated with investments, it is at least reasonably possible that changes in market values, interest rates or other factors in the near term would materially affect participants' account balances and the amounts reported in the financial statements. The Plan's exposure to the credit loss in the event of nonperformance of investments is limited to the carrying value of such investments.

NOTE 2 - FINANCIAL INFORMATION CERTIFIED BY THE CUSTODIANS

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Information regarding investments held at December 31, 2024 and 2023 and investment income for the year ended December 31, 2024 that is disclosed in the accompanying financial statements and supplemental schedule was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Principal Trust Company and Principal Life Insurance Company, the custodians of the Plan.

NOTE 3 - INCOME TAX STATUS

The Plan is a volume submitter plan that has received a favorable opinion letter from the Internal Revenue Service. The Company believes the Plan qualifies under and is operated in accordance with applicable requirements of the Code and related state statutes and the trust, which forms a part of the Plan, is exempt from federal income and state franchise taxes.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 4 - FIXED INCOME GUARANTEED OPTION

The Plan maintains a fully benefit-responsive group annuity contract with Principal Financial Group through the Fixed Income Guaranteed Option ("Guaranteed Interest Account"). Contributions to the Guaranteed Interest Account are maintained in a Principal Financial Group general account and credited for interest and charged for participant withdrawals and administrative expenses. Principal Financial Group is contractually obligated to repay principal and a specified rate of interest that is guaranteed to the Plan. The Guaranteed Interest Account meets fully benefit-responsive investment contract criteria and is reported at contract value.

NOTE 4 - FIXED INCOME GUARANTEED OPTION (Continued)

The crediting rate is based on a formula established by Principal Financial Group but may not be less than 0.15% percent or greater than 3%. The crediting rate is reviewed semiannually for resetting. The 2024 crediting rate was 1.55% through December 2024.

The Plan's ability to receive amounts due is dependent on Principal's ability to meet its financial obligations. There are no reserves against contract value for credit loss. Certain events might limit the ability of the Plan to transact at contract value including premature termination of Plan investments in the Guaranteed Interest Account. The plan administrator does not believe that any events limiting the Plan's ability to transact at contract value are probable of occurring.

NOTE 5 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate or amend the Plan subject to the provisions of ERISA. If the Plan is terminated, all participants will be 100% vested in their account balances.

NOTE 6 - PARTIES-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by the custodians or affiliates. Any purchases and sales of these investments are performed in the open market at fair value. Such transactions, while considered party in interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibitions of party in interest transactions under ERISA.

NOTE 7 - PLAN AMENDMENT

Effective July 1, 2024, the Plan was adopted to automatically enroll eligible participants into the Plan at a contribution rate of 5% and the Plan will automatically increase pre-tax election by 1%, not to exceed 6% of compensation.

NOTE 8 - DELINQUENT PARTICIPANT CONTRIBUTIONS

During the years ended December 31, 2024, the Company failed to remit \$630 of participant contributions within the time frame specified by the Department of Labor (DOL). Failure to remit such amounts within the designated time frame constitutes a prohibited transaction under DOL Regulations. The participant contributions were subsequently remitted to the Plan during 2024.

NOTE 9 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosures in these financial statements.
