#### NOTE 1 - Description of the Plan

The following summary description of Continental Fire & Safety Services, LLC 401(k) Plan is provided for general information purposes only. Participants should refer to the Plan Agreement for more complete information.

General - All employees of Continental Fire & Safety Services, LLC and Guardian Fire Protection Services (the Companies), as defined in the Plan Agreement, having attained the age twenty-one and meeting the service requirements, are eligible to become participants in the Plan. Guardian was a wholly owned subsidiary of Continental prior to an April 1, 2021 spin-off reorganization. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

On January 16, 2024, the Plan sponsor and three affiliated entities connected through common ownership and management were acquired. Employees from each entity continued participating in their respective retirement plans until March 1, 2024, when the Plan was divided into two separate plans. As part of this restructuring, Guardian Fire Protection Services established its own plan, resulting in \$8,513,936 in net assets transferring out of the Plan.

On December 31, 2024, both plans were consolidated into a newly formed plan. \$2,156,445 in remaining net assets were transferred to the new plan.

Contributions - Participants may elect to contribute up to 75% of their pre-tax earnings to the 401(k) Plan. Participants' contributions are subject to annual maximums in accordance with the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants designate how their contribution will be invested in the investment funds selected by the Plan Administrator. The Plan has an automatic enrollment feature under which eligible employees are automatically enrolled with a 1% deferral rate unless they elect to opt out. The Plan provides for an employer matching contribution of 50% of salary deferrals up to 50% of compensation, not to exceed a total of \$2,000.

Participant Accounts - Each participant's account is credited with the participant's contribution, the employer's matching contribution, if applicable, and Plan earnings. Allocations are based upon provisions as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options - Upon enrollment in the Plan, a participant may direct employee contributions in one percent increments in any of the 26 investment options. Participants may change their investment options at any time. The options consist of professionally managed mutual funds and vary in their respective strategies, risks and goals.

### NOTE 1 - Description of the Plan (Continued)

Vesting - Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the Companies' contribution portion of their accounts, plus actual earnings thereon, is based on years of continuous service. A participant is 100 percent vested after six years of credited services.

Notes Receivable from Participants - Participants may request a loan from the Plan of up to 50% of their vested balance or \$50,000, whichever is lower. The loan term is limited to five years unless it is for the purchase of a principal residence. Loans are secured by the participant's account and bear interest at prevailing rates as determined by the plan administrator. Principal and interest are paid through payroll deductions.

Participants' Withdrawals - Upon a participant's retirement date or upon a participant's death or total and permanent disability, all amounts credited to his or her account shall become fully vested. Upon termination, the non-vested portion of a participant's account shall be forfeited.

Distribution of the vested portion of a participant's account shall be made upon termination of employment. The vested portion of the account is payable to the participant or the beneficiary as a lump-sum amount. If the vested portion of the account is less than \$5,000, the Administrator has the option of a distribution without the participant's consent. If the vested portion of the participant's account exceeds \$5,000, a distribution before normal retirement age can only be made with the participant's consent. The non-vested portion of a participant's account shall be forfeited and used to reduce future employer matching contributions.

Forfeited Accounts - At December 31, 2024 and 2023, the value of forfeited non-vested accounts totaled \$- and \$4,348, respectively. The forfeitures of non-vested employer matching contributions from terminated participant accounts are used first to reduce employer matching contributions. The Companies' matching contributions were reduced by \$4,541 and \$6,571 for the years ended December 31, 2024 and 2023, respectively.

SECURE Act and CARES Act - The Plan has implemented certain provisions of the SECURE Act, which was effective January 1, 2020, and the CARES Act, which was signed into law in March 2020. The Plan has until December 31, 2026 to adopt amendments to reflect these provisions.

### NOTE 2 - Significant Accounting Policies

Basis of Accounting - The financial statements were prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions and deductions during the reporting period. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition - The Plan's investments are stated at current fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Dividends are recorded when received. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants - Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. If a participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - The Plan's administrative expenses are primarily paid by the Plan sponsor and are excluded from these financial statements. Fees for the administration of notes receivable from participants and processing of benefit payments are charged directly to the participant's account and are included in administrative expenses. The Plan also pays investment advisory fees. Additional investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events - Management has evaluated events and transactions through October 14, 2025, the date the financial statements were available to be issued.

The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels which are described below. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

#### Level 1 Fair Value Measurements

Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year end. The fair values of common stock, corporate bonds, and U.S. Government securities are based on the closing price reported on the active market where the individual securities are traded.

#### Level 2 Fair Value Measurements

Level 2 inputs consist of quoted prices for similar assets in active and inactive markets and other observable corroborated market data. Level 2 inputs are only used when Level 1 inputs are not available. This includes, but not limited to, quoted prices for similar assets or liabilities in markets that are not active. There are no Level 2 assets.

### NOTE 5 - Information Certified by Trustee

The financial statements and accompanying notes were prepared in part from information certified by Reliance Trust Company, the trustee of the Plan, as of and for the years ended December 31, 2024 and 2023, in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). The information certified includes: investments, notes receivable from participants, investment income, and participant loan interest.

### NOTE 6 - Related Party and Party-in-Interest Transactions

Reliance Trust Company is the trustee as defined by the Plan and ADP Retirement Services provides recordkeeping services to the Plan. Therefore, they are considered parties-in-interest. The Companies sponsor the Plan and are considered parties-in-interest. The administrative expenses paid by the Plan include plan administration and investment advisory fees. These service providers, along with service providers paid on behalf of the plan, are all considered parties-in-interest.

### NOTE 7 - Plan Termination

Effective December 31, 2024 the Plan merged into the plan of the successor employer (see Note 1). In December 2024 all assets of the plan were transferred to the successor employer's plan. As of December 31, 2024, no assets remained in the Plan.

### NOTE 8 - Tax Status

The Plan received its latest determination letter on October 6, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The plan administrator has concluded that as of December 31, 2024 there were no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. There are currently no audits in progress for any tax periods. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### NOTE 9 - Trust Agreement

Effective January 1, 2015, Reliance Trust Company was appointed Trustee of the Plan. In accordance with the powers and duties of the Trustee as designated in the Trust Agreement, the Trustee invests the Plan's assets and the income therefrom for the benefit of the Plan participants. At the employer's discretion, Trustee fees may be paid from the Plan's assets.

### NOTE 10 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits and the statement of changes in net assets available for benefits.



