## **Note 1. Description of Plan**

The following description of the Access TeleCare 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

### ***General***

The Plan is a defined contribution plan covering substantially all employees who have reached the age of 18 of Access TeleCare, LLC and its wholly owned subsidiaries Tele-Physicians, P.C., JSA Health Corp and affiliated entities, Forefront Telecare, Inc., and Neurocall, Inc. (collectively “the Company”). Fidelity Management Trust Company serves as the trustee of the Plan at December 31, 2024 and 2023. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

### ***Contributions***

Participants may elect to defer a portion of compensation, as defined in by the Plan, subject to certain Internal Revenue Code (“IRC”) limitations. Participant salary deferrals may be traditional 401(k) (pre-tax) or Roth 401(k) (after-tax). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan is subject to a qualified automatic contribution arrangement (“QACA”), where automatic pre-tax deferrals are 2% of compensation for each payroll period, unless an affirmative election was made for another amount or to not participate.

Participants may contribute amounts representing distributions from other qualified plans and certain individual retirement accounts. The Company may provide discretionary match and nonelective contributions. The amount, if any, is determined each year by the Company. No such contributions were made for the year ended December 31, 2024. All contributions are subject to certain limitations.

### ***Investment Options***

Participants direct the investment of their accounts into various investment options offered by the Plan. The Plan currently offers mutual funds, a money market fund and common collective trust funds as investment options for participants.

### ***Participant Accounts***

Each participant’s account is credited with the participant’s contribution and allocations of the Company’s contributions and plan earnings, and charged with benefit payments, transaction fees related to notes receivable from participants and distributions, allocations of administrative expenses, and plan losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

### ***Vesting***

Participants are fully vested immediately in all deferral contributions and nonelective employer contributions plus actual earnings thereon.

Effective January 1, 2024, participants hired after January 1, 2024, vest in the Company’s discretionary matching contributions plus earnings thereon based on years of continuous service. A participant is 100% vested upon completion of 3 years of service. Participants hired prior to January 1, 2024, vest immediately in the Company’s discretionary matching contributions and earnings thereon.

***Notes Receivable from Participants***

Participants may borrow from their fund accounts so long as the loan does not exceed the participant's vested interest in the Plan. The loans bear a reasonable rate of interest and are adequately secured.

At December 31, 2024, outstanding loans bore annual interest at a range of 4.25% to 9.5%. Principal and interest are paid ratably through payroll deductions.

***Payment of Benefits***

On termination of service, retirement, disability, or death, a participant or their beneficiary may elect to receive an amount equal to the value of the participant's vested interest in his or her account. Participants may withdraw certain amounts under the hardship provisions as defined by the Plan. Distribution of benefits upon death shall be paid to the participant's beneficiary in one lump-sum payment. In-service distributions are also permitted for participants aged 59 ½.

***Forfeitures***

Prior to the January 1, 2024 amendment to change the vesting schedule, participant accounts were 100% vested at all times. Forfeited amounts are to be used to reduce the contribution of the Company or used to pay any administrative expenses of the Plan. No forfeited amounts were used to reduce the Company contributions or pay plan expenses. At December 31, 2024 and 2023, forfeited nonvested accounts were \$725 and \$179, respectively.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

***Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates and assumptions.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus accrued interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

***Payment of Benefits***

Benefits are recorded upon distribution.

***Administrative Expenses***

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the plan document. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. Expenses relating to specific participant transactions are charged directly to the participant's account.

***Subsequent Events***

The Plan has evaluated subsequent events through October 1, 2025, the date the financial statements were available to be issued.

**Note 3. Fair Value Measurements**

Fair value, as defined under GAAP, is an exit price representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1** Observable inputs such as quoted prices in active markets.
- Level 2** Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3** Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The following is a description of the valuation methodology used for assets measured at fair value:

***Mutual and Money Market Funds***

Mutual and money market funds are publicly traded investments and are valued daily at the closing price reported on the active market on which the funds are traded.

***Common Collective Trust Funds***

The Plan invests in a common collective trust funds for which quoted prices are not available in active markets for identical instruments. The Plan utilizes the net asset value (NAV) provided by the trustee as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust fund, the issuer reserves the right to require 12 or 30 months notification in order to ensure that securities liquidations will be carried out in an orderly business manner. The collective trust fund is not required to be classified within a level on the fair value hierarchy.

Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **Note 4. Certification by Plan Custodians**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, is a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedules is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income on notes receivable from participants as shown in the statements of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedules.

#### **Note 5. Exempt Party-in-Interest Transactions**

Fidelity is the trustee of the plan. Transactions with the trustee qualify as party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Fees paid directly to investment advisors and the third-party administrator for investment and administrative services were \$47,031 during 2024.

#### **Note 6. Transfer of Plan Assets**

On September 1, 2022, the Company acquired Forefront Telecare and approved an updated adoption agreement effective January 1, 2024 to merge the Forefront Telecare, Inc. 401(k) Plan & Trust into the Plan. An aggregate of \$1,797,289 was transferred into the Plan. The transfer consisted \$1,664,170 of investments and \$133,119 of participant and employer receivables due to the plan at December 31, 2023. The receivables were contributed to the Plan in 2024.

#### **Note 7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their accounts.

## **Note 8. Tax Status**

The Plan has not obtained a determination letter from the Internal Revenue Service (“IRS”) stating that the Plan was in compliance with the applicable requirements of the IRC. The Plan is relying on the IRS approval of the non-standardized prototype document that it is utilizing. The IRS has determined and informed the document sponsor by a letter dated June 30, 2020 that the prototype plan document was designed in accordance with applicable sections of the IRC. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC. Therefore, the plan administrator believes that the Plan was qualified, and the related trust was tax exempt as of the financial statement date.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **Note 9. Nonexempt Transactions**

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer’s general assets, but no later than the 15th business day of the month following the month in which the participant contributions are withheld by the employer. While the Company remitted all employee contributions to the Plan, contributions of \$134,283 were not remitted within the required time period by the merged in plan of which, \$59,773 were corrected in the current year.

## **Note 10. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.
