## INDEPENDENT AUDITOR'S REPORT

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Beverly Farm Foundation 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Beverly Farm Foundation 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements of information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024, and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section---

- the amounts and disclosures in the financial statements, referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material aspects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Beverly Farm Foundation 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. ## **Responsibilities of Management for the Financial Statements**

Management's election of the ERISA Section 103(a)(3)(c) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Beverly Farm Foundation 401(k) Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

NOTE 1. DESCRIPTION OF PLAN

The following description of the Beverly Farm Foundation 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution savings and profit sharing plan established by Beverly Farm Foundation (the Company) covering all employees of the Company who have completed one hour of service within the 90 day time period following their date of hire. Leased employees are excluded from participation in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

All Company contributions are discretionary, including the Company match. The discretionary match contribution is equal to a uniform percentage or dollar amount of the participant's deferral. Participants may contribute from 1% to 100% of pretax annual compensation, as defined in the Plan. The total deferral in any taxable year may not exceed a dollar limit which is set by law. This limit is \$23,000 and \$22,500 for 2024 and 2023, respectively. Participants who have attained age 50 before the end of the Plan year are eligible to make an additional catch-up contribution. The maximum allowable catch-up contribution is \$7,500 for 2024 and 2023, respectively.

Participant Accounts

Each participant's account is credited with the participant's contribution and the Company's contribution. The Company's matching contribution uses an allocation formula based on participants' deferrals. The profit sharing contribution uses an allocation formula based on participants' compensation. Participant accounts are also credited or charged for earnings or losses on the Plan's investments.

Investments

Participants may direct contributions, including any Company contributions, into any combination of investment funds. Participants may change their investment elections at any time.

Notes Receivable from Participants

Participants may be eligible to borrow from their salary deferral account under the loan provisions of the Plan. There is a \$1,000 minimum loan that may be requested, but no more than 50% of the participant's vested account balance up to \$50,000 may be borrowed. The notes are secured by the balance in the participant's account and bear a fixed rate of interest of 1% above the prime interest rate as published in the Wall Street Journal. Principal and interest is paid ratably through monthly payroll deductions.

Plan Administration

The Plan is governed by the Company's Board of Directors. Alerus Financial serves as the record keeper and asset custodian.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contribution portion of their accounts plus actual earnings thereon is as follows:

Payment of Benefits

On termination of service, a participant may elect to receive the value of their vested interest in their account in either a lump-sum or installment payments. If vested account balance exceeds \$5,000, then participant consent is required to distribute or the participant may elect to postpone distribution. If vested account balance does not exceed \$5,000, participant consent is not required.

Forfeited Accounts

Forfeited accounts may be used to reduce the Plan's ordinary and necessary administrative expenses for the Plan year. Any remaining forfeitures attributable to discretionary profit sharing contributions made by the Company will be used to reduce any future discretionary contributions made by the Company. Any remaining forfeitures attributable to matching contributions made by the Company will be used to reduce future matching contributions made by the Company. During 2024 and 2023, forfeited nonvested accounts totaled \$11,811 and \$7,864, respectively. In 2024 and 2023, forfeited nonvested accounts reduced administrative expenses by \$6,746 and \$6,007, respectively.

Administrative Expenses

Certain administrative fees including an asset management fee and participant recordkeeping fee are allocated to the participants of the Plan. Other administrative costs such as the audit fee are paid by the Plan Sponsor.

NOTE 2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The accounts of the Plan are maintained on the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Note Receivable from Participants

Participant loans are valued at their outstanding balances, which approximate fair value.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Reclassifications

Reclassifications, if any, are made to the prior year's financial statement presentation to correspond to the current year's format. Total net assets available for benefits and net increase (decrease) during the year are unchanged due to these reclassifications.

NOTE 3. CERTIFIED INVESTMENTS

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments and interest and dividends for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Alerus Financial, N.A. (the asset custodian of the Plan).

NOTE 4. FAIR VALUE MEASUREMENT

FASB Accounting Standards Codification 820, Fair Value Measurement and Disclosure, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority with Level 3 inputs having the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

The investments in collective trusts are valued as a practical expedient utilizing the net asset valuation, exclusive of the adjustment to contract value. The use of net asset value as fair value is deemed appropriate as the collective trusts do not have a finite life, unfunded commitments relating to these types of investments, or significant restrictions on redemptions. The practical expedient is used for valuation, unless it is probable that the Fund will see a portion of the investment at an amount different from the net asset valuation.

Collective Trusts

The plan invests in one collective trust that holds various assets at different levels of volatility:

Federated Hermes Capital Preservation Fund – The fund's investment objective is to seek stability of principal and current income. This fund typically invests in stable value products, including traditional and synthetic guaranteed investment contracts (GICs) and money market instruments.

NOTE 5. INCOME TAX STATUS

The IRS has determined and informed the plan sponsor by a letter dated June 30, 2020 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC).

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes the open tax years are those years ended December 31, 2021 through December 31, 2024.

NOTE 6. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 7. TERMINATION

The Company reserves the right to terminate the Plan, in whole or in part, at any time. Upon termination of the Plan, all amounts credited to participant accounts would become 100% vested.

NOTE 8. PARTY-IN-INTEREST TRANSACTIONS

Fees paid by the Plan for asset management services amounted to \$22,323 and \$21,702 for the years ended December 31, 2024, and 2023. Fees paid by the Plan for recordkeeping services amounted to \$5,817 and \$4,230 for the years ended December 31, 2024, and 2023, respectively.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 9. SUBSEQUENT EVENTS

Plan management has evaluated subsequent events through September 29, 2025. From this evaluation, no events were identified that met the requirement for disclosure.
