To the Plan Administrator
Stratus Team Plan 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit on the 2024 Financial Statement

We have performed an audit of the financial statements of Stratus Team Plan 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of change in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion on the 2024 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section –

- the information in the accompanying 2024 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion of the 2024 Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

NOTE 1 — DESCRIPTION OF PLAN

The following description of the Stratus Team 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan adopted for the benefit of the employees of Stratus Team, LLC and adopting employers (collectively, the Company). All employees, other than leased employees, members of a collective bargaining unit, and temporary employees, who have 30 days of service and are twenty-one or older, are eligible to participate in the Plan. Employees may enter the Plan on the day of meeting the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Principal Trust Company is the trustee for the Plan and Principal Life Insurance Company (Principal Life) provides recordkeeping services. The Company is the plan administrator and has overall responsibility for the operation and administration of the Plan.

Effective January 1, 2024 the Plan was amended to add Synalovski Romanik Saye LLC as a participating employer to the Plan.

Contributions

Participants may contribute up to 100% of annual eligible compensation, as defined by the Plan, and designate a portion or all of their elective deferrals as pre-tax or Roth elective deferrals. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Company makes safe harbor matching contributions based on the employee elective contributions and compensation. The Company matched 100% of the first 3% of employee eligible compensation and 50% of the next 2% of employee eligible compensation contributed to the Plan. The Company may make discretionary matching contributions to the Plan. No discretionary contributions were made in 2024.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participants may also transfer funds to the Plan from other qualified retirement plans.

Investment Options

Participants elect investment accounts in which their contributions, as well as Company contributions, are invested. The investment account options comprise various degrees of risk and return.

NOTE 1 — DESCRIPTION OF PLAN (Continued)

Participant Accounts

Each participant's account is credited with the participant's contribution and employer matching contributions, as well as allocations and investment earnings based on their selected investments. Participant accounts may be charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions and in the safe harbor matching contributions plus earnings thereon. Vesting in the Company's discretionary contributions vests after six years of continuous service, as follows:

Notes Receivable From Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to \$50,000 or 50% of the participant's vested account balance, whichever is less. They are allowed a maximum of two outstanding notes. The loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates as determined quarterly by the Plan administrator. The loan interest is set at 1% above the prime rate, as defined. Principal and interest are paid ratably through monthly payroll deductions.

Payment of Benefits

On termination of service, death, disability or retirement, participants may elect to receive an amount equal to the value of the vested interest in their accounts in either a lump-sum amount or in installments, depending on the size of the participant's account balance at the time of termination.

In-service distributions are permitted from all accounts when a participant has attained age 59½. Distributions from after-tax and rollover accounts are permitted at any time. The Company may authorize certain withdrawals from a participant's account in the event of proven financial hardship. Hardship withdrawals are allowed from a participant's elective deferral accounts and are subject to specific statutory and regulatory requirements.

Forfeited Accounts

Forfeiture balances of terminated participants' nonvested accounts may be used to reduce Company contributions. There were no unallocated forfeitures at December 31, 2024 or 2023, respectively and no forfeitures utilized to reduce Company contributions in 2024.

NOTE 2 — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value, except for its benefit-responsive investment contract which is valued at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Contributions

Contributions from Plan participants and the associated Company matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Fees related to the administration of notes receivable from participants and benefit payments to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments. Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements.

Subsequent Events

Subsequent events were evaluated through October 14, 2025, which is the date the financial statements were available to be issued.

NOTE 3 — FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Mutual funds: Valued at the daily closing price reported by the fund, which is the quoted NAV of shares.

Pooled separate accounts: valued at the NAV of units of the fund, which is based on the estimated market value of the underlying investments less its liabilities.

NOTE 4 — GUARANTEED INVESTMENT CONTRACT

The Plan maintains a fully benefit-responsive guaranteed investment contract issued by Principal Life. Principal Life maintains the contributions in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measure for the guaranteed investment contract, as this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value as reported to the Plan by Principal Life, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer and is to no be less than 1%. Such interest rates are reviewed on a semiannual basis for resetting. The crediting interest rate at December 31, 2024 was 4.85%. Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) certain amendments to the plan documents (including complete or partial plan termination), (2) the aggregate amount of withdrawals by a participating employer and transfers by a participating employer during any 12 month period are limited to 35% of the participating employer's interest as of the date of such withdrawal or transfer.

NOTE 5 — CERTIFIED INFORMATION

Information related to investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, disclosed in the accompanying financial statements and supplemental schedules, was obtained or derived from data provided to the plan administrator and certified to as complete and accurate by Principal Trust Company, the trustee.

NOTE 6 — PARTY-IN-INTEREST TRANSACTIONS

Plan investments include pooled separate accounts and an insurance contract managed by Principal Trust Company and Principal Life. These transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments, as these are not direct payments by the Plan.

NOTE 7 — PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their company contributions.

NOTE 8 — TAX STATUS

As this Plan is a non-standardized pre-approved profit sharing plan, the Internal Revenue Service issued an advisory letter dated June 30, 2020, stating that while they do not issue a determination as to whether a specific employer's plan is qualified, any employer who adopts this Plan will be considered to have a plan qualified under code Section 401(a) provided all the terms are not more favorable for officers, owners, or highly compensated employees than for other employees. Management believes that the Plan is operating in compliance with all the terms provided in the non-standardized plan agreement.

The Plan is subject to examination by the Internal Revenue Service for the statutory period.

NOTE 9 — RISKS AND UNCERTAINTIES

The Plan invests in various types of investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

NOTE 10 — DELINQUENT CONTRIBUTIONS

During the years ended December 31, 2024 and 2023, the Company failed to remit certain employee contributions to the Plan totaling \$46,055 and \$3,447, respectively, within the amount of time prescribed by the Department of Labor.

NOTE 11 — SUBSEQUENT EVENTS

On July 1, 2025, the Plan was amended to add certain provisions provided by the CARES Act and SECURE Act.

The amendment also added Blue Ridge Environmental Consultants, P.A. as an adopting employer.
