Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

YEARS ENDED DECEMBER 31, 2024 AND 2023

NOTE 1 – DESCRIPTION OF THE PLAN:

The following description of The Rossi Group 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan, established on January 1, 1973 (as a profit sharing plan), covering substantially all employees of The Rossi Group, LLC and affiliated companies (collectively, the Company) who elect to participate, have completed six months of service and are age 18 or older. Employees become eligible to participate in the Plan on the first day of the quarter coinciding with or next following the date they meet the eligibility requirements. Employees covered by a collective bargaining agreement, non-resident aliens and any leased employees are excluded from participating in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan's Investment Committee determines the appropriateness of the Plan's investments, monitors investment performance, oversees governance of the Plan, and reports to the Plan's Board of Directors.

Participant Contributions and Investment Options:

Participants may voluntarily contribute a percentage of their pre-tax and post-tax annual eligible compensation up to the maximum deferral allowed by the Internal Revenue Code (the Code). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 1% of eligible compensation, as defined, increasing by 1% each year up to a maximum of 8%. Participants direct the investment of their accounts into various investment options offered by the Plan with various objectives and degrees of financial risk. The Plan currently offers various mutual funds and a money market fund as investment options for participants.

Employer Contributions:

The Company, in its sole discretion, determines the amount, if any, of the discretionary matching contributions to the Plan and when it will be made to the Plan. Discretionary matching contributions for the years ended December 31, 2024 and 2023 were equal to 100% of the first 2% of salary deferrals to all company participant groups. The Company may also make a discretionary profit sharing contribution. Participants must be employed on the last day of the Plan year in order to receive the discretionary profit sharing contribution. The Company did not make a discretionary profit sharing contribution for the years ended December 31, 2024 and 2023.

NOTE 1 – DESCRIPTION OF THE PLAN (CONTINUED):

Participant Accounts:

Each participant's account is credited with the participant's contribution and Company discretionary matching contributions, as well as an allocation of the Company's discretionary profit sharing contribution, if applicable. Participant accounts are also credited with investment earnings or losses and charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are immediately vested in their voluntary contributions and Company discretionary matching contributions, plus actual earnings thereon. Participants are vested in the Company's discretionary profit sharing contributions as follows:

Forfeitures:

Any non-vested portion of a participant's account balance shall be forfeited upon a severance from service, as defined. Forfeitures are used to reduce future employer contributions to the Plan or reduce Plan expenses. There were no forfeitures available as of December 31, 2024 and 2023 or any forfeitures used during the years ended December 31, 2024 and 2023.

Notes Receivable from Participants:

Participants may borrow from their account a minimum of \$1,000 up to a maximum of \$50,000, not to exceed 50% of the value of their vested interest in their account. Loans are evidenced by written promissory notes for the amount of the loan and are secured by the participant's vested account balance. Loan terms range from one to five years, unless such loan is for the purchase of a participant's primary residence. The loans bear interest at a rate of 1% over the prime interest rate, which is commensurate with local prevailing rates as determined by the plan administrator. Principal and interest is paid ratably through monthly payroll deductions. Each participant may not have more than one loan outstanding at any time. These loans are subject to certain restrictions as defined by the Plan and applicable restrictions under the Code.

NOTE 1 – DESCRIPTION OF THE PLAN (CONTINUED):

Payment of Benefits:

Upon termination of service due to death, disability, retirement or other reason (all as defined), a participant or beneficiary may elect to receive either a lump-sum amount equal to the value of participant's vested interest in his or her account, installments over a period not to extend beyond the life expectancy of the participant or beneficiary, or partial withdrawals of at least \$1,000. A partial withdrawal is required for participants or their beneficiaries who must receive required minimum distributions, as defined by the Code. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. The Plan also allows for in-service distributions of the participant's vested accounts upon reaching the age of 59 ½ or due to hardship, as defined by the Plan.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of Accounting:

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (US GAAP).

Use of Estimates:

The preparation of financial statements in conformity with US GAAP requires management of the Plan to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of income and expense during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition:

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by investment advisors and the trustee. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits:

Benefits are recorded when paid.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED):

Notes Receivable from Participants:

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as deemed distributions in accordance with the provisions of the Plan. Management has evaluated notes receivable from participants for collectability and has determined that no allowance is considered necessary at December 31, 2024 and 2023.

Administrative Expenses:

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Reclassifications:

Certain 2023 amounts have been reclassified to conform to the 2024 presentation. Such reclassifications had no material effect on the financial statements.

Subsequent Events:

Management has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

NOTE 3 – RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 4 – CERTIFIED INVESTMENTS:

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Capital Bank and Trust Company (the trustee of the Plan), a qualified institution.

NOTE 5 – FAIR VALUE MEASUREMENTS:

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants, as of the measurement date. Authoritative guidance establishes a hierarchy of valuation techniques based upon whether the inputs to those valuation techniques reflect assumptions other market participants would use based upon market data obtained from independent sources (also referred to as observable inputs).

The following summarizes the fair value hierarchy:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the assets or liabilities;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets' or liabilities' fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded, and therefore are classified as Level 1.

Money Market Fund: Valued at the closing market value of the shares held by the Plan. The money market fund held by the Plan is deemed to be actively traded, and is therefore classified as Level 1.

The Plan's investments are all classified as Level 1 as of December 31, 2024 and 2023 and totaled \$6,707,513 and \$5,641,235, respectively.

NOTE 5 – FAIR VALUE MEASUREMENTS (CONTINUED):

The Plan's policy is to recognize transfers into or out of Level 3 as of the date of the event or change in circumstances that cause the transfer. For the years ended December 31, 2024 and 2023, there were no transfers of investments into or out of Level 3, respectively.

NOTE 6 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS:

Certain investments in American Funds are shares of mutual funds and a money market fund managed by Capital Bank and Trust Company as the trustee of the Plan, as defined by the Plan, and therefore, these investments and transactions qualify as party-in-interest transactions. Notes receivable from participants are also party-in-interest transactions.

Capital Bank and Trust Company provides services to the Plan as the recordkeeper and trustee; therefore, these services and transactions qualify as exempt party-in-interest transactions.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 7 – PLAN TERMINATION:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts, including any employer contributions.

NOTE 8 – TAX STATUS:

The Plan is being operated under a regional prototype non-standardized profit-sharing plan and trust agreement, which received an Internal Revenue Service (IRS) opinion letter, most recently amended June 30, 2020, stating that the form of the prototype is acceptable under Section 401(a) of the Code. Although the Plan has been amended since receiving its opinion letter, the plan administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

US GAAP requires the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE 9 – RECONCILIATION TO FORM 5500:

The differences between these financial statements and the Form 5500, if any, are immaterial.
