### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the financial statements of Faurecia USA Holdings, Inc. Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. ### Note 1 - Plan Description

The following description of Faurecia USA Holdings, Inc. Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan established by Faurecia USA Holdings, Inc. (the "Company," the "Plan Sponsor," or Faurecia). The Plan was established in January 1994 for all salaried employees. Employees are eligible to participate in the Plan after attaining age 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

The Plan provides for employee pretax and Roth salary deferral contributions up to a maximum of 75 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. The Plan also allows participants to contribute up to 75 percent of their compensation on an after-tax basis. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Plan provides for safe harbor matching contributions equal to 100 percent of the first 3 percent of the participant's compensation and 50 percent of the second 3 percent of the participant's compensation.

The Plan also allows for the Company to make discretionary contributions on an annual basis. In 2024, there were no discretionary contributions made to the Plan.

New employees of the Company are automatically enrolled in the Plan at a deferral rate of 6 percent. However, the Plan permits participants to opt out of contributing to the Plan or to contribute at a different rate than the initial 6 percent.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

#### **Vesting**

Participants are immediately 100 percent vested in deferred salary, rollover contributions, and safe harbor matching contributions and any income or loss thereon. Vesting in the Company's discretionary contribution portion of their accounts, as further defined below, plus actual earnings thereon, is based on years of service. Participants are considered to have completed one year of service for the purpose of vesting upon the completion of 1,000 hours of service at any time during the plan year.

All matching contributions made prior to January 1, 2020 for participants who were covered under the merged Clarion 401(k) Retirement & Savings Plan will retain the five-year graded vesting schedule, in which participants become 20 percent more vested upon each year of service, culminating in being 100 percent vested after five years of service.

All matching contributions made to participants who were covered under the merged SAS Automotive USA Inc. 401(k) Plan (SAS) will vest over a four-year graded schedule, in which participants become 25 percent more vested upon each year of service, culminating in being 100 percent vested after four years of service.

Participants are 100 percent vested in all other employer contributions.

**Note 1 - Plan Description (Continued)**

***Benefit Payments***

Distributions are payable upon retirement, death, disability, termination of employment, or reaching the age of 59½ in the form of a lump-sum amount equal to the vested balance of a participant's account. Faurecia SAS employees are allowed qualified reservist distributions.

Hardship withdrawals are available from all non-safe harbor contributions.

Distributions following termination are done in one of three ways for vested account balances. Distributions are subject to automatic rollover for those participants with vested account balances greater than \$1,000 up to a maximum of \$5,000. A participant whose vested account exceeds \$5,000 may elect a distribution in the form of a lump-sum amount or installments.

***Participant Notes Receivable***

Participants may borrow from their accounts, except for after-tax balances, subject to certain maximum and minimum amounts prescribed in the Plan and in the Internal Revenue Code. Notes receivable bear interest at a market rate.

***Forfeitures***

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan.

***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by Empower Trust Company, LLC (Empower Trust) and Empower Annuity Insurance Company (EAIC) (collectively, the "Custodians"). Empower Trust and EAIC are the custodians of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

***Termination***

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

**Note 2 - Summary of Significant Accounting Policies**

***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value.

The pooled separate accounts and commingled separate account are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying assets. All other investments are valued based on quoted market prices reported in active markets. See Note 4 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

***Benefit Payments***

Benefits are recorded when paid.

**Note 2 - Summary of Significant Accounting Policies (Continued)**

***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including October 8, 2025, which is the date the financial statements were available to be issued.

**Note 3 - Certified Information**

Empower Trust and EAIC hold the Plan's investments and participant notes receivable and execute all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Custodians.

**Note 4 - Fair Value Measurements**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

***Level 1***

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

***Level 2***

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly.

***Level 3***

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

**Note 6 - Plan Transfers**

During the year ended December 31, 2024, the Plan engaged in transfers of assets between investment options and/or affiliated plans. These transfers were executed in accordance with the provisions of the plan document and applicable regulatory requirements.
