Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Benevis 401(k) Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Notes to Financial Statements

Note 1. Description of Plan

The following description of the Benevis 401(k) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all employees of New Benevis, Inc. and participating employers, as defined in the Plan document (the Company or Plan Sponsor) who have completed 60 days of service and attained age 21. Employees are eligible to participate in the Plan on the first day of the month coincident with or following the date the age and service requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company and Principal Trust Company (Principal) determine the appropriateness of the Plan's investment offerings and monitor investment performance.

Contributions: Participants may elect to contribute from 1% to 100% of pretax or after-tax eligible compensation, as defined in the Plan document. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan also allows Company discretionary matching contributions for those who are active participants on the last day of the Plan year and have at least 1,000 hours of service during the Plan year. During 2024, the Company made discretionary matching contributions of 30% up to the first 5% of eligible compensation that participants contributed to the Plan. The match is calculated annually in accordance with the Plan document, and the Company funds the match contribution annually. The Company made discretionary matching contributions of \$1,307,989 for the year ended December 31, 2024. Contributions are subject to certain limitations under the Internal Revenue Code.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions are invested in a designated default investment fund until changed by the participant. The automatic enrollment feature is subject to automatic increases of 1% each year as of January 1 up to 6%.

Upon enrollment in the Plan, participants may direct both employee and employer contributions in 1% increments to any of the Plan's investment options. Participants may change their investment options daily.

Participant accounts: Each participant's account is credited with the participant's contributions, an allocation of Company matching contributions, and an allocation of Plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company contribution portion of their accounts plus actual earnings thereon is based on years of continuous service, as defined. Participants are also immediately vested upon reaching the normal retirement age of 65, or upon disability, or death while an active employee. Participants can accrue a vested interest in Company matching contributions in 33% increments per year of service and are 100% vested after three years of credited service.

Note 1. Description of Plan (Continued)

Forfeitures: At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$130,664 and \$266,636, respectively. Any balances in these accounts are used to reduce future Company contributions or pay Plan expenses. During the year ended December 31, 2024, \$214,363 of forfeitures were utilized to reduce the Company's contributions.

Payment of benefits: Upon termination of service, retirement, disability, or death, a participant may receive a lump-sum amount equal to the vested value of his or her account. Participants who are age 59½ or older may request an in-service distribution of their entire vested account balance and participants who experience proven financial hardship may request a withdrawal limited to all or any portion of the participant's deferral contributions account including any earnings thereon. Participants may withdraw their rollover contributions at any time. If a participant's vested account balance does not exceed \$1,000 at the time of termination, the Plan Sponsor will automatically distribute the balance in a lump-sum payment.

Notes receivable from participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note terms are for a period not exceeding five years unless for the purchase of a principal residence, which may not exceed 10 years. Participants are permitted to have only one note outstanding at any given time. Notes are collateralized by the participants' remaining vested account balance and bear interest at rates established by the Company (which are generally commensurate with the prime rate). Principal and interest are paid ratably through biweekly payroll deductions.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Common/collective trust fund: Investments in the common/collective trust fund (CCT) are required to be reported at fair value. The CCT, at the fund level, is composed primarily of fully benefit-responsive investment contracts held by the fund's trustee. These contracts are not considered fully benefit-responsive to the Plan as the underlying contracts are not direct investments between the Plan and the issuer. The statements of net assets available for benefits present the fair value of investment in the CCT. The statement of changes in net assets available for benefits is also prepared on the fair value basis. The Plan has elected to value the CCT using net asset value (NAV) as a practical expedient to determine fair value.

Investment valuation and income recognition: Investments held by the Plan are stated at fair value.. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). Mutual funds are valued at quoted market prices. See Note 4 for further discussion and disclosures related to fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Note 2. Summary of Significant Accounting Policies (Continued)

Payment of benefits: Benefits are recorded when paid.

Use of estimates: The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make note repayments and the Plan Administrator deems the participant note to be in default, the participant note balance is reduced and a benefit payment is recorded.

Subsequent events: The Plan has evaluated subsequent events through October 14, 2025, which is the date these financial statements were available to be issued. All subsequent events, if any, requiring recognition as of December 31, 2024, have been incorporated into these financial statements.

Note 3. Information Certified and Provided by the Trustee

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and supplemental schedules, that was prepared by or derived from information provided by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (Principal Trust Company) (Trustee) and furnished to the Plan Administrator. The Plan Administrator has obtained a certification from the trustee as of December 31, 2024 and 2023, and for the year ended December 31, 2024, that the information provided to the Plan Administrator by the Trustee related to the following assets and income is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the U.S. Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements and supplemental schedules related to the following assets

Note 4. Fair Value Measurements

Financial Accounting Standards Board Accounting Standards Codification (ASC) 820, Fair Value measurements and Disclosures, establishes a framework for measuring fair value. The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Shares of registered investment companies: Valued at the daily closing price, as reported by the fund. Shares held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Units of common/collective trusts: Valued at the NAV provided by the fund's trustee as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

Note 4. Fair Value Measurements (Continued)

Units of pooled separate accounts: Valued at the NAV of units of the pooled separate account. The NAV, as provided by the Trustee, is used as a practical expedient to estimating fair value. The NAV is based upon the fair value of the underlying investments comprising the pooled separate account. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The methodologies described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methodologies are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Changes in fair value levels: To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

The Plan evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no transfers in or out of Level 3.

Note 5. Related-Party Transactions

Certain Plan investments are shares of registered investment companies, a CCT fund, and pooled separate accounts managed by an affiliate of the trustee of the Plan. Principal Trust Company is the trustee as defined by the Plan and; therefore, these transactions qualify as party in interest transactions and are exempt from the prohibited transaction rules.

The Plan Sponsor pays certain investment and administrative expenses of the Plan. Total expenses paid to the Trustee and recordkeeper by the Plan for the year ended December 31, 2024, were \$370,652. In addition, certain administrative functions are performed by employees of the Plan Sponsor for which no compensation is received from the Plan.

Note 6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate risk, market risk and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 8. Tax Status

The Plan has adopted a pre-approved plan sponsored by Principal Life Insurance Company. The pre-approved plan provider has received an opinion letter from the Internal Revenue Service (IRS) as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by the Plan. The Plan Administrator believes that the Plan is designed and is currently operating in compliance with applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
