## INDEPENDENT AUDITOR'S REPORT

To the Plan Administration and Participants

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have audited the financial statements of The Bernick Companies Profit Sharing 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the Statement of Net Assets Available for Benefits as of December 31, 2024, and the related Statement of Changes in Net Assets Available for Benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure Under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and for the year then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. Management's election of the *ERISA* Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Accordingly, the objective of an *ERISA* Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

***Other Matter – Supplemental Schedule Required by ERISA***

The supplemental Schedule H – Line 4(i) – Schedule of Assets (Held End of Year) as of December 31, 2024 (the supplemental Schedule) on page 19, is presented for purposes of additional analysis and is not a required part of the financial statements, but is supplementary information required by the DOL’s *Rules and Regulations for Reporting and Disclosure Under ERISA*. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental Schedule, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental Schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

Their report dated October 8, 2024, indicated that in their opinion (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of *ERISA* Section 103(a)(3)(C). Their report also indicated that the form and content of the 2023 supplemental schedule, other than the information in the 2023 supplemental schedule

that agrees to or is derived from the certified investment information, were presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, and the information in the 2023 supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**NOTE 1 SUMMARY DESCRIPTION OF PLAN**

The following description of The Bernick Companies Profit Sharing 401(k) Plan (the Plan) provides only general information. For a more complete description of the Plan's provisions, refer to the agreement governing the Plan (the Plan Agreement).

General

The Plan is a defined contribution 401(k) plan under § 401(k) of the Internal Revenue Code (IRC) established by Chas. A. Bernick, Inc. (the Company) on January 1, 1982, to provide retirement benefits for eligible employees of the Company and all affiliated companies. The Plan currently provides benefits to the eligible employees of the following related companies: Chas. A. Bernick, Inc. and Rohlring of Duluth, Inc. (collectively Chas. A. Bernick, Inc.); Bernick's Pepsi-Cola of Duluth, Inc.; Bernick's Pepsi-Cola of Dresser, Inc.; The Bernick's Company; Bernick's Full Line Vending, Inc.; Bernick's Family Holding Company; and several acquired predecessor companies that are subsidiaries or affiliates under Bernick's Family Holding Company. The Plan is subject to the provisions of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure Under the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

After reaching 18 years of age and completing one year of service, employees meeting eligibility requirements for the Plan are automatically enrolled, unless they affirmatively elect otherwise. Participants are automatically enrolled at a contribution equal to 6 percent of their total compensation. Additionally, if each participant's deferred rate is below 8 percent, their deferral rate is automatically increased 1 percent each year until their deferral rate reaches 8 percent, unless the participant elects otherwise. Participants may contribute up to 90 percent of pretax annual compensation (100 percent in the case of cash bonuses), as defined by the Plan, up to the maximum amount allowed by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

Participants are permitted to designate a portion or all of their otherwise eligible deferral and rollover contributions as post-tax Roth contributions.

Employees become eligible for company matching contributions only if deferral contributions are made. The Company may make annual discretionary matching and nonelective contributions to participating employees in an amount to be determined by the Board of Directors of the Company (the Board) for each Plan year. The Board may designate all or a portion of any discretionary matching and/or nonelective contributions for a Plan year as "qualified matching and/or nonelective contributions" and allocate them to non-highly compensated employees to help the Plan pass one or more annually required IRC nondiscrimination test(s).

Participants direct the investment of their contributions and company matching contributions into various investment options offered by the Plan.

For the year ended December 31, 2024, the Company made discretionary matching contributions equal to 50 cents for every dollar contributed by participating employees, up to 8 percent of the employee's gross wage.

Participant Accounts

Each participant’s account is credited with the participant’s contribution, the Company’s qualified nonelective contributions, the Company’s discretionary matching and nonelective contributions, an allocation of plan earnings, and is charged with an allocation of administrative expenses. Allocations are based upon participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Notes Receivable – Participants

Participants may borrow from their accounts a minimum amount of \$1,000, up to a maximum amount equal to the lesser of \$50,000, or 50 percent, of their vested account balance. The maximum number of loans outstanding at any one time is one, unless more than one loan existed as of the date the Plan assets were transferred to Fidelity Management Trust Company of Boston, Massachusetts (Fidelity), the Directed Trustee of the Plan. Existing loans transferred to Fidelity shall continue under their existing terms. The loans are secured by the balance in the participant’s account and bear interest at rates mutually agreed upon based upon prevailing market rates, subject to applicable usury limits. Loans shall provide for level amortization, with payments to be made no less frequently than quarterly over a period not to exceed five years. If the loan was used to acquire the participant’s principal residence, payments may be extended to a period up to 10 years. Principal and interest are paid ratably through biweekly payroll deductions. Loans become immediately due and payable upon default, a participant’s termination of employment, death, or disability. A participant’s loan shall be considered in default at the end of the calendar quarter following a calendar quarter for which there is outstanding any part of any payment due (principal or interest).

Vesting

Participants are vested immediately in their 401(k) salary deferral contributions, rollover contributions, qualified matching company contributions, and qualified nonelective company contributions, plus actual earnings thereon.

Nonqualified company annual discretionary matching and nonelective contributions, plus actual earnings thereon, are subject to the vesting schedule below, except upon death or disability, at which time nonqualified company annual discretionary matching and nonelective company contributions, plus actual earnings thereon, are 100 percent vested:

Payments of Benefits

In the case of normal retirement, termination due to permanent disability or death, or termination of employment, a participant may elect to receive the value of their accumulated plan benefits, in accordance with the provisions of the Plan, in a lump sum distribution or in an alternative manner mutually agreed upon by the participant and the Administrative Committee. Certain mandatory distribution provisions apply to participant account balances of \$1,000 or less.

Forfeitures

Forfeitures represent the portion of a participant's account that is not vested at the time of distribution or on the last day of the Plan year in which the participant incurs five consecutive one-year breaks in service.

Any forfeitures occurring during the Plan year shall be applied to reduce contributions of the Company. Remaining forfeitures retained by the Plan may be used to pay administrative expenses if so directed by the Company. Any remaining forfeiture amounts will be used to reduce future company contributions payable under the Plan.

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$74,095 and \$11,178 , respectively. During the year ended December 31, 2024, the Company used \$9,078 of forfeited account balances to pay administrative expenses.

**NOTE 2      SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The Plan's financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements, in conformity with accounting principles generally accepted in the United States of America, requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, as stated by Fidelity as of December 31, 2024 and 2023. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Administrative Committee determines the Plan's valuation policies. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Realized gains and losses from security transactions are reported on the average cost method. Investment income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (or depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable – Participants

Notes receivable from participants are measured at their unpaid balance, plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account when incurred. The Plan estimates expected credit losses on Notes Receivable from Participants based on historical experience, current conditions, and reasonable and supportable forecasts. The Plan utilizes an aging analysis to determine the allowance for credit losses, considering the length of time the receivables have been outstanding and the likelihood of collection. The Plan's credit quality indicators include the participant's employment status and repayment history. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. The estimate of expected credit losses reflects the Plan's assessment of future economic conditions and their potential impact on participants' ability to repay their loans. If a participant does not make loan repayments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced and the delinquent participant note receivable is recorded as a benefit payment based on terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid, with the exception of corrective distributions, which are recorded annually at year-end.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and, therefore, are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to participants' accounts. Investment-related expenses may be included in the net appreciation (depreciation) in fair value of investments or are included within administrative expenses. Other administrative expenses may be paid out of the Plan's trust unless paid by the Company. Audit-related administrative expenses are paid by the Company (see Note 6).

Uncertain Tax Positions

The Plan follows recognition requirements for uncertain income tax positions as required by the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 740-10. Income tax benefits are recognized for income tax positions taken or expected to be taken in a tax return, only when it is determined that the income tax position will more-likely-than-not be sustained upon examination by taxing authorities. The Plan has analyzed tax positions taken for filing with the IRS, the DOL's Employee Benefits Security Administration, and the state jurisdiction where it operates. The Plan believes that income tax filing positions will be sustained upon examination and does not anticipate any adjustments that would result in a material adverse effect on the Plan's financial condition or results of operations.

Accordingly, the Plan has not recorded any reserves or related accruals for interest and penalties for uncertain income tax positions at December 31, 2024 and 2023.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any open tax periods.

Pending Accounting Pronouncements

From time to time new accounting pronouncements are issued by the FASB that are adopted by the Plan as of the specified effective date. If not discussed, management believes that the impact of recently issued standards, which are not yet effective, will not have a material impact on the Plan's financial statements upon adoption.

Subsequent Events

Subsequent events have been evaluated by management through October 14, 2025, which is the date the financial statements were available to be issued.

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the DOL's *Rules and Regulations for Reporting and Disclosure Under ERISA* for 2024 and 2023. Accordingly, Fidelity has certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, the related investment activity reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and the supplemental Schedule H – Line 4(i) – Schedule of Assets (Held at End of Year) as of December 31, 2024.

**NOTE 4 FAIR VALUE MEASUREMENTS**

The FASB ASC 820, *Fair Value Measurements and Disclosures* establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest level of priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820-10 are as described below:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical liabilities in active markets that the Plan has the ability to access.

Level 3	Inputs to the valuation methodology are unobservable and significant to the fair measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value or net asset value (NAV). There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Common/Collective Trusts** – Valued at the NAV of units of a bank common/collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the common/collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

**Registered Investment Companies** – Consist of mutual funds and are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the United States Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 6 RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain plan investments are shares of mutual funds managed by Fidelity, with investment advisory services provided by RBC Wealth Management, a division of RBC Capital Markets, LLC (RBC), an independent investment advisory firm. Fidelity is the Trustee defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Investment advisory services provided by RBC also qualify as party-in-interest transactions. Notes receivable from participants and transactions with the Plan Sponsor also qualify as party-in-interest transactions.

The Company pays for contract administration services provided by Fidelity, the third party administrator of the Plan. Certain fees incurred by the Plan for investment management services are included in the net appreciation (depreciation) in the fair value of the investment, as they are paid through revenue sharing, rather than direct payment. Other investment advisory services and recordkeeping services are recorded in administrative expenses. The Company provides certain accounting and administrative services to the Plan for which no fees are charged. The Company pays for audit services performed by an unrelated independent public accounting firm.

For the year ended December 31, 2024, the Plan incurred expenses totaling \$110,388 and \$114,932, to Fidelity and RBC, respectively.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of *ERISA*.

**NOTE 7     PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of *ERISA*. In the event of plan termination, participants would become 100 percent vested in their nonqualified company annual discretionary matching and nonelective contributions.

**NOTE 8     TAX STATUS**

The Plan relies on the prototype nonstandardized profit sharing plan established by Fidelity, which the IRS determined and informed Fidelity by a letter dated June 30, 2020, that the prototype plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

**NOTE 9     RISKS, UNCERTAINTIES, AND CONCENTRATIONS**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
