**NOTE A | DESCRIPTION OF PLAN**

The following description of R.W. Troxell & Company 401(k) Profit Sharing Plan, (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

*1. General*

R.W. Troxell & Company 401(k) Profit Sharing Plan is a defined contribution 401(k) plan covering all full-time employees of R.W. Troxell and Company, the Plan Sponsor (the Company), who are age 21 or older and have one month of service. Union employees, non-resident aliens, part-time employees, temporary employees and seasonal employees are excluded from eligibility. The Plan was adopted and began operations on January 1, 1977. The Plan was amended and restated effective January 1, 2022, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

*2. Contributions*

Four types of contributions can be made to the Plan.

Salary Deferral Contributions - Each year, participants may contribute up to the maximum dollar amount as determined by the Federal government of pre-tax annual compensation, as defined in the Plan document. The maximum deferral for 2024 and 2023 was \$ 23,000 and \$ 22,500, respectively. Participants who will be age 50 or older by the end of the year are eligible to make catch-up contributions of up to \$ 7,500 for each of the 2024 and 2023 plan years. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants can elect to make pre-tax or Roth deferrals. The Plan includes an automatic deferral feature whereby the Company automatically withholds 6% of compensation for eligible participants and contributes that amount as a pre-tax deferral until the participant makes a contrary election.

Employer Safe Harbor Matching Contributions - The Plan is a qualified automatic contribution arrangement 401(k) plan also known as "QACA". In order to maintain QACA safe harbor status, the Company makes a safe harbor matching contribution. Employees who are active participants at any time during the pay period are eligible for the employer safe harbor matching contribution. The Company will contribute to the Plan a matching contribution equal to 100% of the participant's salary deferral up to 2% of the participant's compensation and 50% of the participant's salary deferral ranging from 2.01% - 6% of the participant's compensation. Contributions are subject to certain Internal Revenue Code limitations.

*2. Contributions*

Discretionary Additional Matching Contributions - The Company has a right to make a discretionary additional matching contribution to the Plan. The discretionary additional matching contribution will not apply to elective deferrals exceeding 6% of the participant's compensation and may be subject to a limit of 4% of the employee's compensation. The Company made no discretionary additional matching contributions during 2024 and 2023.

Employer Nonelective Contributions - The Plan allows the Company to annually make a discretionary nonelective contribution to the Plan. The Company made no discretionary nonelective contributions during 2024 and 2023.

*3. Eligible Participants*

Effective January 1, 2023, employees are eligible to participate in the Plan on the first day of the month coinciding with or next following the date the employee satisfies the eligibility requirements. Prior to January 1, 2023, entry dates for eligible employees were the first day of the Plan year or the first day of the seventh month of the Plan year coinciding with or next following the date the employee satisfies the eligibility requirements. Participants are eligible for safe harbor matching contributions upon the attainment of age 21 and one year of service.

*4. Participant Accounts*

Each participant's account is credited with the participant's contributions and allocations of the Company's contribution and the Plan's earnings and is charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

5. *Vesting*

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s qualified safe harbor contribution, nonelective contribution, and additional matching contribution portion of their accounts plus actual earnings thereon is based on years of continuous service as follows:

Participants will always be 100% vested in the Company’s qualified safe harbor contribution, nonelective contribution, and additional matching contribution portion of their accounts plus actual earnings thereon if they are employed on or after their normal retirement age, if they terminate employment on account of their death, or if they terminate employment as a result of becoming disabled.

*6. Payment of Benefits*

On termination of service due to death, disability or retirement, a participant will receive an amount equal to the value of the participant's vested interest in their account in a lump sum or they may elect to receive in installments only if participant is subject to lifetime RMDs. In the event a participant's account does not exceed \$ 5,000, the Plan will distribute the account without consent, and if the balance exceeds \$ 1,000, the distribution will be directly rolled over to an IRA. Upon death, a participant's account is paid in a lump sum to the designated beneficiary. Under certain circumstances, participants may receive a hardship distribution.

*7. Forfeitures*

Forfeited balances of terminated participant's non-vested accounts can be used to reduce future Company contributions. The balances of the forfeiture account at December 31, 2024 and December 31, 2023 were \$ 11,532 and \$ 16,151, respectively. The Company applied \$ 20,456 and \$ 2,003 of forfeitures to contributions in years 2024 and 2023, respectively.

*8. Notes Receivable from Participants*

Participants may borrow from their participant account a maximum amount equal to the lesser of 50% of the participant's vested account balances or \$ 50,000. Participant loans made from the Plan generally have a term no longer than five years from the date of the loan. Loans may be repaid over more than five years only if funds were used in purchasing a principal residence. Participant loans are secured by the balance in the participants' accounts and bear interest at the prime rate plus 1%.

**NOTE B | SUMMARY OF ACCOUNTING POLICIES**

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements follows:

*1. Basis of Accounting*

The financial statements of the Plan are presented on the accrual basis of accounting.

**NOTE B | SUMMARY OF ACCOUNTING POLICIES**

2. *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

3. *Investment Valuation and Income Recognition*

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

4. *Payment of Benefits*

Benefit payments are recorded when paid.

5. *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

6. *Expenses*

Certain expenses of maintaining the Plan are paid for by the Company and are excluded from these financial statements. Distribution fees are charged directly to the participant's account and are included in administrative expenses. Certain investment related expenses are included in net appreciation (depreciation) of fair value of investments.

7. *Subsequent Events*

Management has evaluated subsequent events for recognition and disclosure in the financial statements through October 14, 2025, which is the date the financial statements were available to be issued. Through October 14, 2025, no subsequent events required recognition or disclosure in the financial statements.

**NOTE C | FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Valuation is based on quoted prices for identical assets and liabilities in active markets.

Level 2 - Valuation is derived from inputs, other than quoted prices included in Level 1, which are observable for the asset or liability either directly or indirectly. Investments classified as Level 2 are generally valued by benchmarking model-derived prices to quoted market prices and trade data for identical or comparable securities. The significant inputs needed in this approach include interest rates, prepayment timing, yield spreads, maturities, credit losses, and credit ratings of the securities.

Level 3 - Valuation is derived from unobservable inputs that are not corroborated by market data.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable relevant inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Interest-bearing cash is valued at cost which approximates fair value.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE C | FAIR VALUE MEASUREMENTS**

The collective trusts are valued at the NAV of units of the collective trusts. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the funds less liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions may occur daily. Were the Fund to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure the securities liquidations will be carried out in an orderly business manner.

**Fair Value of Investments that Calculate Net Asset Value**

During 2024, the Plan held units in the Core Plus Bond, International Equity and Large Cap Value Funds. These funds are Collective Trusts in which purchases and withdrawals are not made in an open market; instead, the purchases and withdrawals occur with the Trust, and in certain circumstances, those transactions are entirely controlled and/or restricted by the Trust. The fair value of these investments is determined by the management of the Trust and is reported to the Fund as the Fund's proportionate share of the net asset fair value of the entities. **NOTE E | PLAN TERMINATION**

Although the Company has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of partial or total Plan termination, participants will be entitled to the full amount in their accounts as of the date of termination.

**NOTE F | TAX STATUS**

The Company has adopted a non-standardized pre-approved profit sharing/money purchase/CODA Plan from BlueStar Retirement Services that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

The Plan files a Form 5500 return in the federal jurisdiction.

**NOTE G | RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Troxell Financial. The Plan has a fiduciary agreement with Fiduciary Consulting Group, Inc. as third-party administrator for the Plan. Ameritas Life Insurance Corporation is the Plan's recordkeeper. Charles Schwab Trust Bank is the custodian for the Plan and manages some of the assets held by the Plan. Transactions with these entities qualify as party-in-interest transactions.

**NOTE H | RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statement of net assets available for benefits.

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of R.W. Troxell & Company 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of R.W. ### Opinion

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. **NOTE A | DESCRIPTION OF PLAN**

The following description of R.W. Troxell & Company 401(k) Profit Sharing Plan, (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

*1. General*

R.W. Troxell & Company 401(k) Profit Sharing Plan is a defined contribution 401(k) plan covering all full-time employees of R.W. Troxell and Company, the Plan Sponsor (the Company), who are age 21 or older and have one month of service. Union employees, non-resident aliens, part-time employees, temporary employees and seasonal employees are excluded from eligibility. The Plan was adopted and began operations on January 1, 1977. The Plan was amended and restated effective January 1, 2022, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

*2. Contributions*

Four types of contributions can be made to the Plan.

Salary Deferral Contributions - Each year, participants may contribute up to the maximum dollar amount as determined by the Federal government of pre-tax annual compensation, as defined in the Plan document. The maximum deferral for 2024 and 2023 was \$ 23,000 and \$ 22,500, respectively. Participants who will be age 50 or older by the end of the year are eligible to make catch-up contributions of up to \$ 7,500 for each of the 2024 and 2023 plan years. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants can elect to make pre-tax or Roth deferrals. The Plan includes an automatic deferral feature whereby the Company automatically withholds 6% of compensation for eligible participants and contributes that amount as a pre-tax deferral until the participant makes a contrary election.

Employer Safe Harbor Matching Contributions - The Plan is a qualified automatic contribution arrangement 401(k) plan also known as "QACA". In order to maintain QACA safe harbor status, the Company makes a safe harbor matching contribution. Employees who are active participants at any time during the pay period are eligible for the employer safe harbor matching contribution. The Company will contribute to the Plan a matching contribution equal to 100% of the participant's salary deferral up to 2% of the participant's compensation and 50% of the participant's salary deferral ranging from 2.01% - 6% of the participant's compensation. Contributions are subject to certain Internal Revenue Code limitations.

*2. Contributions*

Discretionary Additional Matching Contributions - The Company has a right to make a discretionary additional matching contribution to the Plan. The discretionary additional matching contribution will not apply to elective deferrals exceeding 6% of the participant's compensation and may be subject to a limit of 4% of the employee's compensation. The Company made no discretionary additional matching contributions during 2024 and 2023.

Employer Nonelective Contributions - The Plan allows the Company to annually make a discretionary nonelective contribution to the Plan. The Company made no discretionary nonelective contributions during 2024 and 2023.

*3. Eligible Participants*

Effective January 1, 2023, employees are eligible to participate in the Plan on the first day of the month coinciding with or next following the date the employee satisfies the eligibility requirements. Prior to January 1, 2023, entry dates for eligible employees were the first day of the Plan year or the first day of the seventh month of the Plan year coinciding with or next following the date the employee satisfies the eligibility requirements. Participants are eligible for safe harbor matching contributions upon the attainment of age 21 and one year of service.

*4. Participant Accounts*

Each participant's account is credited with the participant's contributions and allocations of the Company's contribution and the Plan's earnings and is charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

5. *Vesting*

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's qualified safe harbor contribution, nonelective contribution, and additional matching contribution portion of their accounts plus actual earnings thereon is based on years of continuous service as follows:

Participants will always be 100% vested in the Company's qualified safe harbor contribution, nonelective contribution, and additional matching contribution portion of their accounts plus actual earnings thereon if they are employed on or after their normal retirement age, if they terminate employment on account of their death, or if they terminate employment as a result of becoming disabled.

*6. Payment of Benefits*

On termination of service due to death, disability or retirement, a participant will receive an amount equal to the value of the participant's vested interest in their account in a lump sum or they may elect to receive in installments only if participant is subject to lifetime RMDs. In the event a participant's account does not exceed \$ 5,000, the Plan will distribute the account without consent, and if the balance exceeds \$ 1,000, the distribution will be directly rolled over to an IRA. Upon death, a participant's account is paid in a lump sum to the designated beneficiary. Under certain circumstances, participants may receive a hardship distribution.

*7. Forfeitures*

Forfeited balances of terminated participant's non-vested accounts can be used to reduce future Company contributions. The balances of the forfeiture account at December 31, 2024 and December 31, 2023 were \$ 11,532 and \$ 16,151, respectively. The Company applied \$ 20,456 and \$ 2,003 of forfeitures to contributions in years 2024 and 2023, respectively.

*8. Notes Receivable from Participants*

Participants may borrow from their participant account a maximum amount equal to the lesser of 50% of the participant's vested account balances or \$ 50,000. Participant loans made from the Plan generally have a term no longer than five years from the date of the loan. Loans may be repaid over more than five years only if funds were used in purchasing a principal residence. Participant loans are secured by the balance in the participants' accounts and bear interest at the prime rate plus 1%.

**NOTE B | SUMMARY OF ACCOUNTING POLICIES**

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements follows:

*1. Basis of Accounting*

The financial statements of the Plan are presented on the accrual basis of accounting.

**NOTE B | SUMMARY OF ACCOUNTING POLICIES**

*2. Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

*3. Investment Valuation and Income Recognition*

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*4. Payment of Benefits*

Benefit payments are recorded when paid.

*5. Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

*6. Expenses*

Certain expenses of maintaining the Plan are paid for by the Company and are excluded from these financial statements. Distribution fees are charged directly to the participant's account and are included in administrative expenses. Certain investment related expenses are included in net appreciation (depreciation) of fair value of investments.

*7. Subsequent Events*

Management has evaluated subsequent events for recognition and disclosure in the financial statements through October 14, 2025, which is the date the financial statements were available to be issued. Through October 14, 2025, no subsequent events required recognition or disclosure in the financial statements.

**NOTE C | FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Valuation is based on quoted prices for identical assets and liabilities in active markets.

Level 2 - Valuation is derived from inputs, other than quoted prices included in Level 1, which are observable for the asset or liability either directly or indirectly. Investments classified as Level 2 are generally valued by benchmarking model-derived prices to quoted market prices and trade data for identical or comparable securities. The significant inputs needed in this approach include interest rates, prepayment timing, yield spreads, maturities, credit losses, and credit ratings of the securities.

Level 3 - Valuation is derived from unobservable inputs that are not corroborated by market data.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable relevant inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Interest-bearing cash is valued at cost which approximates fair value.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE C | FAIR VALUE MEASUREMENTS**

The collective trusts are valued at the NAV of units of the collective trusts. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the funds less liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions may occur daily. Were the Fund to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure the securities liquidations will be carried out in an orderly business manner.

**Fair Value of Investments that Calculate Net Asset Value**

During 2024, the Plan held units in the Core Plus Bond, International Equity and Large Cap Value Funds. These funds are Collective Trusts in which purchases and withdrawals are not made in an open market; instead, the purchases and withdrawals occur with the Trust, and in certain circumstances, those transactions are entirely controlled and/or restricted by the Trust. The fair value of these investments is determined by the management of the Trust and is reported to the Fund as the Fund's proportionate share of the net asset fair value of the entities. The table below provides information related to these types of investments. Additional information on these investments, which are direct filing entities, can be found by viewing its U.S. Department of Labor Form 5500. The Plan did not hold any Collective Trusts at December 31, 2023.

**NOTE E | PLAN TERMINATION**

Although the Company has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of partial or total Plan termination, participants will be entitled to the full amount in their accounts as of the date of termination.

**NOTE F | TAX STATUS**

The Company has adopted a non-standardized pre-approved profit sharing/money purchase/CODA Plan from BlueStar Retirement Services that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

The Plan files a Form 5500 return in the federal jurisdiction.

**NOTE G | RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Troxell Financial. The Plan has a fiduciary agreement with Fiduciary Consulting Group, Inc. as third-party administrator for the Plan. Ameritas Life Insurance Corporation is the Plan's recordkeeper. Charles Schwab Trust Bank is the custodian for the Plan and manages some of the assets held by the Plan. Transactions with these entities qualify as party-in-interest transactions.

**NOTE H | RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE I | CONCENTRATIONS OF CREDIT RISK**

The Plan maintains its cash balances at Charles Schwab Trust Bank. Cash balances are insured by the Federal Deposit Insurance Corporation (FDIC). Balances in these accounts routinely exceed the federally insured limit. The Plan has not experienced any losses on such accounts as of December 31, 2024, and through the date of this report.
