INDEPENDENT AUDITORS' REPORT

To the Participants and Plan Administrator of the
Looking Upwards, Inc. 401(k) Retirement Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Looking Upwards, Inc. 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the Statements of Net Assets Available for Plan Benefits as of December 31, 2024 and 2023, and the related Statement of Changes in Net Assets Available for Plan Benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements.

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of Plan

The following description of the Looking Upwards, Inc. 401(k) Retirement Plan (the Plan) is intended to provide only general information regarding the Plan. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General

The Plan is a participant-directed defined contribution 401(k) plan that covers substantially all full-time employees except leased employees of Looking Upwards, Inc. (the Organization or Employer) who are 21 years old or older and have completed 60 days of service. During 2024, the Plan adopted the required long-term part-time (LTPT) employees eligibility provision of the Setting Every Community Up for Retirement Enhancement Act of 2019 (SECURE Act), to provide that LTPT employees who have attained the age of 21 are eligible to participate in the Plan for purposes of making employee deferral contributions if they worked 500 or more hours during the last three consecutive years. The Plan also covers certain employees who work less than 35 hours a week and have completed one year of service. The Organization serves as the Plan administrator and Ascensus Trust Company serves as the Plan’s trustee. Effective January 1, 2024, highly compensated employees are excluded from participating in the Plan. The Plan was established on January 1, 1985 and restated on January 1, 2022, under Sections 401(a) and 401(k) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may elect to contribute any percentage of their annual pretax compensation, not to exceed annual limitations as provided by the IRC. The Plan allows for Roth contribution deferrals. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions up to annual limits provided by the IRC. Participants may also make rollover contributions from other qualified retirement plans.

Effective January 1, 2025, the Plan adopted a provision of the Setting Every Community Up for Retirement Enhancement Act of 2022 (SECURE) Act 2.0, allowing certain eligible participants to make increased catch-up elective deferrals, referred to as “super catch-up” contributions. Under this provision, the maximum catch-up deferral amount for participants between the ages of 60 and 63 increased from \$7,500 to \$11,250.

The Plan provides for the Organization to make discretionary matching contributions and discretionary profit-sharing contributions. To be eligible to receive the discretionary profit-sharing contribution, an employee must have worked a minimum of 1,000 hours and must be employed on the last day of the Plan year except upon death, disability, or early retirement. For the year ended December 31, 2024, no discretionary profit-sharing contribution was made. Contributions are limited in accordance with the Internal Revenue Service (IRS) rules and regulations.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Organization's matching contribution, if any, an allocation of the Organization's profit-sharing contribution, if any, Plan earnings and losses and any administrative expenses incurred. Allocations are based on individual participant account balances or participant compensation, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants become fully vested in the Employer contributions and the annual allocation of Plan earnings on those contributions after six years of service, or if a participant reaches early retirement age as an employee, dies or becomes disabled before retirement. Participants are partially vested in the Employer contributions as follows: 20% after 2 years, 40% after 3 years, 60% after 4 years, 80% after 5 years, and 100% after 6 years.

Participant Notes Receivable

Participants may borrow from their fund account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Note terms range from 1 to 5 years, or up to 15 years for the purchase of a primary residence and only one loan can be outstanding at a time. The notes are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

On retirement, death, or termination of service, a participant or beneficiary may elect to receive an amount equal to the vested value of the participant's account as a lump-sum amount. Alternatively, in certain cases, the participant may elect to defer the distribution. The Plan provides for mandatory distributions to participants upon reaching age 73 or participants who separate from service with account balances less than \$7,000 (increased from \$5,000 effective January 1, 2024).

Early Withdrawals

Participants, by written notice, may request a financial hardship withdrawal from their vested accounts, subject to the limitations imposed by the IRC. Participants who have attained normal retirement age, as defined by the Plan, may elect to withdraw all or a portion of their accounts.

Effective January 1, 2023, the Plan adopted the provision of the SECURE Act 2.0 to permit self-certification of financial hardship withdrawals.

Forfeitures

Participants in the Plan who leave the employment of the Organization before completing six years of service forfeit the non-vested portion of their accounts. Forfeitures are used to reduce Employer contributions or pay administrative expenses related to the Plan or may be reallocated to employees as a profit sharing contribution. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$1,246 and \$1,211, respectively. During 2024 and 2023, no forfeitures were used to reduce Employer contributions or pay administrative expenses or reallocated to participants.

Subsequent Events

Management has evaluated subsequent events through October 7, 2025, which is the date these financial statements were available to be issued.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Valuation of Investments and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (Note 3). The Plan Administrator determines the Plan's valuation policies, utilizing information provided by the investment advisor and Reliance Trust for the collective investment trust fund trustee.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded at the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Participant Notes Receivable

Participant notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Interest income on participant notes receivable is recorded when it is earned. A receivable is considered past due if payment has not been received within stated terms. Delinquent participant notes receivable are reclassified as distributions based on terms of the Plan document.

Contributions

Participant contributions are recorded bi-weekly when the Organization remits payroll deductions for investment into the Plan. Discretionary matching and profit sharing contributions are recorded at the end of the year, if applicable.

Payment of Benefits

Benefits are recognized when paid to participants or their designated beneficiaries.

Administrative Expenses

Expenses incurred in the administration of the Plan are paid by the Organization unless the Organization directs that such expenses be paid by the Plan. Expenses that are paid by the Organization are excluded from these financial statements. Participant notes receivable set-up and maintenance fees and distribution processing fees are paid directly by the participants through a reduction in their account and are not included in administrative expenses. Investment management, recordkeeping, education and training and other third-party advisor fees are paid by the Plan through revenue sharing as a reduction of investment income (net appreciation or depreciation) from the related investment fund.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets, liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported changes in net assets. Accordingly, actual results may differ from those estimates.

Risks and Uncertainties

The Plan provides for various investment options with various investment objectives. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits.

The Plan invested in three mutual funds that accounted for approximately 57% and 58% of total Plan investments as of December 31, 2024 and 2023, respectively.

Financial Instruments with a Concentration of Credit Risk

The Plan's investments are held by a single trustee. The Plan's exposure to credit risk is associated with the outside entity's non-performance of its fiduciary responsibilities relating to these amounts as specified in the agreements. Benefits provided by the Plan are not insured or guaranteed by the Pension Benefit Guaranty Corporation.

3. Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives highest priority to unadjusted quoted prices in active markets for identical assets (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy and inputs to the valuation methodologies are described as follows:

Level 1 inputs are unadjusted quoted prices in active markets for identical assets the Plan has the ability to access.

Level 2 inputs are other than quoted prices in active markets that are observable either directly or indirectly for the asset. Such inputs are derived principally from or corroborated by observable market data for similar assets by correlation or other means, over substantially the full contractual term of the asset, if applicable.

Level 3 inputs are unobservable and significant to the fair value measurement. Such inputs generally rely on the Plan's own assumptions about the assumptions that market participants would use in pricing the asset.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis:

Cash and Cash Equivalents: The carrying amounts of cash and cash equivalents are deemed to be valued at the deposit amount plus accrued interest, as determined according to stated terms.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Investment Trust: The Plan invests in the Reliance Trust Company Collective Investment Trust for the Metlife Group Annuity Contract Series 25053 Class 0. It is valued at the NAV of units of a collective trust. The NAV, as provided by the fund manager, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily; redemption notice is not required.

Were the Plan to initiate a full redemption of the collective trust, the trust reserves the right to temporarily delay withdrawals in order to ensure that liquidations of securities will be carried out in an orderly business manner. Unit values are determined by dividing the fund's net assets at fair value by its units outstanding at the valuation dates.

As of December 31, 2024 and 2023, the Plan's investments in mutual funds are reported at level 1 within the fair value hierarchy.

4. Plan Termination

The Organization expects to continue the Plan indefinitely. However, the Organization reserves the right to amend the Plan or contributions thereto, at any time and in any manner that it deems advisable, provided that no amendment shall have the effect of diverting Plan assets for purposes other than for the exclusive benefit of the Plan participants and any Plan termination would be subject to the provisions of ERISA. If the Plan is terminated, the participants would become fully vested and entitled to receive all amounts credited to their accounts.

5. Income Tax Status

The Plan is a non-standardized pre-approved profit sharing plan sponsored by The Angell Pension Group, Inc. (Angell). Angell has obtained an opinion letter dated June 30, 2020, stating that the form of the Plan is acceptable under Section 401 of the IRC. Generally, the Plan Administrator and the Plan may rely on the opinion letter received by Angell as to the form of the Plan qualifying under the IRC. The Plan has been amended since the letter was obtained. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Therefore, the Plan Administrator believes the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Summary of Financial Data Certified by the Trustee's Agent

The following is a summary of financial information and data certified by the trustee's agent, Ascensus, LLC as an agent for Ascensus Trust Company:

7. Differences from Form 5500

Differences between the Annual Return/Report of Employee Benefit Plan, Form 5500, and these financial statements are a result of different classifications between line items. Total Plan assets are in agreement.

8. Related Party Transactions and Party-in-Interest Transactions

Certain Plan investments are held by the trustee's agent, Ascensus Trust, LLC, and recordkeeping administrative services are provided by The Vanguard Group, Inc. Therefore, these transactions qualify as party-in-interest transactions. For the year ended December 31, 2024, the Plan made direct payments to service providers for investment management and recordkeeping services of approximately \$56,150.

9. Non-exempt Transactions

During 2024, the Employer failed to remit participant contributions and loan repayments of \$24,824 and \$2,417, respectively, to the Plan on a timely basis as prescribed in the applicable Department of Labor Regulations 29 CFR 2510.3-102. Defined contribution plans must remit employee contributions to the Plan as soon as they can be reasonably segregated from the Employer's general assets, but no later than the 15th business day of the month following the month in which the participant contributions are withheld or received by the Employer.

During 2024, the Employer remitted untimely participant contributions and loan repayments of \$27,241, due to the Plan for the year ended December 31, 2024. The Employer is currently working with its third-party administrator to calculate and remit any lost earnings associated with these late remittances.
