Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following description of the Silver Lake Specialized Rehabilitation and Care Center 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all eligible employees of Silver Lake Specialized Rehabilitation and Care Center (the "Plan Sponsor", "Company", or "Employer"). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Eligibility

All employees of the Plan Sponsor who are at least 21 years of age and have completed at least one year of service, are eligible to participate in the Plan. Employees can enter the plan on the first day of the Plan year or on the first day of the seventh month of the Plan year coinciding with satisfaction of the eligibility requirements. An employee is not eligible to participate if they are a leased employee or a union employee whose employment is governed by a collective bargaining agreement, except Charge Nurses; who are eligible to participate.

Contributions

Participants may contribute up to 100% of their gross compensation, as defined by the Plan, on a pre-tax or after-tax "Roth" basis, subject to Internal Revenue Code ("IRC") limitations. Participants who are at least age 50 may make an additional "catch-up" contribution subject to IRC limitations. Participants may also contribute funds from another qualified retirement plan ("rollover contributions"), subject to certain requirements.

Participants receive a 3% safe harbor non-elective contribution. For the Plan years ended December 31, 2024 and 2023, the Company contributed safe harbor non-elective contributions of \$188,135 and \$176,020, respectively.

In addition, the Company may make a discretionary profit-sharing contribution to participants who have completed one year of service during the Plan year and are employed on the last day of the Plan year. No discretionary profit-sharing contributions were made during 2024 and 2023.

Participant Accounts

Each participant's account is credited or charged with contributions, investment income (loss), and administrative expenses. Each participant's account is credited with the participant's proportional allocation of the Plan's earnings, including unrealized gains and losses, and administrative expenses. For participant directed investments, participants determine the percentage in which contributions are to be invested in each fund. Participants may change their investment options as set forth in the plan document.

1. DESCRIPTION OF PLAN (Continued)

Notes Receivable from Participants

Loans may be made from the Plan only to the extent the participant has vested funds in the Plan. Eligible participants may borrow funds, up to 50% of their vested Plan assets or \$50,000. Each participant is limited to one loan with a loan minimum of \$1,000. Loans must generally be repaid over a period no longer than five years.

Vesting

Participants are fully vested in that portion of their account which represents their voluntary contributions, the Company's safe harbor contributions and the earnings and losses thereon. Participants become 100% vested in the Company's discretionary profit-sharing contributions, and earnings and losses thereon upon death, total and permanent disability, or attainment of normal retirement age. Otherwise, a participant's interest in the Company's discretionary profit-sharing contributions, and earnings and losses thereon vest according to the following schedule:

Forfeitures

When certain terminations of participation in the Plan occur, the nonvested portion of a participant's account represents a forfeiture, as defined by the Plan. If a forfeiting participant is re-employed and fulfills certain requirements, as set forth in the Plan, the participant's account will be restored. Remaining forfeitures will be used to pay qualified Plan expenses, reduce employer contributions to the Plan or be allocated to participants. Unallocated forfeitures for participant directed investments available to reduce Plan expenses or employer contributions at December 31, 2024 and 2023 totaled \$9,884 and \$7,534, respectively. No forfeitures were used to pay qualified Plan expenses or reduce employer contributions during the years ended December 31, 2024 and 2023.

Distribution of Benefits

The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Benefits may be distributed to participants upon termination of employment by reason of retirement, disability, death, or other separation from service. Distributions will be made in the form of a lump sum payment.

A participant may also request a withdrawal upon attainment of age 59 1/2 or upon demonstration by the participant to the Plan administrator that the participant is suffering from "hardship". Hardship is defined in applicable regulations promulgated or to be promulgated pursuant to Section 401(k) of the Internal Revenue Code or standards established by the Secretary of the Treasury or their delegate. Participants requesting an in-service distribution may not receive more than one distribution during the year and the distribution cannot be less than \$5,000, unless the participant's entire account balance is less than \$5,000. Participants may request a withdrawal from their rollover funds at any time.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the financial statements and disclosure of contingent assets and liabilities at the date of the financial statements. Estimates also affect the reported amounts of revenue and expenses during the reporting period. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

In accordance with U.S. GAAP, fixed annuity contracts held by a defined-contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses

Substantially all expenses incurred in the administration of the Plan are paid by the Company. Certain investment fees and participant transaction fees are paid through the Plan.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks such as interest rate, credit risks and overall market volatility. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document. The Plan has determined an allowance for credit losses from participants is unnecessary at December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Allowance for Credit Losses

The Plan records a receivable for the employer contribution that is remitted to the Plan subsequent to the Plan's year-end. The Plan considers an expected allowance for credit losses that is updated to reflect any changes in credit risk since the receivable was initially recorded. The estimated allowance for credit losses is based on historical, current, and expected future conditions. The Plan has not experienced any historical credit losses relative to contributions receivable and future economic conditions are not expected to change relative to historical financial information, therefore management has determined that no allowance for credit losses is necessary as of December 31, 2024 and 2023.

Fair Value Measurements

The Plan has financial instruments which are recorded at fair value in the statements of net assets available for benefits. The Plan makes estimates regarding the valuation of assets measured at fair value in the financial statements. These assets include the investments in pooled separate accounts.

Fair Value Measurement - Definition and Hierarchy

U.S. GAAP defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The Plan uses various valuation techniques in determining fair value. U.S. GAAP establishes a hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the observable inputs be used when available. Observable inputs are inputs that market participants would use in pricing the asset or liability developed based on market data obtained from sources independent of the Plan. Unobservable inputs are inputs that reflect the Plan's assumptions about the assumptions market participants would use in pricing the asset or liability, developed based on the best information available in the circumstances. The hierarchy is broken down into three levels based on the reliability of inputs as follows:

- Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Valuation adjustments are not applied to Level 1 instruments. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation of these products does not entail a significant degree of judgment.
- Level 2 - Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly, or indirectly.
- Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

The availability of observable inputs can vary and is affected by a wide variety of factors. To the extent that valuation is based on models or inputs that are less observable or unobservable in the market, the determination of fair value requires more judgment. Accordingly, the degree of judgment exercised by the Plan in determining fair value is greatest for instruments categorized in Level 3. In certain cases, the inputs used to measure fair value may fall into different levels of the fair value hierarchy. In such cases, for disclosure purposes the level in the fair value hierarchy within which the fair value measurement in its entirety falls is determined based on the lowest level input that is significant to the fair value measurement in its entirety. A description of where the Plan's investments fall within the fair value hierarchy is provided in Note 3. There were no changes in valuation methodologies during the years ended December 31, 2024 and 2023.

3. FAIR VALUE MEASUREMENTS

The Plan's pooled separate accounts are measured at fair value on a recurring basis and are reported at fair value using net asset value ("NAV") as a practical expedient and are valued at \$4,230,497 and \$4,277,222 at December 31, 2024 and 2023, respectively.

The NAV, as provided by the contract issuer, is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Pooled separate accounts are valued daily, can be redeemed daily, and have no unfunded commitments. Plan level withdrawals require 30 days' written notice.

In accordance with U.S. GAAP Subtopic 820-10, certain investments that were measured at NAV per share (or its equivalent) have not been classified in the fair value hierarchy.

4. GUARANTEED INVESTMENT CONTRACT

The Plan holds a traditional investment contract issued by The Voya Retirement Insurance and Annuity Company ("Voya", "the contract issuer"). The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

With traditional investment contracts, the Plan owns only the contract itself. These contracts are designed to accrue interest based on crediting rates established by the contract issuers.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer. Such interest rates are reviewed and reset on a quarterly basis.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that would also limit the ability of the Plan to transact at contract value with the participants.

5. CERTIFIED INVESTMENT INFORMATION

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, The Voya Retirement Insurance and Annuity Company, the Plan's custodian, has certified that the following data included in the accompanying financial statements and supplemental schedule of assets (held at end of year) is complete and accurate as of December 31:

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their accounts.

7. PARTY-IN-INTEREST TRANSACTIONS

The Plan allowed participants of the Plan to invest in certain funds that are managed by The Voya Retirement Insurance and Annuity Company, the custodian of the Plan. As such, transactions between the participants investing in these funds and the Plan qualify as party-in-interest transactions.

The Plan allows current employees who are participants to receive loans under specific circumstances. As such, transactions between the participants that have loans and the Plan qualify as party-in-interest transactions.

8. TAX STATUS

The Internal Revenue Service ("IRS") has determined and informed the sponsor of the volume submitter plan document adopted by the Company by a letter dated June 30, 2020, that the volume submitter plan document and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan has not requested its own determination letter from the IRS. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified, and the related trust is tax-exempt. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. RECONCILIATION TO FORM 5500

Certain items have been classified differently between the financial statements and the Form 5500. Net assets available for benefits and changes in net assets available for benefits per the financial statements agree to Form 5500 in total as of December 31, 2024 and 2023.

10. SUBSEQUENT EVENTS

The Company has evaluated subsequent events through October 13, 2025 the date these financial statements were available for issuance.
