Note 1 - Description of plan

The following brief description of Universidad Carlos Albizu Savings and Investment Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering employees of Universidad Carlos Albizu, Inc., San Juan Campus (the Plan Sponsor), who have completed 3 months of continuous service and are age eighteen or older; excluding self-employed unionized employees and non-resident alien individuals. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective May 11, 2020, the Plan was amended and restated, and Empower Trust Company, LLC was appointed as the new Custodian of the Plan. Plan assets were transferred into funds comparable to those offered by the previous Custodian, John Hancock Life Insurance Company (U.S.A.).

Contributions

Each year, participants may contribute an amount of their compensation not exceeding the maximum deferral specified by law. Participants may also contribute amounts representing distributions from other qualified plans. The Plan Sponsor may make a discretionary contribution, which is not limited to its current or accumulated net profit. Contributions are subject to certain limits. Contributions made by the Plan Sponsor are distributed among participant accounts based on eligible compensation. Eligible compensation excludes overtime and bonuses.

Participants direct the investment of their account balances into various investment options offered by Empower Trust Company, LLC, the Custodian of the Plan.

Participant accounts

Each participant's account is credited with the participant's contributions, allocations of the Plan Sponsor matching contributions and Plan gains or losses. The benefit to which a participant is entitled is the vested benefit that can be provided from the participant's accounts.

Note 1 - Description of plan – (continued)

Vesting

Participants are immediately vested in their voluntary contributions, Plan Sponsor's contributions, and actual earnings thereon.

Loans to participants

Loans to participants are not permitted.

Payment of benefits

On termination of service due to death, disability or retirement, a participant or participant's beneficiaries will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service due to other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution.

Plan expenses and administration

The Plan Sponsor is responsible for the general administration of the Plan and for carrying out the provisions thereof. Certain administrative functions are performed by officers or employees of the Plan Sponsor. No such officers or employees receive compensation from the Plan. All reasonable expenses related to the Plan administration will be paid from Plan assets, to the extent of those not paid by the Plan Sponsor.

Plan termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. However, no such action may deprive any participant or beneficiary under the Plan of any vested right.

Note 2 - Summary of accounting policies

Basis of accounting and presentation

The financial statements of the Plan are prepared under the accrual basis of accounting.

Note 2 - Summary of accounting policies – (continued)

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investments valuation and income recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits

Benefits are recorded when paid.

Benefits payable

The Plan accounts for benefits payable in accordance with the guidance provided by the American Institute of Certified Public Accountants (AICPA), *Audit and Accounting Guide, Audits of Employee Benefit Plans*. This guidance requires that benefits payable to persons who have withdrawn from participation in a defined contribution plan be disclosed in the notes to the financial statements rather than recorded as a liability of the Plan.

As of December 31, 2024 and 2023, there were no benefits payable to participants who have elected to withdraw from the Plan but have not yet been paid.

Note 3 - Information certified by the Custodian (unaudited)

The plan administrator has elected the method of compliance permitted by Section 103(a)(3)(C) of the U.S. Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Custodian of the Plan, Empower Trust Company, LLC, has certified as to the completeness and accuracy of all investment related information reflected in the accompanying financial statements as of December 31, 2024 and 2023, and for the year ended December 31, 2024, and the related notes to the financial statements, and the schedule H, line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024.

Note 3 - Information certified by the Custodian (unaudited) – (continued)

The Custodian maintains all records, executes investment transactions, and holds all the assets of the Plan. In addition, the Custodian, upon authorization from the plan administrator, distributes benefit payments to the participants.

Note 4 - Tax status

The Plan is subscribed under the Oriental Bank & Trust (the Trustee) which has been qualified under the appropriate sections of the Puerto Rico Internal Revenue Code (the Code), as amended. The application to qualify the Plan within Oriental Group's Plan has been approved through a determination letter dated August 27, 2013, issued by the Puerto Rico Treasury Department.

The Plan has been amended since receiving the determination letter. The Plan Administrator filed with the Puerto Rico Treasury Department a request for a determination letter considering the latest amendments to the Plan and the Plan obtained its latest determination letter on July 24, 2019, in which the Puerto Rico Treasury Department stated that the Plan, as then designed, was in compliance with the applicable requirements of the Code. The Plan Administrator believes that the Plan, as currently designed and being operated, is in compliance with the applicable requirements of Section 1081.01 of the Code. Therefore, no provision for income taxes and provision for asserted and unasserted claims and assessments affecting the plan assets that might result from the loss of tax-exempt status have been included in the Plan's financial statements.

Note 5 - Fair value measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) No. 820 *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC *Topic of Fair Value Measurements* are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the assets or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds – Investments in mutual funds consist of shares of mutual funds that are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan consist of open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and were categorized as Level 1.

Note 5 - Fair value measurements – (continued)

Fixed annuities – The reported values for fixed annuity options are reported daily based on the valuation method disclosed in the annuity contract, as calculated by the annuity provider. These investments are classified as Level 2.

Collective trust funds – Share prices/NAV reported on the Plan summary reports for the collective trust funds are generally obtained directly from the fund house or other investment provider. If an observable input is available, an attempt is made to receive share prices from more than one source, and before the share price is entered into the recordkeeping system, a systematic comparison is performed and any difference in quoted share prices for the same fund is resolved by contacting the investment provider directly to ensure the correct share price is recorded. Variance reports are also reviewed, showing the percentage of share price changes from the prior day. The internal pricing analyst and management will review the overall movement of market indices and will apply judgment in determining whether any further research with investment providers will be pursued for share price variances from the prior day. Daily, after all research and validation have been performed, and variances have been resolved, share prices are closed and loaded to the recordkeeping system. Due to the various unique investments that may be allowed in a collective trust fund, and the various redemption restrictions that may be imposed, a plan sponsor should individually review the prospectus and operations of each of these types of investment options.

Per US GAAP guidance, investments which use a net asset value per share (NAV) practical expedient for fair value measurement, as defined in ASC No. 820, should be removed from the leveling table and shown as a reconciling item. In general, the use of the practical expedient requires that the NAV is not publicly available.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan's management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Certain Plan investments consist of mutual funds and money market accounts managed by the Custodian. Therefore, these transactions qualify as party-in-interest transactions.

Note 7 - Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to multiple risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The Plan failed the non-discrimination test for the year ended on December 31, 2024. As of the date of these financial statements, the correction for this non-compliance event has not yet been made. Management is in the process of determining the corrective action, which is expected to include the reimbursement of excess contributions, plus accumulated earnings, to certain highly compensated employees.

Note 9 - Non-exempt prohibited transactions

During the years ended December 31, 2024 and 2023, participant contributions amounting to \$12,425 and \$90,325, respectively, were deposited in the trust later than required by the Department of Labor regulations. During the year ended December 31, 2024, the late participant contributions for the fiscal year 2023 amounting to \$90,325 were fully credited by the estimated investment income that would have been earned had these participant contributions been remitted on a timely basis. As of the date these financial statements were available to be issued, the 2024 late contributions were pending to be credited by the estimated investment income that would have been earned had these participant contributions been remitted on a timely basis.

Note 10 - Subsequent events

The Plan has evaluated subsequent events through October 14, 2025, which is the date the financial statements were available to be issued. No events have occurred subsequent to the date of the statement of net assets available for benefits date and through the date the financial statements were available to be issued, that would require additional adjustment to, or disclosure in, the financial statements.
