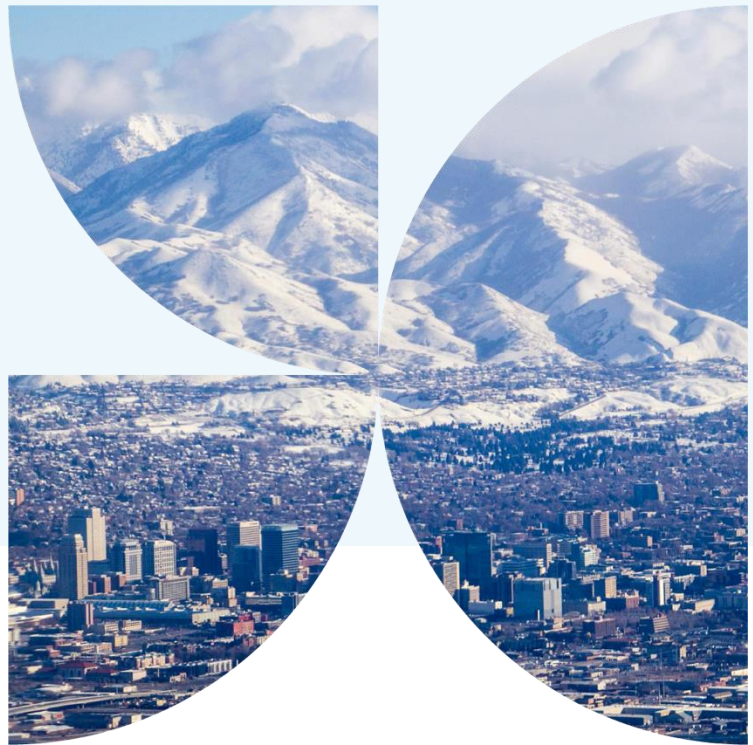

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Schnitzer Properties 401(k) Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

1. Description of Plan

The following description of the Schnitzer Properties 401(k) Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General –The Plan is a 401(k) defined contribution plan covering all eligible individuals who are employed by the participating companies, have achieved three consecutive months of service, and received an Internal Revenue Service (“IRS”) Form W-2 from the participating companies. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Schnitzer Investment Corp., the Plan sponsor, and Schnitzer Properties Management, LLC, an affiliated entity, are participating companies in the Plan.

Contributions – Employees may make elective deferrals subject to the annual limits defined in the Internal Revenue Code (“IRC”). For participants who have not attained age 50, contributions are limited to \$23,000 and \$22,500 for 2024 and 2023, respectively. Participants age 50 or older may make contributions of up to \$7,500 in addition to the above limits for 2024 and 2023. Contributions which exceed allowable limits are returned to the participants. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may also contribute amounts representing distributions from other qualified contribution plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan.

The employer makes matching contributions of 35 percent of the participant’s 401(k) contribution (subject to certain limitations) with the match being limited to 35 percent of the first 6 percent of the participant’s annual compensation. The employer may also make a discretionary profit sharing contribution to the Plan, although no such discretionary employer contributions have been made to date or are anticipated at this time to be made in the future. Such contribution may be fixed in terms of dollars, percentage of profits or a percentage of annual compensation and would be received by all eligible participants.

Participants Accounts – A separate account is maintained for each Plan participant. The account of each eligible participant who was employed on the last day of the Plan year is credited with employer discretionary profit sharing contributions (if any) as defined above. Contributions shall be allocated, as of the date they are received by the Plan, to the participants for whom they are made and credited to each participant’s account. Each participant’s account is credited with net earnings, gains and losses according to the terms of the underlying investments. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s account.

Vesting – Participants are 100 percent vested in their elective salary deferrals plus actual earnings thereon at all times.

Vesting in benefits derived from the employer matching and profit sharing contribution, plus earnings thereon, is based on years of service. A participant is 100 percent vested after three years of credited service, where each year must include a minimum of 1,000 hours of service. Employees are automatically 100 percent vested upon death or disability.

1. Description of Plan (Continued)

Loans to Participants – A participant may borrow from his or her fund account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of his or her account balance. Loans must be repaid within five years, unless the loan proceeds are used to acquire the participant’s principal residence, in which case longer terms may be agreed on. Loans are secured by the balance in the participant’s account and bear interest at a commercially reasonable rate, which is credited to the participant’s account. Interest rates ranged from 5.25% to 10.50% at December 31, 2024 and from 5.25% to 7.50% at December 31, 2023. Principal and interest is paid ratably through periodic payroll deductions.

Payment of Benefits – On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant’s vested interest in his or her account or annual installments over a specific period. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. Depending on election of the payout method, the participant may be subject to IRS withholding. At December 31, 2024, there were no net assets available for benefits that had been allocated to participants who had requested distributions, but had not yet received distributions.

Forfeited Accounts – Forfeitures of non-vested employer matching and profit sharing contributions may be used to pay employer contributions and future plan administrative expenses. Forfeitures were used to pay employer contributions of \$17,254 and \$22,263 for 2024 and 2023, respectively. Forfeitures of \$900 and \$-0- were used to pay plan administrative expenses for 2024 and 2023, respectively. Net assets available for benefits include approximately \$20,292 and \$5,008 in unallocated forfeitures at December 31, 2024 and 2023, respectively.

Employer Contributions Receivable – Represents the amount that the employer is obligated to contribute for work that participants performed during the years ended December 31, 2024 and 2023. The Plan’s management considered all employer contributions receivable to be fully collectable. Accordingly, there was no allowance for doubtful accounts.

Plan Termination – The Plan sponsor has the right to terminate the Plan at any time subject to the provisions of ERISA. In the event of plan termination, the accounts of all participants will be fully vested.

2. Summary of Significant Accounting Policies

Basis of Accounting – The accompanying financial statements have been prepared on the accrual basis.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – Investments are reported at fair value, other than the stable value fund which is reported at contract value (see Note 3). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The trustees determine the Plan’s valuation policies utilizing information provided by the investment advisors and custodians. See Note 4 for discussion of fair value measurements.

2. Summary of Significant Accounting Policies (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net investment gains from mutual funds includes the Plan's gains and losses on investments bought and sold as well as held during the year, and reinvested dividends from mutual funds.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. A loan is considered to be in default as of the last day of the calendar quarter following the calendar quarter in which an unpaid installment payment was due. If the missed installment payment(s) plus interest are not paid in full before the loan is declared in default, the loan shall be deemed a distribution.

Excess Employee Elective Deferrals – Amounts payable to participants for deferrals in excess of amounts allowed by the IRC are recorded as a liability with a corresponding reduction in contributions. For the years ending December 31, 2024 and 2023, there were no excess employee elective deferrals.

Administrative Expenses – Charges by Standard Insurance Company (“Standard”), except for certain transactional charges that are paid by the particular participant involved, are reflected as administrative expenses in the accompanying statements. Certain other costs of administering the Plan such as payroll expenses of administrative and clerical personnel are incurred by the Plan sponsor without charge to the Plan.

Payment of Benefits – Benefits are recorded when paid.

3. Stable Value Fund

The Standard Stable Asset A Fund (“Stable Value Fund”) meets the fully benefit-responsible investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Standard, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The contract value of the Stable Value Fund at December 31, 2024 and 2023 was \$4,517,060 and \$4,700,394, respectively. The crediting interest rate was 3.04% for 2024 and 2.78% for 2023. The crediting interest rate is set by Standard using a process similar to that used by banks or other insurance companies for similar products, but cannot be less than one percent annually. Such interest rates are reviewed on a quarterly basis for resetting.

The Plan's ability to receive amounts due is dependent on the Stable Value Fund's ability to meet its financial obligations. The Stable Value Fund's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events, such as the premature termination of the Stable Value Fund by the Plan or the termination of the Plan, would limit the Plan's ability to transact at contract value with the Stable Value Fund. The Plan sponsor believes the occurrence of such events, that would also limit the Plan's ability to transact at contract value with Plan participants, is not probable.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observed for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds (registered investment companies): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that were registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

4. Fair Value Measurements (Continued)

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Changes in Fair Value Levels – The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported on the actual date of the event or change in circumstances that caused the transfer.

5. Information Prepared and Certified by Custodian

The December 31, 2024 and 2023 Statements of Net Assets Available for Benefits, the investment activities included in the Statements of Changes in Net Assets Available for Benefits, and the accompanying notes to the financial statements were prepared in part or entirely from information certified by Reliance Trust Company, the custodian, in accordance with 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The information certified includes investments of \$45,067,200 and \$40,588,037 at December 31, 2024 and 2023, respectively, and related investment income of \$5,519,579 and \$5,425,871 for the years ended December 31, 2024 and 2023, respectively.

6. Party-in-Interest

The Plan invests in Standard Stable Asset A, a stable value fund provided by Standard Insurance Company who is the Plan’s record keeper.

Fees paid to Standard for recordkeeping and administrative services amounted to \$72,031 and \$71,676 for the years ended December 31, 2024 and 2023, respectively. The Plan Sponsor incurred and paid audit fees of \$10,000 and \$9,400 on behalf of the Plan during the years ended December 31, 2024 and 2023, respectively.

7. Tax Status

The Plan is designed to be qualified and exempt from income taxes under applicable sections of the IRC. The Plan obtained its latest determination letter dated March 31, 2014 in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan's management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The Plan administrator believes it is no longer subject to income tax examination for years prior to 2021.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

10. Recently Adopted Accounting Guidance

In June 2016, the FASB issued guidance (FASB ASC 326) Allowance for Credit Losses. The Plan adopted the standard effective January 1, 2023. The impact of the adoption was not material to the financial statements.

11. Subsequent Events

Management of the Plan has evaluated events and transactions occurring after December 31, 2024 through October 13, 2025, the date the financial statements were available for issuance, for potential recognition or disclosure in the financial statements and concluded that no subsequent events have occurred that would require recognition in the financial statements or disclosure in the notes to the financial statements, other than discussed below.
