1. General Description of the Plan

The HSBC-North America (U.S.) Tax Reduction Investment Plan (the “Plan”) is a defined contribution plan for eligible current and former employees of participating subsidiaries and affiliates of HSBC North America Holdings Inc. (“HNAH” or the “Plan Sponsor”), including HSBC Finance Corporation (“HSBC Finance”), HSBC USA Inc. (“HSBC USA”), HSBC Markets USA Inc. (“HMUS”) and HSBC Technology & Services (USA) Inc. (“HTSU”). Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is funded through a single 401(k) trust with Vanguard Fiduciary Trust Company (“Vanguard” or “Trustee”). The Plan is subject to the requirements of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The HSBC - North America (U.S.) Benefits Administrative Committee (the “Committee” or the “Administrator”) is responsible for administering the Plan and complying with all ERISA reporting and disclosure laws applicable to the Plan. The Committee has complete discretionary authority to interpret, apply, and administer the terms of the Plan and to determine eligibility for benefits and the amount of any benefits under the Plan. The HSBC - North America (U.S.) Investment Committee (the “Investment Committee”) determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

Contributions

Effective January 1, 2023, the Plan was amended to allow for employees to make Roth contributions to the Plan in addition to pre-and non-Roth after-tax contributions.

Employees are eligible to participate in the Plan after 30 days of service and at any age. Employees may contribute up to 40% of their total compensation to the Plan each year. Unless they decline participation, employees that are newly hired or rehired on or after January 1, 2009 are automatically enrolled in the Plan for 3% pre-tax contributions after they become eligible. Participants direct their contributions into various fund investments options, however if the participant does not make a fund selection their contributions are invested in a Vanguard Target Retirement Fund based on the employee’s age as of December 31 of their year of hire and projected years to retirement (age 65) until changed by the participant. Contributions by highly compensated employees (as defined by law) or employees affected by the Internal Revenue Service (the “IRS”) limits may be limited. Employees may elect to make contributions on a pre and after-tax (including Roth), or rollover basis. Pre-tax contributions are taken out of an employee’s pay before taxes are deducted. After-tax contributions (including Roth contributions) are taken out of an employee’s pay after it has been reduced for taxes. If you are a highly compensated employee under the IRS definition, you cannot make any after-tax contributions (other than Roth contributions) to the Plan. Rollover is for lump-sum payments (pre-tax or after-tax (including Roth)) from another employer’s qualified plan into a “rollover account” in the Plan. Each eligible participant who has attained age 50 before the close of the Plan year shall be eligible to contribute pre-tax and/or Roth catch-up contributions up to IRS limits. Pre-tax and after-tax (including Roth) contributions, other than catch-up contributions made by highly compensated employees, are matched each pay period by employer contributions up to a total of 6% of their compensation within plan funding limits as follows:

- 3% match on the first 1% an employee contributes
- 1% match on the second 1% an employee contributes
- 1% match on the third 1% an employee contributes
- 1% match on the fourth 1% an employee contributes.

Employer-matching contributions are made in cash and invested in accordance with the participant’s investment elections. There is no service requirement and all deferrals are eligible for matching contributions. These contributions are fully vested immediately.

HNAH generally has the right to discontinue or modify its contributions at any time.

Notes Receivable from Participants

Loans to participants are available under the Plan. A \$40 loan fee is deducted from the amount borrowed when the loan is made. Each loan must be for an amount not less than \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of the participant’s account balance. No more than two non-residential loans and one loan for the construction or acquisition of a principal residence may be outstanding at any time. Loans are secured by the participant’s account balance. Loans must be repaid within four and a half years except that, at the Committee’s discretion, loans for the construction or acquisition of a participant’s principal residence may be made for a term of up to 25 years. However, all loans become due upon severance of the participant’s employment. The Committee will determine the interest rate to be charged on each loan based on prevailing market conditions for similarly secured personal loans. The range of interest rates on outstanding loans is 3.75% to 9.00% as of December 31, 2024. Prepayment of a loan in full is allowed at any time without penalty. Loan repayments are made automatically through bi-weekly payroll deductions.

1. General Description of the Plan (continued)

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the employer's contribution and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan documents. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100 percent vested in their contributions, employer matching contributions, and related investment performance.

Payment of Benefits

If certain conditions are satisfied, a participant's after-tax contributions may be withdrawn at any time whereas pre-tax contributions, Roth contributions, employer matching contributions made on or after January 1, 1999, and employer matching contributions made on or after January 1, 2005 if you participated in the HSBC Bank USA Thrift Incentive Plan, may not be withdrawn except for an immediate financial hardship, certain qualified distributions (Qualified Birth, Qualified Adoption, or Qualified Disaster Recovery), termination of employment or attainment of age 59 1/2. If the participant is under age 59 1/2, the withdrawal is subject to a 10% IRS early withdrawal penalty. Special tax rules also apply to the withdrawal of Roth contributions. Generally, Roth contributions and earnings that are withdrawn in a "qualified distribution" (generally after the account has been held for at least 5 years and if the distribution is on account of death, disability or after age 59 1/2) are not taxable. Earnings on Roth contributions that are withdrawn under circumstances that do not constitute a "qualified distribution" are subject to tax and may also be subject to early withdrawal penalties. Special rules apply for purposes of determining what portion of a withdrawal consists of Roth contributions and earnings and what portion of the distribution, if any, is taxable. Withdrawals during employment may be subject to minimum amount requirements depending on the type and option of withdrawal. There are no restrictions over the frequency of withdrawals, unless noted in the Plan provisions.

On termination of services due to any reason, including retirement or long-term disability, the full value of the participant's Plan account can be paid to the participant. In the event of death, the benefit will be paid to the beneficiary.

For 2023 the plan was amended to increase the age at which required minimum distributions commence from age 72 to age 73.

Administrative Expenses

The Vanguard Fiduciary Trust Company and the Vanguard Group of Investment Companies is the trustee and record keeper of the Plan, respectively. The Plan paid approximately \$2,140,000 and \$2,207,000 in 2024 and 2023, respectively, of expenses related to the administration of the Plan.

2. Summary of Significant Accounting Policies

Basis of Accounting

The Plan is accounted for on the accrual basis of accounting in accordance with U.S. generally accepted accounting principles (“U.S. GAAP”).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could materially differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies. See Note 9 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Net realized appreciation/depreciation is the difference between the selling price of an investment and the cost of that investment.

The change in unrealized appreciation/depreciation of investments is the difference between the fair value of an investment at the end of the plan year and the fair value of the same investment at the beginning of the plan year or at its acquisition date if acquired during the plan year.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Processing fees on these notes are recorded as administrative expenses and are expensed as incurred. Delinquent loans are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Participant withdrawals and distributions are recorded in the financial statements when paid.

3. Information Certified by the Plan's Trustee

The Plan Sponsor has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net investment income, interest income on investments, and interest income on notes receivable from participants, as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Fair value measurements as of December 31, 2024 and 2023 as described in Note 9 excluding the leveling of investments.
- The schedule of assets (held at end of year) as of December 31, 2024, as shown on Schedule H - Line 4i.

4. Tax Status of the Plan

The Plan has received a favorable determination letter dated May 15, 2017 from the Internal Revenue Service (“IRS”) confirming the Plan’s continuing tax-qualified status under the Internal Revenue Code (the “Code”). In 2017, the IRS ended the determination letter cycle program for individual designed plans. Accordingly, absent special circumstances outlined by IRS guidance, the Plan will not be receiving determination letters going forward. Although the Plan has been amended since applying for the May 15, 2017 determination letter, the Plan’s Administrator and the Plan’s Counsel believe that the Plan is designed and is currently being operated in compliance with applicable requirements of the Code.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. Plan Termination

The Plan Sponsor expects to continue the Plan indefinitely. Nevertheless, it maintains the right to suspend or discontinue Plan Sponsor contributions and/or terminate the Plan at any time and for any reason, to the extent permitted by law. In addition, it may amend or modify the Plan from time to time to the extent permitted by law. Any changes will be communicated to participants in writing. In the event of a termination, all vested benefits will be non-forfeitable and will not be returned to HNAH.

6. Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market rate, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

7. Party-In Interest Transactions

Transactions resulting in Plan assets being transferred to or used by a related party are prohibited under ERISA and/or the Code unless a specific exemption applies. The plan engages in numerous transactions and third party service relationships that are subject to those prohibited transaction rules. For example, certain Plan investments are shares of mutual funds and collective trusts managed by Vanguard. These transactions and service relationships are generally designed (a) to avoid prohibited transactions for which there are no exemptions (e.g., self-dealing), and (b) where exemptions are available, to utilize those exemptions from the prohibited transaction rules. Notes receivable from participants also qualify as party-in-interest transactions.

8. Commitments and Contingencies

In the ordinary course of business, the Plan may be named as defendant in or be a party to various pending and threatened legal proceedings. The Plan Administrator and the Plan’s counsel believe, based upon current knowledge, that liabilities arising out of any such current proceedings will not have a material adverse effect on the statements of net assets available for benefits and the related statements of changes in net assets available for benefits.

9. Fair Value Measurements

Accounting principles related to fair value measurements provide a framework for measuring fair value and focus on an exit price in the principal (or alternatively, the most advantageous) market accessible in an orderly transaction between willing market participants (the "Fair Value Framework"). The Fair Value Framework establishes a three-tiered fair value hierarchy with Level 1 representing quoted prices (unadjusted) in active markets for identical assets or liabilities. Fair values determined by Level 2 inputs are inputs that are observable for the asset or liability, either directly or indirectly. Level 2 inputs include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in markets that are not active, and inputs other than quoted prices that are observable for the asset or liability, such as interest rates and yield curves that are observable at commonly quoted intervals. Level 3 inputs are unobservable inputs for the asset or liability and include situations where there is little, if any, market activity for the asset or liability. Transfers between leveling categories are recognized at the end of each reporting period.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Daily quoted prices representing the net asset value ("NAV") of shares of the fund held by the Plan at the end of the year.

Collective Trusts: Valued at the NAV of units of a collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. There are no unfunded commitments, redemption restrictions or redemption notices at the participant or plan-level as of December 31, 2024 and 2023.

Brokerage Option: Self-directed brokerage accounts representing participant-directed funds primarily held in mutual funds, which are valued at NAV based on quoted prices held at the end of the year. There were no concentrations in any one type of investment or industry.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
