## INDEPENDENT AUDITORS' REPORT

To the Participants and the Board of Trustees  
Whiteley Technical Services, LLC 401(k) Profit Sharing Plan  
Beaumont, Texas

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Whiteley Technical Services, LLC 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, the related statements of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). ## NOTES TO THE FINANCIAL STATEMENTS DECEMBER 31, 2024

(1) **DESCRIPTION OF THE PLAN**

The following description of Whiteley Technical Services, LLC 401(k) Profit Sharing Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution 401(k) plan covering all employees of the company who are not governed by a collective bargaining agreement under which retirement benefits were the subject of good faith bargaining, nonresident aliens, and leased employees, who have completed two (2) months of service with a minimum age of twenty-one. Employees may begin participating on the first day after eligibility requirements are met. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions** - Each year, participants may contribute up to 90% of either pretax 401(k) deferrals or Roth 401(k) deferrals. However, the total of the participant's contribution may not exceed the maximum allowed by law of pretax annual compensation, as defined in the Plan, up to the IRS limit. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The company contributes a Safe Harbor Nonelective Contribution equal to a uniform percentage, to be determined each year. For the year ending December 31, 2024 the company's Safe Harbor Contribution was 100% of the participant's salary deferrals that do not exceed 3% of the participant's compensation plus 50% of the salary deferrals between 3% and 5% of compensation. The company may contribute a discretionary matching contribution equal to a uniform percentage, to be determined each year. When applying this discretionary percentage, only salary reductions up to 4% of the annual compensation will be considered. Participants direct the investment of their contributions into various investment options offered by the Plan.

**Participant Accounts** - Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and, (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - Participants are immediately vested in their contributions plus actual earnings thereon. Participant are also immediately vested in their employer Safe Harbor Contributions. Vesting in the Company's matching contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. After one year of active service, an employee becomes 33% vested. Thereafter, vesting increases to 67% the second year and then to 100% the third year.

**Notes Receivable from Participants** - Participants may borrow from their fund accounts up to a maximum not to exceed \$50,000 or 50% of their elective deferral account less earnings. Loan transactions are treated as a transfer to (from) the investment fund from (to) the Participant Notes fund. Loan terms are not to extend beyond five years or ten years for home loans. The loans are secured by the balance in the participant's account and bear a reasonable interest rate. Interest rates at December 31, 2024 were 8.75%.

(1) **DESCRIPTION OF THE PLAN (CONTINUED)**

**Payment of Benefits** - On termination of service for any reason, a participant is entitled to receive a distribution of the total vested amount credited to their account. If the total vested account balance does not exceed \$7,000, the account balance will be distributed in a lump sum. If the total vested account balance exceeds \$7,000, the participant may elect to receive a distribution at any time; if the participant does not elect to receive a distribution, their vested account balance will be distributed after they reach normal retirement age. Participants with account balances exceeding \$5,000 may elect to receive single lump sum distributions or substantially equal installments, paid at least annually, over a specified period of time that does not exceed their life expectancy or the joint and survivor life expectancy of the participant and their beneficiary.

**Forfeited Accounts** - Forfeited balances of terminated participants' nonvested accounts are used to reduce administrative costs and then future Company contributions. At December 31, 2024, forfeited non-vested accounts totaled \$16,374. During 2024, \$352 was forfeited by participants who withdrew from the Plan and \$-0- was used to offset plan expenses.

(2) **SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared using the accrual method of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value, based on the quoted market prices of the underlying securities within each fund at December 31, 2024 as reported Fidelity Workplace Services, LLC. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the plan document.

**Payment of Benefits**

Benefits are recorded when paid.

**Funding Policy**

It is the policy of the Plan's employer to deposit the participants' withheld contributions within the ERISA required time limit which is the earliest date they can segregate deferrals from general assets.

**Withdrawing Participant Obligations**

Amounts allocated to withdrawing participants are claims that have been processed and approved for payment prior to year-end, but not paid as of that date. These amounts were deemed immaterial for the years ended December 31, 2024.

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

*Common stocks, corporate bonds and U.S. government securities:* Valued at the closing price reported on the active market on which the individual securities are traded.

*Mutual funds:* Valued at the net asset value ("NAV") of shares held by the plan at year end.

*Pooled separate account:* The unit value is calculated using the market value of the assets net of the investment management fee, of each sub-account and the number of outstanding unit.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(4) **PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

(5) **TAX STATUS**

The plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan is a Non-Standard Pre-Approved Profit Sharing Plan with CODA of Fidelity Workplace Services, LLC, under FMR, LLC and obtained its latest advisory letter issued by the Internal Revenue Service as evidence that the Plan is a qualified plan, as then designed, and was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

(6) **PARTY IN INTEREST TRANSACTIONS**

Certain Plan investments are shares of separate accounts managed by Fidelity Workplace Services, LLC. Fidelity Workplace Services, LLC is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for services provided by the Trustees amounted to \$34,549 for the year ended December 31, 2024.

At December 31, 2024, the Plan also incurred party-in-interest expenses in the amount of \$10,557 paid to MBG Retirement, Inc., investment advisor, for services provided to the plan.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
