#### **Note 1—Description of the Plan**

The following description of Knowles Intermediate 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

*General* – The Plan was established on January 1, 2023, by Knowles Intermediate PD Holdings, LLC (the “Company”, “Employer”, or “Plan Sponsor”).

Effective October 31, 2023, Cornell Dubilier Electronics, Inc. and its related subsidiaries and affiliates (“Cornell”) was acquired by Knowles Electronics, LLC and/or one of its affiliates. Upon acquisition, all participants of the Cornell Dubilier Electronics, Inc. 401(k) Plan (the “Cornell Plan”) became fully vested and no further contributions were made. All participants were notified of the formal termination of the Cornell Plan effective April 1, 2024, and were required to take a distribution, of which an option was provided to rollover the funds to Knowles Intermediate 401(k) Plan.

The Plan is a defined contribution plan intended to qualify under Section 401(k) of the Internal Revenue Code (“IRC”) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), The Plan covers all eligible employees of the Company. Employees become eligible to participate in the Plan upon attainment of age 21 and achievement of three months of service. The Plan excludes eligibility for residents of Puerto Rico and all retired and inactive employees of the Cornell Dubilier Electronics, Inc and certain of its subsidiaries and affiliates as of November 1, 2023, as described and listed in the Plan’s adoption agreement. Plan entry dates are the first day of the first month for which the eligibility requirements are met.

*Participant Contributions* – Eligible participants may elect to contribute a portion of their compensation to the Plan, subject to the IRC limitations for 401(k) plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may also rollover amounts representing distributions from other qualified defined benefit or contribution plans. Roth contributions are permitted by the Plan. Contributions are subject to certain limitations allowed under Section 402(g) of the IRC.

*Employer Contributions* – Matching contributions are made at the discretion of the Company’s Board of Directors. The Company made a matching contribution equal to 35% of participant contributions, up to a maximum of 6% of compensation. The discretionary matching Company contribution is invested in the same investment options and in the same ratio as the participants have directed their own investments. Company contributions are typically funded when the employee contributions are funded and are subject to certain limitations under the IRC. An additional profit sharing amount may be contributed at the discretion of the Company’s Board of Directors. No additional discretionary profit sharing contributions were made for the year ended December 31, 2024 (Audited).

*Participant Accounts* – Each participant’s account is credited with (a) the participant’s contribution, (b) the Company’s contributions, if any, and (c) an allocation of the Plan’s earnings. Each participant’s account is charged with participant withdrawals and an allocation of Plan losses and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

### Note 1—Description of the Plan (continued)

*Vesting* – All participant contributions made to the Plan are fully vested at all times and are not subject to forfeiture for any reason. Company contributions made to the Plan are vested according to number of years of service. After three years of service, a participant is 100% vested in Company contributions. Participants with less than three years of service are not vested in Company contributions.

*Benefits Paid to Participants* – Withdrawals are made on a lump-sum basis or at the participant's option as a deferred annuity upon retirement, disability, termination, or proof of hardship. If death occurs prior to retirement, the participant's account is paid to the designated beneficiary. The Plan allows participants to make hardship withdrawals to satisfy certain immediate and heavy financial needs. A participant may request a hardship withdrawal for certain qualifying expenses as defined by the Plan document, and within what the Internal Revenue Service ("IRS") deems an immediate and financial need of the participant.

*Hardship Withdrawals* – The Plan allows participants to make hardship withdrawals to satisfy certain immediate and heavy financial needs. A participant may request a hardship withdrawal for certain qualifying expenses as defined by the Plan document, and within what the IRS deems an immediate and financial need of the participant.

*Forfeitures* – Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeitures may be used to reduce Employer contributions or administrative expenses. At December 31, 2024 (Audited) and 2023 (Compiled), forfeited nonvested accounts totaled \$681 and \$-0-, respectively. For the year ended December 31, 2024 (Audited), \$153 in forfeitures were used to pay administrative expenses.

*Administration* – Under the terms of a Plan Services Agreement between Voya Retirement Insurance and Annuity Company and the Plan, Voya Retirement Insurance and Annuity Company will provide the participant recordkeeping and other related services. All amounts contributed to the Plan are forwarded to Voya Institutional Trust Company (the "Trustee") and invested in various funds as designated by the participant.

### Note 2—Summary of significant accounting policies

*Basis of Accounting* – The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

*Use of Estimates* – The preparation of financial statements in accordance with U.S. GAAP requires the Plan administrator and the Company to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein and disclosure of contingent assets and liabilities. Such estimates include those regarding fair value. Actual results, as determined at a later date, could differ from those estimates.

*Administrative Expenses* – The Plan is administered the Plan Sponsor. Certain administrative functions are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan. Substantially all administrative expenses are paid either directly by the Plan Sponsor or by the account of the Participant or through forfeitures.

*Investment Valuation and Income Recognition* – The Plan's investments are stated at fair value except for the guaranteed investment contracts which are stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

### Note 2—Summary of significant accounting policies (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Guaranteed investment contracts held by defined contribution plans are reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive guaranteed investment contracts since contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The statements of net assets available for benefits present the contract value of the guaranteed investment contracts. The statement of changes in net assets available for benefits is also prepared on a contract value basis. See Note 4 for discussion of fully benefit-responsive guaranteed investment contracts.

Management fees and operating expenses charged to the Plan for investments in guaranteed investment contracts and mutual fund accounts are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

*Investment Options* – Upon enrollment in the Plan, a participant may direct employee and Employer contributions in any of the investment options offered by the Plan.

*Payment of Benefits* – Benefits are recorded when paid.

*Risks and Uncertainties* – Investment securities, in general, are exposed to various risks, such as interest rates, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in value of investment securities will occur in the near term and that such changes could materially affect participant's account balances, and the amounts reported in the financial statements.

### Note 3—Fair value measurements

*Fair Value Measurements* – The Plan follows the fair value measurements topic of the Financial Accounting Standards Board Accounting Standards Codification 820, which defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value. The standard describes three levels of inputs that may be used to measure fair value:

*Level 1* – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date.

*Level 2* – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

*Level 3* – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

**Note 3—Fair value measurements (continued)**

A financial instrument’s level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following are descriptions of the valuation methodologies used for instruments measured at fair value:

*Mutual Funds* – These investments are public investment vehicles valued using the net asset value (“NAV”) provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is calculated using quoted prices available in active markets and classified at Level 1 of the valuation hierarchy.

*Money Market Fund* – This investment is a public investment vehicle valued using NAV provided by the administrator of the fund. The underlying assets are generally comprised of short-term securities representing high-quality, liquid debt, and monetary assets. The redemption and subscription frequencies are daily and the fund has no redemption notice periods or unfunded commitments. The money market fund is classified within Level 1 of the valuation hierarchy.

#### **Note 4—Guaranteed investment contract**

The Plan has fully benefit-responsive investment contracts with Voya Retirement Insurance and Annuity Company, which maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contracts issuer is contractually obligated to repay the principal and interest at a specified rate that is guaranteed to the Plan.

As described in Note 2, because the guaranteed investment contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contracts. Consequently, the investment is stated at contract value on the statements of net assets available for benefits and is not included within the fair value hierarchy. Contract value, as reported to the Plan by the Trustee, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures of spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the Trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contracts do not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

#### **Note 5—Information certified by the Trustee (unaudited)**

The Plan Sponsor has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Voya Institutional Trust Company, the qualified institution, has certified to the completeness and accuracy of the following data included in the accompanying financial statements:

- Investments, at fair value and guaranteed investment contracts, at contract value as shown on the statements of net assets available for benefits as of December 31, 2024 (Audited) and 2023 (Compiled).
- Net appreciation in fair value and contract value of investments and interest on guaranteed investment contracts as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024 (Audited).
- Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2024 (Audited).

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

### Note 6—Party-in-interest transactions

Certain Plan investments are shares of mutual funds and a guaranteed investment contracts managed by an affiliate of Voya Institutional Trust Company. Voya Institutional Trust Company is the Trustee as defined by the Plan and, therefore, those transactions qualify as party-in-interest transactions. Fees paid by the Plan and deducted from participant accounts for contract administrative expenses amounted to \$37,994 for the year ended December 31, 2024 (Audited), and are included in administrative expenses on the accompanying statement of changes in net assets available for benefits..

### Note 7—Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, all amounts credited to participants' accounts will become 100% vested.

### Note 8—Tax status

The Plan has obtained an opinion letter, dated June 30, 2020, from the IRS stating the Plan is designed in accordance with applicable sections of the IRC. The Plan has been amended, revised, and restated since the date of the opinion letter. However, the Plan administrator believes the Plan, as amended, revised, and restated, remains in accordance with the applicable requirements of the IRC and has no income subject to unrelated business income tax and, therefore, the Plan and related trust continue to be tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 (Audited) and 2023 (Compiled), there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.

### Note 9—Prohibited transactions

During 2024, participant salary deferral contributions to the Plan totaling \$6,033 were not remitted to the Plan in accordance with DOL's rules regarding timely remittances on multiple occasions. Plan management calculated the lost earnings on these deferrals and plans to correct the late remittances through DOL's voluntary Fiduciary Correction Program ("VFCP") during 2025. The lost earnings are not significant to the financial statements.
