1. Description of the Plan

The following description of Xinergy 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document and Adoption Agreement for a more complete description of the Plan’s provisions.

General

The Plan is a controlled group defined contribution plan covering all employees of Xinergy Corp., South Fork Coal Company, LLC, Raven Crest Contracting, LLC, Big Run Mining, Xinergy Straight Creek, Inc., Pinnacle Insurance Corp., True Energy, LLC, and Brier Creek Coal (collectively referred to as the “Plan Sponsor”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is available to all employees who are at least 18 years of age. Participation in the Plan is strictly voluntary. Eligible employees can elect to participate immediately upon date of hire.

Contributions

Each year, participants may contribute, on a pre-tax or Roth basis, up to 100% of their eligible compensation, as defined by the Plan Document, subject to certain Internal Revenue Service (IRS) limitations. In addition, participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. Participants can change the investment options previously elected at any time.

The Plan Sponsor contributes a safe harbor matching contribution equal to 100% of each participant’s contribution up to 3% of compensation and 50% of each participant’s contribution between 3% and 5% of compensation. Participants are eligible for the Plan Sponsor safe harbor matching contributions on the first day of the plan year quarter (January 1, April 1, July 1, or October 1) after six months of service.

Receivables, if any, from the Plan Sponsor for contributions are unsecured.

Participant Accounts

Individual accounts are maintained for each participant to reflect the participant’s contributions, Plan Sponsor contributions, and investment earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

1. Description of the Plan (continued)

Vesting

Participants are immediately vested in their voluntary contributions, the Plan Sponsor's safe harbor matching contributions, and earnings on these contributions.

Notes Receivable from Participants

Participants may borrow from their fund accounts. The minimum amount of the loan is \$1,000, and the maximum amount is the lesser of one-half of the participant's vested account balance or \$50,000. One loan may be outstanding at a time per participant, and the loans generally bear interest at the prime interest rate plus 1%. The loans are generally repayable in level periodic payments over various terms of up to five years, except for those utilized for the acquisition of a principal residence, which may be repaid over a period of time up to 30 years. The loans are secured by the balance in the participant's account. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

At any time on or after the age of 59½ or upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount or installments equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

The Plan permits in-service and hardship withdrawals under certain conditions.

Forfeitures

Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeitures of terminated participant's non-vested accounts may be used to reduce future Plan Sponsor contributions to the Plan or to pay plan expenses. If a terminated participant is rehired by the Plan Sponsor, then the participant may be entitled to a restoration of certain amounts forfeited, based on provisions in the Plan Document. As of December 31, 2023, there was \$11,185 in the forfeiture account, which was included in plan assets. Forfeited nonvested accounts used to pay fees totaled \$11,197 and \$11 in 2024 and 2023, respectively.

Termination of the Plan

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

2. Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts in the Plan's financial statements. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Prior to August 28, 2023, Transamerica Life Insurance Company (Transamerica) held the plan assets under a group annuity contract in either a Stable Value Core Fund account, which was stated at contract value, or various pooled separate accounts, which were stated at fair value. Effective August 28, 2023, the Plan's investments were transferred to Voya Retirement Insurance and Annuity Company (Voya). Voya maintains the investments in either a guaranteed investment contract (the "Voya Fixed Account"), which is stated at contract value, or various pooled separate accounts, which are stated at fair value.

The maximum loss, if any, that would be incurred by the Plan if the counterparties to the Plan's investments failed to perform is the recorded amount of such investments. Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

2. Significant Accounting Policies (continued)

Notes Receivable from Participants (continued)

Upon default of notes receivable from participants, the entire outstanding principal and interest shall be immediately due and payable. If a distributable event, as defined by the IRC, has occurred, the note receivable will be foreclosed on and be offset against the participant's account balance. If a participant's note receivable is in default, the participant shall be treated as having a taxable deemed distribution whether or not a distribution event has occurred.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Certain administrative expenses of the Plan are paid by the Plan Sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Certain investment related expenses are netted in net realized and unrealized appreciation in the fair value of investments.

Subsequent Events

Plan management has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

During February 2025, the Plan sponsor filed for protection under Chapter 11 of the U.S. Bankruptcy Code. During August 2025, the bankruptcy proceeding was converted to a Chapter 7 liquidation. The effect of the bankruptcy filing on the Plan is not presently determinable. Management of the Plan continues to evaluate the impact of the bankruptcy on the Plan's ongoing operations and compliance with the ERISA. Benefit payments totaling approximately \$1,660,000 have been distributed from the Plan through September 15, 2025.

3. Income Tax Status

The Plan Sponsor adopted a prototype plan sponsored by Benefits Administrators, LLC that received a favorable opinion letter from the IRS dated June 30, 2020, which states the form of the prototype plan is acceptable for use under applicable sections of the IRC.

Effective August 23, 2023, the Plan Sponsor adopted a prototype plan sponsored by CBIZ Benefits & Insurance Services that received a favorable opinion letter from the IRS dated June 30, 2020, which states the form of the prototype plan is acceptable for use under applicable sections of the IRC. The Plan has been amended since the latest opinion letters referenced above; however, the Plan Administrator believes that the Plan is being operated in accordance with applicable requirements of the IRC and, accordingly, remains exempt from income taxes.

4. Certified Information (Unaudited)

Certain information in the accompanying financial statements and ERISA-required supplemental schedules, related to investments and participant notes receivable held as of December 31, 2024 and 2023, and net realized and unrealized appreciation in the fair value of investments, interest income from the Voya Fixed Account, interest income from the Transamerica Stable Value Core Fund, and interest income on participant notes receivable for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Transamerica for the period from January 1, 2023 to August 28, 2023, and Voya for the period from August 28, 2023 to December 31, 2024.

The Plan had one investment, the Voya Vanguard Target Retirement 2030 fund, representing 28% of the Plan's net assets available for benefits as of December 31, 2024 and 2023.

5. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurement (Topic 820)*, are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets the Plan has the ability to access.
- Level 2 Inputs to the methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

5. Fair Value Measurements (continued)

The fair value measurement level of the asset or liability within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes to the methodologies used as of December 31, 2024 and 2023.

Pooled separate accounts are valued daily using publicly available quoted market information. Many of these accounts invest exclusively in one underlying mutual fund traded on an established market. These types of accounts are measured using quoted market prices of identical assets in active markets (Level 1). Those accounts directly invested in fixed maturity securities are measured based on the pricing data provided by outside valuation service providers who generally use the mean of bid and ask prices but may also use alternative observable pricing inputs for certain securities (Level 2).

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although management of the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. Guaranteed Investment Contract

The Plan invests in a guaranteed investment contract with Voya that is a fully-benefit responsive investment contract (FBRIC). The contributions are maintained in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Voya is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

6. Guaranteed Investment Contract (continued)

Because the investment is fully benefit-responsive, contract value is the relevant measurement attribute for the portion of the net assets available for benefits attributable to the investment contract. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with Voya. Such events include amendments to the Plan Documents (including complete or partial plan termination or merger with another plan), changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, bankruptcy of the Plan Sponsor or other Plan Sponsor events that cause a significant withdrawal from the Plan, or the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator believes any events that would limit the Plan's ability to transact at contract value with participants are not probable of occurring.

7. Stable Value Core Fund

Prior to August 28, 2023, the Plan invested in a Stable Value Core Fund with Transamerica that was a FBRIC. Transamerica maintained the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Transamerica was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan.

Because the Stable Value Core Fund was fully benefit-responsive, contract value was the relevant measurement attribute for the portion of the net assets available for benefits attributable to the Stable Value Core Fund. Contract value, as reported to the Plan by Transamerica, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due was dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations could have been affected by future economic and regulatory developments.

7. Stable Value Core Fund (continued)

Certain events limited the ability of the Plan to transact at contract value with EAICA. Such events included amendments to the Plan Documents (including complete or partial plan termination or merger with another plan), changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, bankruptcy of the Plan Sponsor or other Plan Sponsor events that cause a significant withdrawal from the Plan, or the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. No events that would have limited the Plan's ability to transact at contract value with participants occurred.

8. Party-in-Interest Transactions

Prior to August 28, 2023, certain investments were held and managed by Transamerica; therefore, these transactions qualified as party-in-interest transactions. Effective August 28, 2023, certain investments are held and managed by Voya; therefore, these transactions qualify as party-in-interest transactions.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

10. Delinquent Participant Contributions

Defined contribution plans are required to remit participant contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets. Contributions totaling \$35 during 2017, \$18,627 during 2019, and \$214 during 2023 were not remitted within the required time period. The delinquent contributions are in the process of being corrected as of October 14, 2025.
