Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

#### Note A – Plan Description and Summary of Significant Accounting Policies

General: The following information of VSE Corporation Group Health & Welfare Plan (the Plan) is provided for informational purposes only. Participants should refer to the trust agreement, plan document, and summary plan description as provided by the plan sponsor, VSE Corporation (the Corporation), for more complete and current information.

Description: The Plan was established effective January 1, 2012 by the Corporation's management and plan administrator. The Plan was established as a voluntary employees' beneficiary association (VEBA) under section 501(c)(9) of the Internal Revenue Code (IRC). The Plan is also subject to various provisions of the Employee Retirement Income Security Act (ERISA) of 1974 (as amended). The Plan serves as a funding vehicle for qualified medical and fringe benefit contributions made by the Corporation for employees working on certain contracts with the federal government some of which are subject to the McNamara-O'Hara Service Contract Act (the Act) of 1965 (as amended) and other collective bargaining agreements. The Act generally requires that wages paid to employees working on certain federal contracts be at least equal to prevailing wage rates as established by the Department of Labor (DoL) for localities in which the employees are working. The Act also requires employers to provide certain qualified fringe benefits in addition to the prevailing wage rate. The DoL annually establishes health and welfare contribution rate requirements for covered employees. Qualified fringe benefit may include health and medical, dental, vision, life and disability, non-statutory paid time off, and other qualified fringe benefits.

Plan Administration: Under the Act, employers are required to ensure compliance with the prevailing wage and health and welfare benefit requirements. Accordingly, many employers establish separate trusts or other funded arrangements which receive and administer the health and welfare contributions. If such contributions are paid to a trust, the trust must preclude the employer from recapturing any of the contributions paid into the trust in meeting the minimum prevailing wage requirement and from diverting any of the funds of the trust for its own benefit or use. The Plan was designed as a VEBA to satisfy the Act requirements. The Plan is managed by trustees, which are primary representatives of the Corporation. The trustees retained the services of a third-party administrator, CBIZ Benefits & Insurance Services, Inc. (CBIZ), which specializes in administrative services for employee benefit plans. The Plan also retained Aetna Life Insurance Company (Aetna), UPMC Health Plan, Connecticut General Life Insurance Company (Cigna), and other carriers and providers for insurance, claims processing, and other ancillary benefits.

Income Tax Status: The Plan received a determination letter from the Internal Revenue Service (IRS) in August 2014 setting forth the Trust's tax exemption under IRC Section 501(c)(9) effective January 1, 2012. Accordingly, the Trust is exempt from the payment of income taxes on its exempt activities. Any activities unrelated to the Trust's exempt status are subject to taxation. The Trust agreement may also be amended from time-to-time to clarify certain provisions or comply with new regulations and such amendments may require IRS approval. No assurances can be provided on any such amendments until reviewed and approved by the IRS.

Basis of Accounting: Effective December 31, 2024, the plan sponsor resolved to terminate and liquidate the Plan and as a result, the Plan changed its basis of accounting from the going concern basis used in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements. Under the liquidation basis of accounting, the financial statements are prepared to reflect the plan's expected resources and obligations as it winds down. All assets are reported at their estimated net realizable value, and liabilities are stated at estimated settlement amounts. Otherwise, the Plan prepared its financial statements on the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. Under the cash basis of accounting, revenue is recognized when cash is received rather than when it is earned, and expenses are recognized when cash is expended rather than when an obligation is incurred. The Plan's modification to the cash basis of accounting is in regards to the reporting of employer and participant contributions, which are accrued on a monthly basis based upon monthly labor hours for employees covered by the Act or collective bargaining agreements or based upon the actual costs of benefits provided for participants not covered by the Act or collective bargaining agreements, the accrual of insurance premium refunds and rebates, the reporting of deposits and advances for claims processing, the deferral and accrual of plan administrative expenses and insurance premiums, the accrual premium rebate credits for benefits provided by the plan sponsor, the accrual of premium reserve obligations owed to plan participants under the Act, and the accrual of estimated claims incurred but not reported as estimated by management with the assistance of a third party actuary.

Eligibility: The Plan covers employees working under federal contracts some of which are covered by the Act or collective bargaining agreements. Generally, full-time, part-time, and temporary employees for whom fringe benefits are required to be provided under the Act or collective bargaining agreements are covered under the plan. Benefits are generally reserved for employee coverage but employees may purchase additional coverage for spouse and dependents through pre- and after-tax deductions as allowable under IRS and ERISA rules and regulations.

Benefits: The Plan provides health benefits, including medical, hospitalization, prescription drug, dental, and vision coverage through various preferred provider options, accident, disability, supplemental life, and other fringe benefits to eligible employees as allowed under IRS and ERISA rules and regulations. Although benefits typically cease at termination of employment, the Plan also provides for continuation of benefits to former employees, spouses, and dependents under the Consolidation Omnibus Budget and Reconciliation Act (COBRA).

Employer Contributions: Funding is established monthly by the Corporation in accordance with prevailing wage rates and health and welfare contribution rates for employees covered under the Act or collective bargaining agreements or on a cost reimbursable basis for other participants. The Corporation adjusts the health and welfare contributions rates annually when contracts covered by the Act or collective bargaining agreements are awarded.

Employer Contributions – Continued: The Corporation uses the effective health and contribution rates released typically July each year by the DoL. The Corporation is required under the Act to provide qualified fringe benefits as established annually and some contracts require compliance on an average basis for covered employees while other contracts require compliance on an individual, per employee basis. For the years ended December 31, 2024 (in liquidation) and 2023 (ongoing), the Act's effective hourly health and welfare contribution rates were either \$5.36, \$4.98, and \$4.80.

Participant Contributions: Participants may make pre- and post-tax salary reduction contributions from their compensation for additional health insurance and other qualified benefits provided by the Plan for spousal and dependent coverage as allowed by the IRS and ERISA rules and regulations. Employee contributions for qualified health insurance are withheld on a pre-tax basis for additional coverage for spouses and dependents and remitted to the Plan.

Premium Rebates: The Corporation also may elect to take premium rebate credits for benefits provided by the plan sponsor outside of the Plan in meeting the health and welfare contribution rate requirement under the Act and collective bargaining agreements. The trustees of the Plan may also direct the plan sponsor to contribute excess funds in participant premium reserve accounts, as defined and maintained by the Plan, or contributions to the Plan in excess of prevailing wage requirements under the Act and collective bargaining agreements to retirement or pension plans established to receive excess prevailing wage contributions. Whether the qualified fringe benefits are provided for employees through the Plan or directly by the plan sponsor, the Corporation is required to demonstrate compliance with the prevailing wage and health and welfare contribution rate requirements. The Plan is designed to facilitate compliance. For the years ended December 31, 2024 (in liquidation) and 2023 (ongoing), the Corporation took premium rebates credits of approximately \$418,100 and \$4,265,900, respectively, for qualified fringe benefits funded directly by the Corporation outside of the Plan, including credits for retirement contributions made by the Corporation, non-statutory sick and bereavement leave, tuition reimbursement, cash in lieu of benefits, and military, civic, and jury duty. As of December 31, 2024 (in liquidation) and 2023 (ongoing), the accrued premium rebates for unapplied rebate credits for benefits provided by the Corporation to plan participants outside of the trust were approximately \$-0- and \$354,700, respectively.

Premium Reserve: Where required, the Plan maintains accounts for each participant working on contracts covered by Act and collective bargaining agreements. Some contracts require the plan sponsor to demonstrate compliance with the prevailing wage and health and welfare contribution requirements on an individual, per participant basis and others only require demonstration on an average participant basis for employee's working on designated contracts. As such, the accrued premium reserve represents the unexpended contributions remaining in the participants' premium reserve accounts, as defined by the Plan, or amounts necessary to meet compliance on an average basis for employees working on contracts requiring average based compliance.

Premium Reserve – Continued: The Corporation makes contributions to premium reserve accounts for employees covered by the Act at the prevailing health and welfare fringe contribution rate established by the Act up to the statutory limitations set forth under the Act or collective bargaining agreements. The unexpended amounts remaining in the participant premium reserve accounts are either used to fund qualified fringe benefits or are directed to a retirement trust fund for the benefit of participants and as such, are treated as accumulated eligibility credits and reflected as accrued premium reserve obligations in the accompanying financial statements until used for benefits or transferred to a retirement plan. As of December 31, 2024 (in liquidation) and 2023 (ongoing), the accrued eligibility credits for unused premium reserve amounts for Plan participants were reported as accrued premium reserve obligations of approximately \$-0- and \$346,400, respectively.

Claims Processing and Stop-Loss Coverage: The Plan entered into administrative services agreements with Aetna, UPMC, and Cigna for claims processing and benefits administrative support. The agreements are partially self-insured arrangement which included the Plan obtained individual or per participant and aggregate stop-loss insurance coverage. The individual and aggregate stop-loss coverage limits were \$225,000 (Aetna) and \$150,000 (UMPC) during each of the years ended December 31, 2024 (in liquidation) and 2023 (ongoing). Stop-loss claims are netted against claims paid by Aetna, UPMC, and Cigna when either the individual or aggregate coverage limit is reached. During the years ended December 31, 2024 (in liquidation) and 2023 (ongoing), the Plan incurred approximately \$1,489,100 and \$2,094,100, respectively for claims administration and processing and stop-loss insurance coverage.

Post-Retirement Benefits: Health and other benefits provided by the Plan generally cease at termination of employment with continuation of health insurance and other benefits as provided for under COBRA. Any accrued premium reserve obligations represent the unexpended balance in participant accounts from contributions made at the prevailing health and welfare contribution rates established under the Act or required under collective bargaining agreements, less the benefit premiums, retirement plan allocations, and other benefit payments made on the behalf of participants. Amounts remaining in the participant premium reserve accounts at termination of employment are generally used to fund qualified fringe benefits or are directed to a retirement trust fund for the benefit of participants. The claims incurred but not reported liability was estimated by management with the assistance of a third-party actuary using various regression and trend analysis of claims paid and other factors. Significant estimates are used by the Plan in establish the claims incurred but not reported obligations in the accompanying financial statements. Given the improvement in the timeliness of claims payments realized by the Plan and nominal effective interest rates, management's estimate for claim reserve did not include an escalation factor for inflation or other factors. The estimated liabilities for claims incurred but not reported totaled approximately \$-0- and \$1,663,000, respectively, as of December 31, 2024 (in liquidation) and 2023 (ongoing).

Administrative Expenses: The Plan reports administrative, recordkeeping, accounting, bank and other fees as expenses in the accompanying financial statements as costs are incurred. Additionally, the plan sponsor may provide administrative support and also pay certain professional and other fees on behalf of the Plan as allowed under IRS and ERISA rules and regulations. During the years ended December 31, 2024 (in liquidation) and 2023 (ongoing), the Plan incurred administrative expenses totaling approximately \$196,000 and \$317,000, respectively, including plan administrative fees of approximately \$161,800 and \$275,800, respectively, professional fees of approximately \$33,500 and \$41,000, respectively, and bank fees of approximately \$600 and \$200, respectively.

Investment Valuation and Recognition: Investments are reported at fair value (except for fully benefit response investment contracts reported at contract value). Fair value is generally determined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Certain investments may be valued at net asset value as a practical expedient of estimated fair value. The Plan reports interest, dividends, net realized and unrealized gains and losses (i.e., market appreciation and depreciation) as components of investment income. Purchases and sales of investments are recorded on a trade-date basis, interest income is recorded when earned, and dividends on an ex-dividend date basis. Interest income is reflected on the accrual basis of accounting.

Fair Value Measurements: The Plan established a reporting framework for measuring and disclosing fair value measurements. Fair value measurement disclosures are required for assets and liabilities measured and reported at fair value in the accompanying financial statements. Management uses a fair value measurement hierarchy based upon the lowest level of any input that is significant to the measurement with Level 3 being the lowest level of recognition. Management also attempts to maximize the use of observable inputs (Level 1 and 2) and minimize unobservable inputs (Level 3). Accordingly, the Plan classifies would classify any financial instruments valued at fair value in the following categories:

*Level 1* – valuation methodology based upon unadjusted quoted prices for identical assets or liabilities traded in an active market that the Plan has the ability to access;

*Level 2* – valuation methodology based upon unadjusted quoted prices for similar assets and liabilities traded in active markets or identical or similar assets and liabilities in inactive markets, observable market inputs for assets and liabilities not traded in active markets, observable market inputs derived or corroborated principally by correlation or other means, or Level 1 instruments where there is a contractual restriction; and

*Level 3* – valuation methodology based upon unobservable inputs that are significant to the fair value measurement.

Fair Value Measurements – Continued: As of December 31, 2024 (in liquidation) and 2023 (ongoing), the Plan reported no significant assets or liabilities were reported at fair value on a recurring basis in the accompanying financial statements. Disclosures about estimated fair values and fair value measurements were determined by the Plan based upon pertinent market data and other information available as of December 31, 2024 (in liquidation) and 2023 (ongoing). Considerable judgment is necessary to interpret market and financial data and to develop fair value measurements in certain circumstances, especially for Level 3 financial instruments. Although the Plan is unaware of any factors that would significantly affect their estimates, the Plan’s estimates of fair values and fair value measurements may not be indicative of amounts realized at disposition.

Termination: The Corporation reserves the right under the trust agreement and plan document to amend or terminate the Plan at any time subject to provisions of the IRC and ERISA. In the event of termination, the Plan must first apply assets to plan obligations and then to participant benefits. The plans sponsor resolved to terminate and liquidate the Plan effective December 31, 2024. As a result, the Plan changed its basis of accounting from the going concern basis used in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements. Plan assets were substantially used to cover claims administration and benefits.

Accounting Estimates: The preparation of financial statements in conformity with Plan’s basis of accounting, the liquidation basis of accounting for the 2024 financial statements and the modified cash basis of accounting for the 2023 financial statements, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America, requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Significant estimates are used by management, in the determination of the accrued premium reserve and claims incurred but not reported obligations in the accompanying financial statements, including the timing and amount of asset recoveries and liabilities settlements. Due to the uncertainties inherent in these estimates, it is at least reasonably possible that changes in these estimates and assumptions will occur in the near term. Accordingly, actual results could differ significantly from management’s estimates.

Reclassifications: Certain amounts were reclassified for comparative reporting purposes and to adhere to the current financial statement presentation.

**Note B – Concentrations of Risk**

Cash and Cash Equivalents: As of December 31, 2024 (in liquidation) and 2023 (ongoing), the Plan’s cash and cash equivalents consist principally of depository accounts with a national financial institution. These accounts are generally covered by federal insurance up to statutory limits.

Cash and Cash Equivalents – Continued: As of December 31, 2024 (in liquidation) and 2023 (ongoing), the Plan reported cash balances in excess of federal insurance limits of approximately \$-0- and \$368,000, respectively. The Plan typically has balances in excess of federal insurance limits which changes daily as cash balances fluctuate. Also, as of December 31, 2024 (in liquidation) and 2023 (ongoing), the Plan also maintained approximately \$-0- and \$22,500, respectively, in an imprest account with a brokerage as required by claims processing provider.

Plan Participants: A significant portion of the plan participants are employees of the Corporation working under federal contracts covered by the Act. As such, these federal contracts are subject to termination clauses whereby the government may terminate contracts for cause or convenience. Any contract terminations or funding delays affecting these employees may have a significant impact upon the Plan or the Corporation's desire to maintain the Plan. Other than participant contributions, substantially all of the Plan's income or additions are derived from the Corporation and its employees.

##### **Note C – Termination and Liquidation Basis of Accounting**

Effective December 31, 2024, the Plan adopted the liquidation basis of accounting in accordance with ASC 205-30, Presentation of Financial Statements – Liquidation Basis of Accounting. This change was made due to the plan sponsor's decision to terminate the plan and initiate liquidation proceedings, which became imminent as defined in ASC 205-30-25-2. Under the liquidation basis of accounting, the financial statements are prepared to reflect the plan's expected resources and obligations as it winds down. All assets are reported at their estimated net realizable value, and liabilities are stated at estimated settlement amounts. The plan sponsor notified participants and regulatory agencies of its intent to terminate the plan, where required. The liquidation was complete by December 31, 2024 with the plan sponsor assuming responsibility for ongoing claims and benefit obligations. The plan administrator has ceased accepting new contributions and used all remaining assets for benefits administration and benefit claims. The preparation of financial statements under the liquidation basis requires management to make significant estimates, including the timing and amount of asset recoveries and liability settlements. Consequentially, actual results could differ significantly from management's estimates.

##### **Note D – Related Party and Party-in-Interest Transactions**

Plan Sponsor: The Plan's sponsor, VSE Corporation, may at management's discretion pay certain administrative and professional expenses of the Plan. During the years ended December 31, 2024 (in liquidation) and 2023 (ongoing), the Corporation paid for certain professional services and compliance related costs associated with the Plan.

Plan Sponsor – Continued: Certain administrative functions are performed by officers or employees of the Corporation. No such officer or employee receives compensation from the Plan for such services other than ordinary benefits as a Plan participant. These transactions are generally exempt from the party-in interest transaction prohibitions.

Third-Party Administrator: The Plan retained CBIZ Employee Benefits (CBIZ) and related affiliates to provide certain management and administrative services. The Plan incurred management and administrative service fees totaling approximately \$161,800 and \$275,800, respectively, during the years ended December 31, 2024 (in liquidation) and 2023 (ongoing). The administrative service providers invoice their services generally based upon the number of active plan participants each month. The administrative service providers may be affiliated with insurance agencies and carriers providing coverage to the Plan that may receive commissions and other forms of remuneration from the insurance companies and related affiliates. CBIZ may also outsource certain functions to other third parties in delivering the administrative services to the Plan.

Claims Processing and Stop-loss Coverage: Health and medical claims processing were provided by Aetna, UMPC, and Cigna during the years ended December 31, 2024 (in liquidation) and 2023 (ongoing) with stop loss coverage either \$225,000 (Aetna) and \$150,000 (UMPC) during the each of the years then ended. As such, the Plan is subject to various risks associated with its relationship with Aetna, UPMC, Cigna, and other carrier and provider processing systems.

##### **Note E – Plan Receivables**

In accordance with the Plan's basis of accounting, the liquidation basis of accounting for the 2024 financial statements and the modified cash basis of accounting for the 2023 financial statements, the Plan reports outstanding employer and participant contributions based upon monthly labor hours through December 31, 2024 (in liquidation) and 2023 (ongoing) as plan receivables. Employer contributions are determined by the Plan based upon per hour labor factors established annually by the Act up to statutory limitations also set forth under the Act. Some contracts require the plan sponsor to meet the prevailing wage and health and welfare contribution requirements on an average basis while other require compliance on an individual, per participant, basis. For participants not covered by the Act, the Plan provides for coverage to participants on a cost reimbursable basis using the implied coverage premium rates established annual under the partially self-insured arrangement with Aetna, UPMC, and Cigna. For participants covered by the Act, the Corporation adjusts the hourly labor factors generally annually upon award of each contract covered by the Act. The Corporation may also be required to fund contributions in excess of those required under the Act to ensure adequate liquidity in the Plan as the plan sponsor has committed to funding the Plan adequately to meet its financial obligations.

Participant contribution receivables represent pre and post-tax withholdings for spousal and dependent coverage pending remittance to the Plan by the Corporation. Pursuant to the Plan's basis of accounting, the Plan reported contribution receivables of approximately \$-0- and \$3,331,300, respectively, as of December 31, 2024 (in liquidation) and 2023 (ongoing), including employer contributions of approximately \$-0- and \$2,214,800, respectively, and participant and other contributions of approximately \$-0- and \$1,116,500, respectively, as of December 31, 2024 (in liquidation) and 2023 (ongoing).

##### **Note F – Accrued Premium Rebates**

The Corporation may elect to take premium rebate credits for benefits provided by the Corporation outside of the Plan in meeting the health and welfare fringe benefit rates required under the Act and may also contribute excess funds in participant premium reserve accounts, as defined by the Plan, to a retirement trust fund established for the benefit of plan participants. Any premium rebate credits unapplied as of the end of the reporting period are reflected as an accrued premium rebate obligation in the accompanying financial statements. For the years ended December 31, 2024 (in liquidation) and 2023 (ongoing), the Corporation took premium rebates credits of approximately \$418,100 and \$4,265,900, respectively, for qualified fringe benefits funded directly by the Corporation for plan participants outside of the Plan, including credits for retirement contributions made by the Corporation, administrative leave, bereavement, and military, civic, and jury duty. As of December 31, 2024 (in liquidation) and 2023 (ongoing), the accrued premium rebates for unapplied rebate credits for benefits provided by the Corporation to plan participants outside of the trust were approximately \$-0- and \$354,700, respectively. The premium rebate credits are generally determined by the Corporation and applied subsequently as credits against employer contributions to the Plan so that the Plan can capture all benefits provided to the plan participants in meeting the prevailing wage requirements of the Act or collective bargaining agreements.

##### **Note G – Accrued Premium Reserve**

Where required, the Plan maintains accounts for each participant working on contracts covered by Act or by collective bargaining agreements. Some contracts require the plan sponsor to demonstrate compliance with the prevailing wage and health and welfare contribution requirements on an average basis for participants working on the designated contracts or on an individual, per participant, basis for contracts so designated. As such, the accrued premium reserve represents accumulated eligibility credits or unexpended contributions remaining in the participants' premium reserve accounts, as defined by the Plan, or amounts necessary to meet compliance on an average basis for employees working on contracts requiring average based compliance.

Contributions are made by the Corporation based upon the contractual terms and the prevailing health and welfare fringe contribution rates established by the Act. The Corporation makes contributions to premium reserve accounts for employees covered by the Act at the prevailing health and welfare fringe contribution rate established by the Act up to the statutory limitations based upon whether compliance is on an individual, per participant, basis or on an average basis. The accumulated eligibility credits or unexpended amounts remaining in the participant premium reserve accounts are either used to fund qualified fringe benefits or are directed to a retirement trust fund for the benefit of participants and as such, are reflected as accrued premium reserve obligations in the accompanying financial statements. As of December 31, 2024 (in liquidation) and 2023 (ongoing), the accrued eligibility credits for unused premium reserve accounts for participants covered by the Act were reported as premium reserve obligations as follows:

**Note H – Claims Paid and Claims Incurred But Not Reported**

The Plan entered into administrative services agreements with Aetna, UPMC, and Cigna for claims processing and benefits administrative support. The agreements are partially self-insured arrangements which included the Plan obtained individual or per participant and aggregate stop-loss insurance coverage. The individual and aggregate stop-loss coverage limit was \$225,000 for Aetna during each of the years ended December 31, 2024 (in liquidation) and 2023 (ongoing), and \$150,000 for UPMC during each of the years then ended. Stop-loss claims are netted against claims paid by Aetna and Cigna when either the individual or aggregate coverage limit is reached. During the years ended December 31, 2024 (in liquidation) and 2023 (ongoing), the Plan incurred approximately \$1,489,100 and \$2,094,100, respectively, for administrative claims processing and stop-loss insurance coverage. Cigna processes participant health claims for reimbursement through an imprest account funded by the Plan. The Plan was required to maintain an imprest account balance of approximately \$0- and \$22,500, respectively, as of December 31, 2024 (in liquidation) and 2023 (ongoing). Not including any accruals for accumulated eligibility credits (premium reserve obligations) or the claims incurred but not reported, the Plan paid approximately \$7,783,900 and \$13,394,900, respectively, in health, medical, pharmacy, and dental claims during the years ended December 31, 2024 (in liquidation) and 2023 (ongoing).

As part of the administrative services agreements with Aetna, UPMC and Cigna, the Plan partially self-insures for health, medical, pharmacy, and dental coverage. The arrangements with Aetna, UPMC, and Cigna include individual participant and aggregate stop-loss insurance coverage. Stop-loss claims are netted against claims paid when coverage limits are reached on either a per participant or aggregate basis and the carriers may also isolate individuals with known risks for higher specific deductibles. Management also hired a benefit consultant and actuary to assist with estimating the claims incurred but not reported liability. The claims incurred but not reported liability was determined based upon a series of regression and trend analyses of claims paid and other factors. Given the improvement in the timeliness of claims payments realized by the Plan and nominal effective interest rates, management’s estimate for claim reserve did not include an escalation factor. Management also considers subsequent claims paid when ultimately establishing the claims incurred but not reported liabilities or adjusting the estimates prepared but the benefit consultant and actuary based upon actual subsequent claims. The following summarizes the various regression and trend analyses prepared by the actuary and used by management in determining the claims incurred but not reported liability as of December 31, 2024 (in liquidation) and 2023 (ongoing), which also included claims reserve allowances as follows:

The Plan incurred premium charges under the fully insured policies totaling approximately \$1,313,600 and \$2,940,900, respectively, during the years ended December 31, 2024 (in liquidation) and 2023 (ongoing). Health and other benefits provided by the Plan generally cease at termination of employment with continuation of health insurance and other benefits as provided for under COBRA. Significant estimates are used by management, the plan administrator, the plan underwriter and other third parties retained by the Plan in the determination of the accrued premium reserve and claims incurred but not reported obligations in the accompanying financial statements. Due to the uncertainties inherent in these estimates, it is at least reasonably possible that changes in these estimates and assumptions will occur in the near term. Accordingly, actual results could differ significantly from management’s estimates and any difference may be material.

##### **Note J – Income Tax Consideration**

Income Tax Status: The Plan received a determination letter from the Internal Revenue Service (IRS) in August 2014 setting forth the Trust's tax exemption under IRC Section 501(c)(9) effective January 1, 2012. Accordingly, the Trust is exempt from the payment of income taxes on its exempt activities. Any activities unrelated to the Trust's exempt status, such as net investment income, are subject to taxation. Trust agreement may also be amended from time-to-time to clarify certain provisions or comply with new regulations and such amendments may require IRS approval. No assurances can be provided on any such amendments until reviewed and approved by the IRS.

Unrelated Business Income: Investment income of organizations exempt under IRC Section 501(c)(9) is generally subject to taxation as unrelated business income. However, IRC Section 512(a)(3)(B) provides a general exclusion from unrelated business income tax for income sources committed to provide for the payment of life, sick, accident, and other permissible benefits. IRS Regulation 143874-10 established guidance for implementation of IRC Section 512(a)(3)(E) to limit the amount of exempt function income that can be set aside when calculating unrelated business income. As such, organizations exempt under IRC Section 501(c)(9) must determine their unrelated business income at the lesser of its net investment income or the excess of the amount set aside as of the close of the tax year over the qualified asset account limit established by IRC Section 419A. Accordingly, the net investment income of organizations exempt under IRC Section 501(c)(9) is taxable to the extent that the organization's assets exceed the amount reasonably and actuarially determined to fund claims incurred but not reported and associated claims administrative costs. Additionally, the IRS allows for a specific deduction of up to \$1,000 of unrelated business income. The Plan reported no significant investment income for the years ended December 31, 2024 (in liquidation) and 2023 (ongoing) and thus, no significant unrelated business income for the years then ended. Accordingly, no provision for income taxes is reflected in the accompanying financial statements as of and for the years ended December 31, 2024 (in liquidation) and 2023 (ongoing).

Tax Contingencies: Although the Plan has not received any notice of intent to examine its tax returns, the Plan's tax returns remain subject to examination or review by tax authorities pursuant to various statutes of limitations. Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan. Furthermore, accounting principles generally accepted in the United States of America require Plan management to recognize a tax liability (or asset) if the Plan has taken uncertain tax positions that would more likely than not be sustained upon examination. Management is unaware of any significant uncertain tax positions arising during the years ended December 31, 2024 (in liquidation) and 2023 (ongoing) that are more likely than not to be sustained should the Plan's tax returns be subject to examination. Accordingly, the Plan did not incur or accrue any penalties or interest associated with uncertain tax positions during the years then ended.

**Note K – Plan Termination**

The Corporation reserves the right under the Plan agreement to amend or terminate the Plan at any time subject to provisions of the IRS and ERISA rules and regulations. In the event of termination, the Plan must first apply assets to plan obligations, with any remaining assets used to provide benefits to plan participants. Substantially all of the plan participants are employees of the Corporation working under federal contracts with many participants covered under the Act. As such, these federal contracts are also subject to termination clauses whereby the government may terminate contracts for cause or convenience. Any contract terminations or funding delays caused by political, budgetary, or other administrative matters may affect employees participating in the Plan and the Corporation's ability and desire to maintain the Plan. The plans sponsor resolved to terminate and liquidate the Plan effective December 31, 2024. As a result, the Plan changed its basis of accounting from the going concern basis used in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements. The Corporation was committed to ensuring the Plan is adequately funded to meet its obligation and all remaining plan assets were substantially used to cover claims administration and benefit obligations.

**Note L – Contingencies**

The Plan is, from time to time, involved in various legal actions, claims or disputes arising from the normal course of its operations and administering benefits for participants that, in the opinion of management will not have a significant impact upon the Plan's financial condition or operation. The Plan was previously reviewed by the Department of Labor for various compliance for the period January 1, 2017 through July 31, 2020. The Department of Labor issued the results of their review in August 2024 (in liquidation) in which no further action was required. As a result, management contends that prior examinations and review of the Plan have not resulted any significant fines or assessments and is not expecting any significant fines or assessments as a result of the ongoing examination. Accordingly, no contingent liabilities have been accrued for any loss contingencies in the accompanying financial statements. No assurances are provided given the nature of these contingencies.

**Note M – Subsequent Events Evaluation**

The Plan has evaluated subsequent events for the period January 1, 2025 through October 12, 2025, the date on which these financial statements were available to be issued and during this period, there were no subsequent events that required recognition or disclosure in the accompanying financial statements. The Plan was effectively terminated on December 31, 2024.
