INDEPENDENT AUDITORS' REPORT

To the Board of Directors
Dermatology Solutions Group, LLC 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Dermatology Solutions Group, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

1. DESCRIPTION OF THE PLAN

The following description of the Dermatology Solutions Group, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan sponsor, Dermatology Solutions Group, LLC (the Company), established the Plan effective as of January 1, 2015. The Plan is a multiple-employer defined contribution plan available to all employees of the Plan sponsoring Company and its adopting subsidiaries, who have completed 250 hours of service within the first three consecutive months of employment and are age 21 or older. The Plan is subject to the provisions of ERISA.

Eligibility for Participation

Employees may become a participant in the Plan as of the Plan entry date coinciding with or following their completion of 90 days of service with the Company. The Plan entry dates are January 1, April 1, July 1 and October 1. In order to complete three months of service, an employee must simply remain in the Company's employment for three months following the employee's commencement date. The employee must complete 250 hours of service during the three-month period. If an employee is part-time or a temporary employee and then becomes full-time, they will get credit for that time employed.

Contributions

Each year, participants may contribute a portion of pretax annual compensation, as defined in the Plan and subject to Internal Revenue Service (IRS) limits. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company's matching contribution is 100% of the participant's first 1%, plus 50% of the participant's next 5% of the pay period compensation contributed. Effective April 26, 2020, the Plan was amended to eliminate matching contribution. Effective January 1, 2021, the Plan was amended to resume matching contribution.

Participants may direct all employee and employer contributions among certain funds, as described in the employee enrollment package prepared by the Plan's trustee.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of (1) the Company's contribution and (2) the Plan's earnings and reduced by any Plan losses and administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. A participant vests in the Company's discretionary contributions in accordance with the following schedule:

Administrative Expenses

Expenses attributable to general Plan administration are paid by the Plan and allocated among the accounts of all participants in proportion to their account balances, unless paid by the Company. During 2024, expenses paid by the Plan and allocated to participant accounts were \$177,696.

Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant may elect to: 1) receive a lump-sum amount equal to the value of the participant's vested interest in their account, 2) receive annual installments or 3) roll their investments into another qualified plan or account. For termination of service due to other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution or rollover into another qualified account. Participants with account balances less than \$1,000 must take a lump-sum distribution as soon as practicable following termination.

Forfeitures

Non-vested benefits of terminated participants are forfeited on the date the participant receives a complete distribution of vested benefits. Forfeitures are used to reduce employer contributions or pay certain administrative expenses of the Plan. As of December 31, 2024 and 2023, the Plan had approximately \$6,217 and \$4,551, respectively, available to reduce future employer contributions or pay certain administrative expenses of the Plan. For the year ended December 31, 2024, the amount of forfeitures used to reduce employer contributions totaled approximately \$55,000.

Investment Options

Upon enrollment in the Plan, a participant may direct participant contributions as well as the employer's matching contributions in whole percentage increments of earnings in any of the funds offered by the Plan. Participants should reference prospectus information supplied by the Plan for detailed fund information.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits

Benefits are recorded when paid.

Risks and Uncertainties

The Plan invests in a variety of investment funds. Investments in general are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Contributions

Participant and employer contributions are recorded in the period during which the Company makes payroll deductions from the Plan participants' earnings.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5, *Fair Value Measurements*, for the fair value disclosures.

The Plan's pooled separate accounts include the accounts maintained by Principal Life Insurance Company. The fair value of those investments in the pooled separate accounts are estimated using the net asset value (NAV) per unit. The Plan presents, in the statement of changes in net assets available for plan benefits, the net appreciation in the fair value of its investments, which consists of the net change in fair value of the pooled separate accounts.

Purchases and sales of investments, including gains or losses, are recorded on a trade-date basis. Interest income is recorded when earned, and dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Subsequent Events

The Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

5. FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement).

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024 and 2023:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Participant-directed brokerage accounts: Consists of money market funds, common stocks and mutual funds. Mutual funds are valued at the net asset value of shares of mutual funds held at year end. Common stock is valued at the closing price reported on the active market on which the security is traded.

Pooled separate accounts: Based upon NAV as a practical expedient. The NAV of a pooled separate account is based on the market value of its underlying investments. The pooled separate account's NAV is not a publicly quoted price in an active market.

8. TAX STATUS

The underlying non-standardized prototype plan has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the Plan is qualified under Section 401(a) of the Internal Revenue Code (IRC), and therefore, the related trust is tax-exempt. The Plan administrator has determined that it is eligible to and has chosen to rely on the current IRS non-standardized prototype plan opinion letter. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan administrator believes the Plan is in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is qualified and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions, including the IRS. The Plan is not currently under IRS examination for any Plan years.
