Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of **MOZILLA CORPORATION 401(k) PLAN (the Plan)**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Notes to the Financial Statements

Note 1 - Description of Plan:

The following description of the Mozilla Corporation 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan, a pre-approved defined contribution plan, was established October 15, 2005 by Mozilla Corporation (the Company/Plan Sponsor). The Plan was designed to provide participants with a means to defer a portion of their compensation for retirement funds and to provide benefits as defined in the Plan document in the event of disability, death, or financial hardship. The Plan was most recently amended effective January 1, 2023 to include automatic enrollment provisions for newly hired employees. The Plan Administrator believes that the Plan is currently designed and operated in compliance with the applicable requirements of the Internal Revenue Code (IRC) and the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as amended.

On December 29, 2022, the SECURE Act 2.0 was signed into law. The new law makes changes to include provisions intended to expand coverage, increase retirement savings, increase the age at which retirees must begin taking required minimum distributions, change catch-up contributions, and simplify and clarify retirement plan rules. Most of the provisions in the SECURE Act 2.0 legislation are optional and many require regulatory guidance prior to implementation. The Plan continues to operate under required legislative and regulatory requirements. Written amendments to the Plan to reflect these operational changes will be adopted at a later date in accordance with applicable law and Internal Revenue Service (IRS) guidance.

Effective October 18, 2024, the Plan implemented the auto portability provision under the SECURE 2.0 Act. Auto portability allows for automatic roll-in of a participant's eligible account balance from a prior employer's retirement plan into the employee's new plan through a negative consent process. The SECURE 2.0 Act also increased the mandatory cash-out/auto portability threshold from \$5,000 to \$7,000.

In 2024, the Company also approved implementation of certain SECURE 2.0 provisions with effective dates in 2025. Effective January 1, 2025, participants who attain ages 60 through 63 will be eligible for an increased catch-up contribution limit. The additional catch-up contribution limit is the greater of (a) \$10,000, adjusted for cost of living beginning in 2026, or (b) 150% of the regular catch-up limit in effect for 2024 (\$11,250). Effective April 1, 2025, the Plan will adopt certain additional withdrawal options permitted under SECURE 2.0. These include modifications to the Qualified Birth or Adoption Distribution (up to \$5,000 per child within one year of birth or adoption finalization), withdrawals for emergency expenses (up to \$1,000 annually), distributions related to federally declared disasters, and distributions for victims of domestic abuse.

Eligibility

No age or service requirements exist. All full-time regular employees are eligible to enter the Plan on the first of the month following their date of hire. Fixed Term and Seasonal employees are eligible to enter the Plan on the first day of the month following attaining age 21 and completing 1,000 hours of service. Interns and student workers are not eligible to participate in the Plan.

Contributions

Participants may elect to contribute annually not to exceed 90% of their annual pretax eligible compensation up to a maximum of \$23,000 for 2024. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Contributions are subject to limitation. Participants are also allowed to make catch-up, Roth, and rollover contributions from other tax-qualified, employer-sponsored retirement plans. Such contributions are deposited in the appropriate investment funds in accordance with the participants' directives and the Plan's provisions.

For all newly hired employees on or after January 1, 2023, the Plan automatically defers 6% of eligible compensation on a pre-tax basis. Employees are notified approximately 60 days prior to the automatic enrollment date where participants can either opt out of automatic enrollment or make a different deferral election. Rehires are not automatically enrolled.

Company contributions are as follows under the Plan document.

- Annual safe harbor nonelective contributions in an amount equal to 3% of eligible compensation.
- Discretionary nonelective contributions allocated using a ratio of participant eligible compensation to total eligible compensation. The Company's Board of Directors approved a 4% discretionary contribution for the year ended December 31, 2024. A participant must be employed on the last day of the Plan year to receive discretionary nonelective contributions.
- Discretionary matching contributions may be up to 4% of eligible compensation. The Company did not make a matching contribution for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions, the participant's qualified rollover contributions, employer matching and nonelective contributions, and Plan earnings or losses thereon.

Vesting

Participants become 100% immediately vested in all their accounts upon contribution.

Participant Investment Options

Upon enrollment in the Plan, participants must direct the allocation of their contributions to any of the investment options offered by the Plan or to self-directed brokerage accounts. The Fidelity Freedom K funds by year are the default investment options based on the participant's age and assuming normal retirement age as defined in the Plan document. Participants may change their investment options any time throughout the year (subject to specific limitations placed by certain investment funds) via the third-party administrator's direct phone or internet website.

Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 up to the maximum of the lesser of \$50,000 or 50% of their vested account balance. Loans are secured by the remaining balance in the participant's account. The term of the loan shall not exceed five years except in the case of a loan for the purpose of purchasing the principal residence of the participant, in which case the term for repayment may be over a period no longer than 10 years. Repayment of loans must be either by check or through payroll deductions of both principal and interest. The interest rate is determined by the Plan Administrator based on the prevailing interest rates charged by persons in the business of lending money for loans which would be made under similar circumstances. The interest rate is fixed throughout the duration of the loan, currently ranging from 4.25% through 9.50% per annum. The loans have various maturities through December 2033.

Payment of Benefits

A participant with a vested account of more than \$5,000 may, upon termination of employment, retirement, total disability, death, or reaching age 59 1/2, elect to receive an amount equal to his or her vested account interest in a lump-sum distribution. A participant with a vested account of \$5,000 or less may, upon termination, have the vested amount paid out in a lump-sum distribution. Eligible distributions between \$1,000 and \$5,000 are rolled over into a traditional individual retirement account unless otherwise elected by the participant. The Plan allows for hardship withdrawals from a participant's deferral account only. There were no participant requests to withdraw from the Plan as of December 31, 2024 or 2023 that had not been paid as of those dates.

Plan Trustee

Fidelity Management Trust Company is the Trustee of the Plan. Substantially all of the Plan's assets are held by the Trustee.

Note 2 - Significant Accounting Policies:

Basis of Accounting

The financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan Administrator to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments of the Plan are held by the Trustee and invested based solely upon instructions received from participants. The Plan's investments are reported at fair value, as of the last day of the Plan year. Fair value is the price that would be received to sell assets or paid to transfer liabilities in an orderly transaction between market participants at the measurement date. The Retirement Plan Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and Trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The market volatility of equity-based investments may substantially impact the value of such investments at any given time. It is likely that the value of the Plan's investments; both in total and in individual participant accounts, has fluctuated since December 31, 2024.

Management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of net appreciation (depreciation) in fair value of investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent loans are treated as distributions based upon the terms of the Plan document.

Contributions

Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Benefits Paid to Participants

Benefits paid to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and self-directed brokerage accounts are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

Subsequent Events

The Plan Administrator evaluated subsequent events from December 31, 2024 through October 10, 2025, the date these financial statements were available to be issued, and has determined that, except as disclosed in Note 1, there were no material subsequent events that required recognition or additional disclosure in these financial statements.

Note 3 - Certified Information:

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the Trustee.

Note 4 - Fair Value Measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology that are unobservable and significant to the fair value measurements.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common / collective trusts: Composed of fully benefit responsive contracts such as wrap agreements and insurance company separate account agreements, under which the insurance company or other financial institution contract issuer agrees, subject to certain conditions, to make payments from the contract in connection with redemptions from the common collective trust funds for plan participant-initiated benefit payments at contract value comprised of principal plus interest crediting adjustments. Valued at the net asset value of units of the issuer's common/collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the common / collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidation will be carried out in an orderly business manner.

Self-directed brokerage accounts: Accounts primarily consist of common stocks and mutual funds that are valued at the closing price reported on the active market on which the individual securities are traded. Accounts also include cash for which the carrying value approximates fair value due to the short-term nature of these financial instruments.

Note 5 - Related-Party Transactions and Party-in-Interest Transactions:

Plan investments are managed by either an affiliate of the Trustee or an investment company registered under the Investment Company Act of 1940, contracted by the Trustee. Any purchases and sales of these investments are open market transactions at fair value. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the party-in-interest prohibition.

The Trustee provides certain administrative services to the Plan pursuant to a Plan Service Agreement (PSA). The Trustee receives revenue from mutual fund service providers for services the Trustee provides to the funds. This revenue is used to offset certain amounts owed to the Trustee for its administrative services to the Plan.

If the revenue received by the Trustee from such mutual fund service providers exceeds the amount owed under the PSA, the Trustee remits the excess to the Plan's trust on a quarterly basis. Such amounts shall be allocated to the accounts of the participants. The Plan or Plan Sponsor may make a payment to the Trustee for administrative expenses not covered by revenue sharing.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

Note 6 - Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 7 - Tax Status:

The Plan has adopted an amended and restated Pre-Approved Defined Contribution Plan provided by FMR LLC (FMR), an affiliate of the Trustee. The FMR plan has received a favorable opinion letter dated June 30, 2020 from the IRS as to the form of the plan being acceptable under Section 401 of the IRC. This opinion on the acceptability of the form of the plan is not a ruling or determination as to whether the plan qualified under Code section 401(a). The Plan has been amended since the FMR plan received the opinion letter. The Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements.

Note 8 - Risks and Uncertainties:

The Plan provides for various investment options in any combination of mutual funds, common/collective trusts, or self-directed brokerage accounts. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

The Fidelity 500 Index Fund represented approximately 19% and 18% of Plan assets as of December 31, 2024 and 2023, respectively. The Fidelity Freedom 2050 IPR Fund represented approximately 11% and 10% of Plan assets as of December 31, 2024 and 2023, respectively.
