### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Management has obtained certifications from Fidelity Management Trust Company, a qualified institution, as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

**Note A – Description of Plan**

The following description of the MG Engineering D.P.C. (“Company”) 401(k) Profit Sharing Plan and Trust (“Plan”) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan’s provisions. Except as otherwise noted, information below is as of the end of the Plan year.

**General.** The Plan is a defined contribution plan, covering all full-time employees of the Company who have completed two consecutive months of service and who are twenty or older and who are not an excluded class of employees. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions.** Each year, participants may contribute between 1 percent and 92 percent of pretax annual compensation or up to the maximum percentage allowable not to exceed the limits of Code Section 401(k). For 2024, the maximum deferral amount is \$23,000. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified benefit plans. Participants may make after-tax contributions (Roth contributions). The Plan allows participants to rollover balances from their former retirement plans as long as they are participating in the Plan. Each year, the Company will contribute a fixed matching contribution of 5 percent of the participants’ salary deferrals. Additional profit-sharing amounts may be contributed at the option of the Company’s board of directors. Contributions are subject to certain IRS limitations.

**Participant Accounts.** Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution and, (b) Plan earnings (losses) and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The Plan permits participants to self-direct the investments in their accounts into a variety of investment options. All participants have elected to self-direct their accounts. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting.** Participants are 100% vested in the value of their accounts at all times. In addition, participants are 20% vested in the Company’s contribution once they have completed their first year of credit service with the Company and an additional 20% each year thereafter.

**Notes Receivable from Participants.** A participant may request a loan from their account within the Plan. The minimum loan allowed is \$1,000. The maximum loan allowed is the lesser of one-half of the vested account balance or \$50,000, reduced by the participant’s highest loan balance outstanding from the Plan during the preceding twelve months. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant notes fund. Loans must be repaid by payroll deductions over a maximum period of five years unless the loan is a principal residence loan which must be repaid over a maximum period of 25 years.

**Notes Receivable from Participants (continued).** No more than one loan outstanding will be permitted at any point in time, unless the loan is refinanced. Loans bear interest at prime plus 2%. Participant loans amounted to \$303,307 and \$261,121 at December 31, 2024 and 2023, respectively.

**Payment of Benefits.** On termination of service due to death, disability or retirement, a participant shall receive a lump-sum amount equal to the value of the participant's vested interest in his or her account or an annuity. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account in the form of either a lump-sum, partial, installment or annuity distribution.

**Forfeited Accounts.** Generally, when a participant terminates in the plan, the nonvested portion of the participant's account, as defined by the plan, represents a forfeiture. Pursuant to the provisions of the plan, these accounts are first used to pay for any administrative expenses, and then, if applicable, are used to reduce the employer's matching contributions to the plan. As of December 31, 2024 and 2023, the forfeiture account balance was \$2,102 and \$1,514, respectively. During the year ended December 31, 2024, forfeitures from nonvested accounts totaled \$5,785, and of that, \$5,295 were used to pay for administrative expenses.

**Note B – Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan are prepared under the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year. See Note D for discussion of fair value measurements.

**Note B – Summary of Significant Accounting Policies (continued)**

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

***Payment of Benefits***

Benefits are recorded when paid.

***Administrative Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

**Note C – Certified Investments**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan).

**Note D – Fair Value Measurements**

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

*Interest-bearing cash:* Value based on quoted prices for similar assets or liabilities.

*Mutual funds:* Valued at the net asset value (NAV) of shares held by the plan at year end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note E – Related Party and Party in Interest Transactions**

Participant loans are managed by Fidelity Management Trust Company. Fidelity is a trustee as defined by the plan, and therefore, these transactions qualify as party-in-interest transactions. **Note F – Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

**Note H – Tax Status**

The Internal Revenue Service has determined and informed Fidelity Management and Research Co in a letter dated June 30, 2020, that their prototype plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC) and is exempt from federal income tax. The plan has been amended since receiving the opinion letter. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified, and the related trust is tax-exempt.

**Note H – Tax Status (continued)**

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note I - Corrective Distributions Payable**

The Plan failed the discrimination test for the year ended December 31, 2024. Excess contributions amounting to \$17,952 are recorded as a liability in the accompanying statement of net assets available for benefits and as a reduction of participant contributions for the year.

The Plan processed these excess contributions in August 2025.

**Note J – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Note K – Plan Amendment**

On October 16, 2023, the Plan was amended to add four new participating employers to the Plan. Effective November 21, 2023, Kallen & Lamelson, LLP, MG Engineering FL Corp., MG Engineering-PA, Corp. and MGE Unified Technologies Corp. were permitted to participate in the Plan.

**Note L – ERISA Bond Requirement**

The Employee Retirement Income Security Act of 1974 (ERISA) requires that every person who handles funds or other property of the Plan be bonded. The bond coverage is to be determined by the balance of the total plan assets, and is required to be at least equal to the lesser of 10% of the plan's assets at the beginning of the plan year or \$500,000. At December 31, 2024, the Plan's sponsor maintained bond coverage in the amount of \$500,000.

**Note M – Subsequent Events**

Subsequent events were evaluated through October 2, 2025, which is the date the financial statements were available to be issued.
